Scope and Content Note: **The collection, spanning the period from 1960 to 1976, includes correspondence, reports, minutes, studies, newspaper clippings, reference material and other types of papers, mainly relating to Mr. McFadden's work as a member of the South Carolina House of Representatives for district #50 of York County. Most of the collection pertains to York County affairs, including race relations, public education, appropriations, taxes, home rule and the work of the York County Legislative Delegation, but there is also much information on affairs at the state and regional level, including legislation and McFadden's work on the House Judiciary Committee. The collection is arranged alphabetically by subject and, there under, the records are in chronological order. A brief annotation is included with some subjects to help describe the contents contained within. The type of material for each subject may vary. At this time, related records might include the records of the York County Democratic Party (Acc. 61) and the York County Democratic Women's Club (Acc.60).**

Transfer of Items: Two tapes, concerning public hearings on possible, additional black representation on school boards through the creation of a ward system, were transferred from the files pertaining to the subject York County Race Relations (Box 21 – Folder 138).
