SIR: In compliance with the provisions of an act entitled "An act making appropriations for the current and contingent expenses of the Indian Department," etc., approved June 29, 1888 (25 Stats., p. 234), I have the honor to transmit herewith a list of Indian depredation claims in favor of citizens of the United States and against Indian tribes hold-

ing treaty relations with the Government which were investigated pursuant to said act to this date.

Said list contains the number of the claims, name, and post-office address of each claimant, character of the property stolen or destroyed, Indians charged with the depredation, when committed, when filed, amount claimed, amount allowed, date of action, and the "date and clause of the treaty creating the obligation for payment," and also what funds, now existing "by reason of treaty or other obligation, out of which the same should be paid."

Accompanying each claim herewith is the original record of the testimony presented and all former action had, together with a letter embodying office "opinions and conclusions upon all material facts, and all the evidence and papers pertaining thereto."
