### GOV. LYNCH REMAINS POPULAR, STATE HOUSE & SENATE ELECTIONS CLOSE

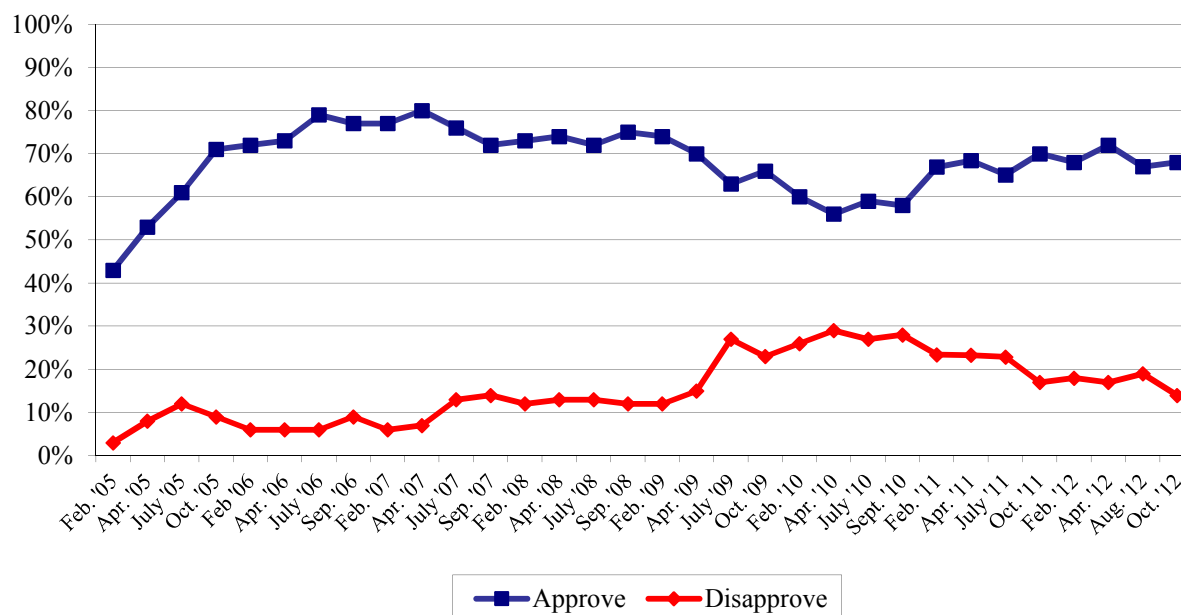
DURHAM, NH – Governor Lynch is ending his term with very high job approval ratings. The race for control of the State House and State Senate is currently up for grabs.

These findings are based on the latest **WMUR Granite State Poll**,\* conducted by the University of New Hampshire Survey Center. Six hundred and thirty-eight (638) randomly selected New Hampshire adults were interviewed by landline and cellular telephone between September 27 and September 30, 2012. The margin of sampling error for the survey is +/- 3.9 percent. Included is a subsample of 600 likely general election voters (margin of sampling error +/- 4.0%).

#### Gubernatorial Approval

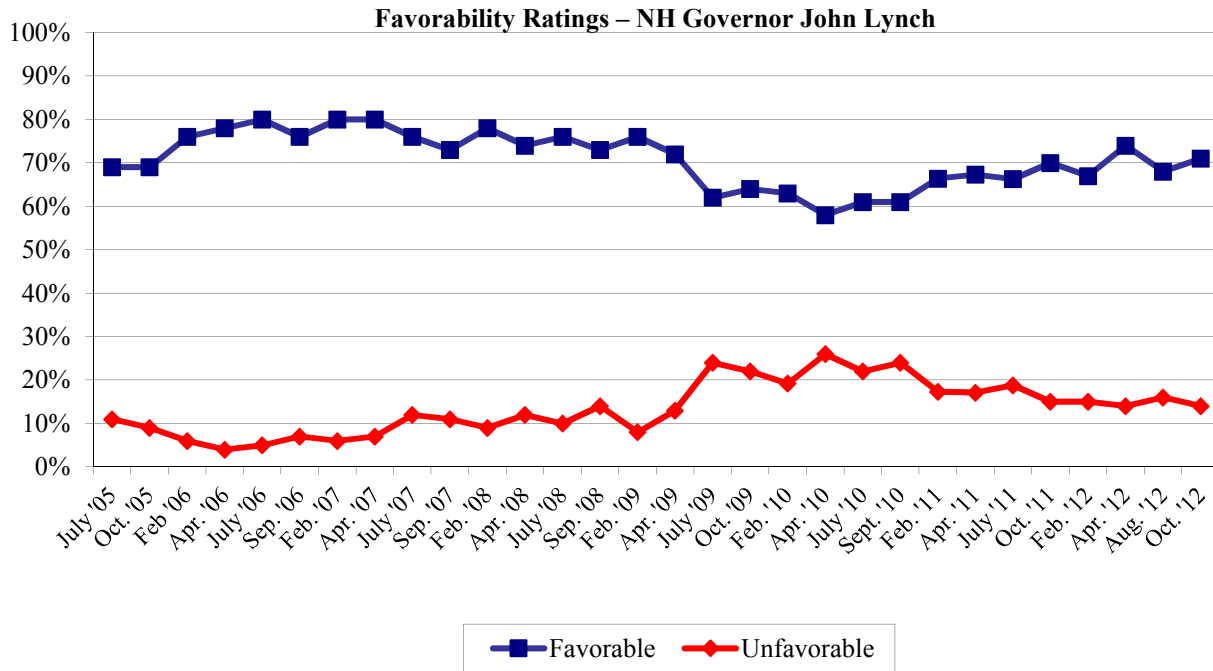
In the final months of John Lynch's record 4 terms as New Hampshire Governor, he continues to be seen as a very effective governor. In the most recent Granite State Poll, 68% of New Hampshire adults say they approve of the way he is handling his job as governor, 14% disapprove, and 17% are neutral or are unsure. Lynch continues to enjoy high approval ratings from his strong support among Democrats (80% approve) and also receives majority support from Independents (66%) and Republicans (54%).

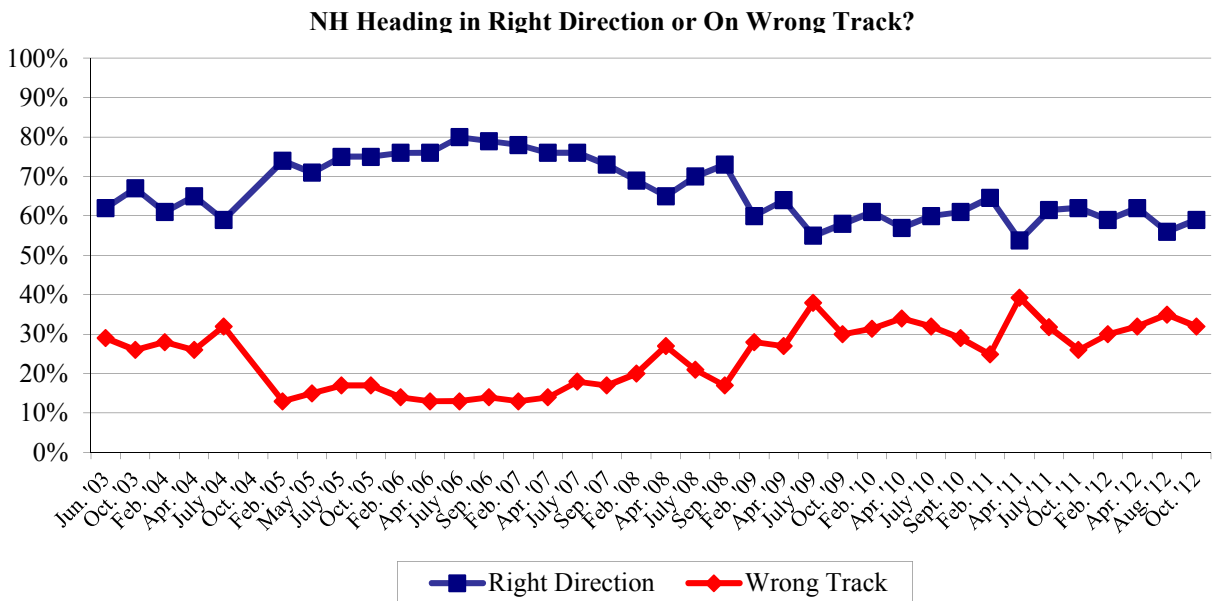
Lynch's personal favorability ratings also remain very high. In the latest Granite State Poll, 71% of New Hampshire adults say they have a favorable opinion of Lynch, 14% have an unfavorable opinion, 10% are neutral, and 5% say they don't know enough about him to say. Lynch's net favorability rating, the percentage having a favorable opinion minus the percentage having an unfavorable opinion, remains high at +57%. Lynch receives very high net favorability ratings from Democrats (+73%) as well as from Independents (+62%), and even receives high net favorability ratings from Republicans (+35%).



### Right Direction or Wrong Track?

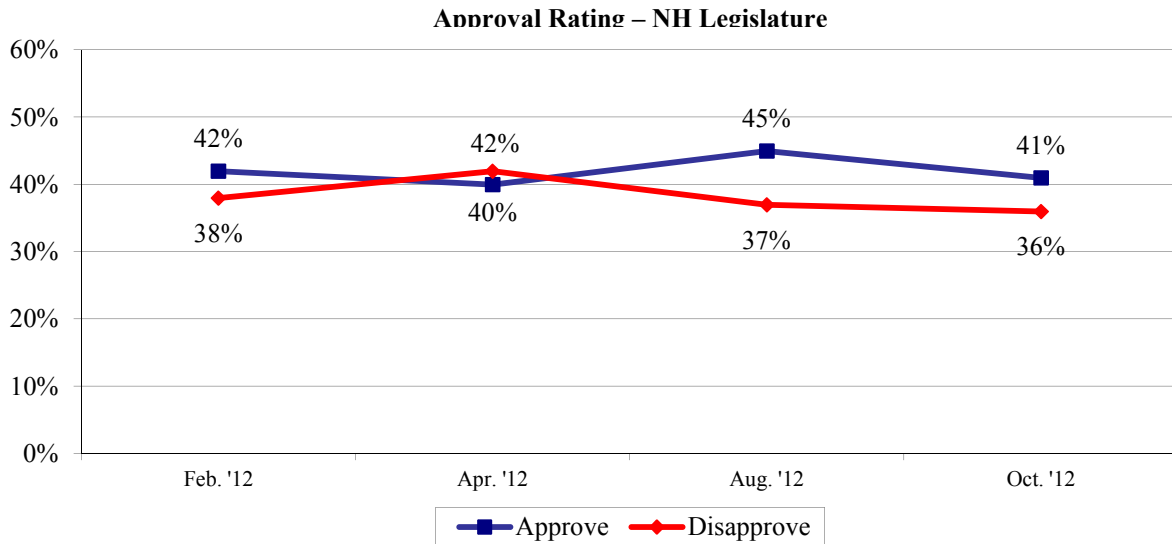
New Hampshire residents continue to think the state as a whole is headed in the right direction. Currently, 59% of New Hampshire adults feel the state is heading in the right direction, 32% think the state is seriously off on the wrong track, and 9% are unsure.

Majorities of Republicans (60%), Democrats (56%), and Independents (67%) say the state is headed in the right direction.



### Approval of NH Legislature

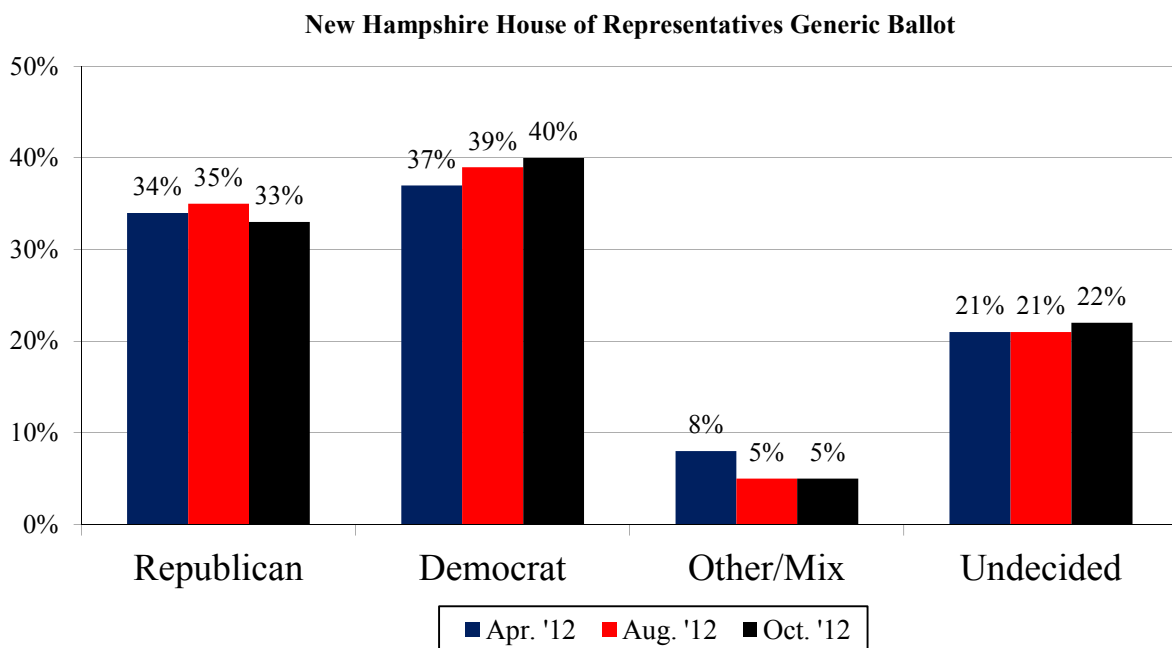
Republicans gained large majorities in the New Hampshire House of Representatives and Senate in 2010 after four years of control by Democrats. The state is split in how good of a job the Legislature is doing - 41% approve of how the State Legislature is doing its job, 36% disapprove, and 23% are neutral or don't know enough to say. A majority of Republicans (55%) and a plurality of Independents (43%) approve of the job the Legislature is doing, but only 29% of Democrats approve.



### New Hampshire House of Representatives

Likely 2012 New Hampshire voters were asked which party's candidate they planned to vote for in the upcoming election for state representative. Democratic candidates have been named by an increasing percentage of New Hampshire likely voters with 40% saying they will vote for Democratic candidates, 33% for Republican candidates, 5% supporting another party or a mix of Republicans and Democrats, and 22% undecided. When undecided voters are asked which candidate they are leaning toward, 43% of all voters say they will vote for Democratic candidates, 37% for Republican candidates, 5% will vote for candidates of a third party or a mix of Republicans and Democrats, and 15% remain undecided.

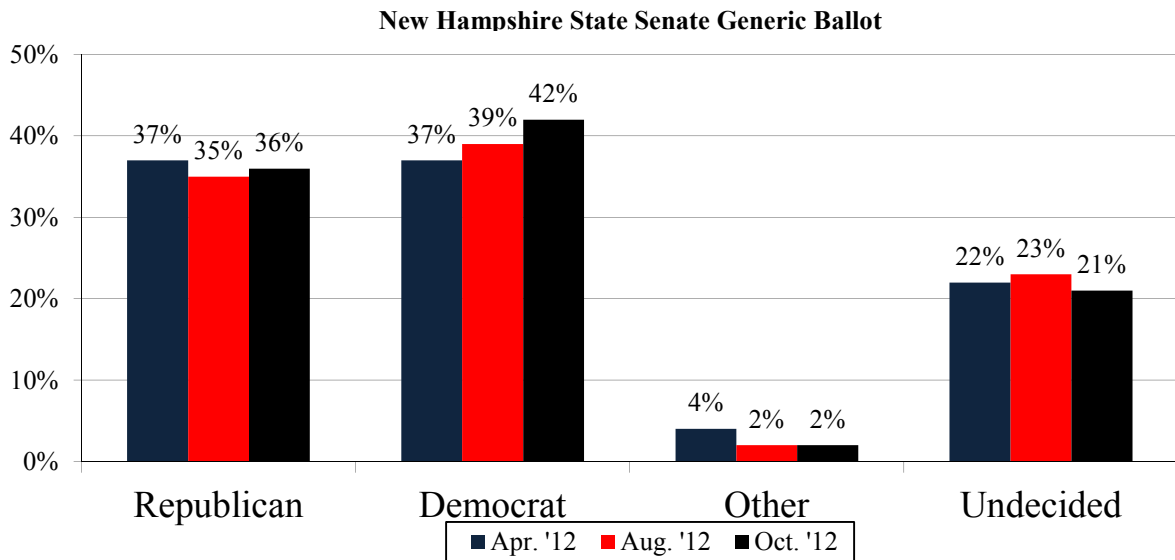
Based on an evaluation of past "generic ballot" polling in New Hampshire and actual election results, these results would translate into 196 seats for Republicans and 204 seats for Democrats. But this estimate, and the estimate for Senate seats, is highly dependent on actual turnout in November.



## New Hampshire State Senate

Likely 2012 New Hampshire voters are also more likely to say they will vote for Democratic candidates for SNH Senate than they have been in earlier polls. Currently, 42% say they will vote for the Democratic candidate from their district, 36% support the Republican candidate, 2% favor some other candidate, and 21% are undecided. When undecided voters were probed about which party they were leaning toward supporting, 45% say they will vote for the Democratic candidate in their district, 38% favor the Republican candidate, 2% prefer some other candidate, and 15% remain undecided.

Based on an evaluation of past “generic ballot” polling in New Hampshire and actual election results, these results would translate into 10 seats for Republicans and 14 seats for Democrats.



### Granite State Poll Methodology

These findings are based on the latest WMUR Granite State Poll, conducted by the University of New Hampshire Survey Center. Six hundred and thirty-eight (638) randomly selected New Hampshire adults were interviewed by landline and cellular telephone between September 27 and September 30, 2012. The margin of sampling error for the survey is +/- 3.9 percent. Included is a subsample of 600 likely general election voters (margin of sampling error +/- 4.0%).

The data have been weighted to adjust for numbers of adults and telephone lines within households, respondent sex, and region of the state. In addition to potential sampling error, all surveys have other potential sources of non-sampling error including question order effects, question wording effects, and non-response. Due to rounding, percentages may sum to just above or below 100%. Respondent numbers in each demographic may not equal the total respondent number due to respondents choosing not to answer some demographic questions.

A historical analysis was done looking at the results of the "generic ballot" question and the actual number of seats won by Republicans in the New Hampshire House and Senate in the 2000 through 2010 elections was presented at the annual meeting of the American Association for Public Opinion Research Annual (AAPOR), and is available from the UNH Survey Center.

The model developed in this paper used for estimating House seats from the generic ballot question (with undecideds probed) is:  
 $\text{HOUSE SEATS} = -245.842 + (2.383 * \text{2-party GOP estimate})$

In this Granite State Poll, the two party estimate of House seats for Republicans is 46.3% of 400 seats, or 185 (37% GOP / (37% GOP + 43% DEM = 46.3%)) is calculated and inserted into the formula above. This results in an estimate of 196 Republican House seats and 204 Democratic House seats.

The model developed for estimating Senate seats from the generic ballot question (with undecideds probed) is:  
 $\text{SENATE SEATS} = -40.0 + (4.5 * \text{2-party GOP estimate})$

In this Granite State Poll, the two party estimate of Senate seats for Republicans is 45.8% of 24 seats, or 11 (38% GOP / (38% GOP + 45% DEM = 45.8%)) is calculated and inserted into the formula above. This results in an estimate of 10 Republican Senate seats and 14 Democratic Senate seats.
