APPROVAL RATINGS FOR GOVERNOR LYNCH SLIP, ECONOMY AND STATE BUDGET TOP PROBLEMS



DURHAM, NH – Governor John Lynch's approval ratings have slipped to their lowest level since early in his tenure as governor. The economy remains the most important problem facing New Hampshire and there is growing concern about the state budget.

These findings are based on the latest **Granite State Poll**,^{*} conducted by the University of New Hampshire Survey Center. Five hundred and fifty-eight (558) randomly selected New Hampshire adults were interviewed by telephone between June 24 and July 1, 2009. The margin of sampling error for the survey is +/-4.1 percent.

Gubernatorial Approval


John Lynch has enjoyed very high job approval ratings since early in his first term as governor of New Hampshire, but they have slipped in recent months to their lowest level since his first year in office. Currently, 63% of NH adults approve of how he is handling his job as governor, 27% disapprove, and 11% are neutral or don't know. Lynch's support has dropped largely among Republicans -- only 48% approve of the job he has done in the current poll compared to 62% in the Spring Granite State Poll.




NH Gubernatorial Approval – John Lynch

Lynch's personal favorability rating has also dropped in recent months. In the latest Granite State Poll, 62% of New Hampshire adults say they have a favorable opinion of Lynch, 24% have an unfavorable opinion, 8% are neutral, and 6% say they don't know enough about him to say. Lynch's net favorability rating, the percentage having a favorable opinion minus the percentage having an unfavorable opinion, has fallen to +38%, down from +59% in April.



In June, Governor Lynch signed a law that allowed gay and lesbian couples in New Hampshire to marry after he had opposed this during the last campaign. Signing the same-sex marriage bill has hurt him somewhat politically with 28% of New Hampshire adults saying they are less likely to vote for him because he signed the bill, 19% say they are more likely to vote for him, but most Granite Staters, 52%, said it will have no effect on their vote. The impact of Lynch's signing of the same-sex marriage bill has occurred along partisan lines so the overall political impact should me only modest. Nearly half of Republicans (49%) say they are less likely to vote for Lynch because he signed the same-sex marriage bill while 38% of Democrats say they are more likely to vote for Lynch because he signed the bill.




More or Less Likely to Vote For Gov. Lynch because of Signing Same-Sex Marriage Bill

Most Important Problem Facing New Hampshire

New Hampshire residents continue to be worried about the condition of the state's economy. In the latest Granite State Poll, 32% of New Hampshire adults view the economy and jobs as the most important issue facing the state, followed by the state budget (22%), high taxes (11%), health care (6%), and how to fund primary and secondary education (3%). The percentage who name the economy as the most important problem facing the state has dropped considerably in recent months from a high of 43% in the Winter 2009 Granite State Poll, however, concerns about the state budget have increased as the Legislature and the Governor have wrapped up work on the budget.

Lower income residents, those with lower levels of education, and residents of Northern New Hampshire are most likely to say that jobs and the economy is the most important problem facing the state. Republicans and people earning between \$75,000 and \$100,000 are most likely to say the state budget is the most important problem.




Most Important Problem Facing NH

Right Direction or Wrong Track?

As the recession continues and as more controversial legislation, such as the same-sex marriage bill, is passed, New Hampshire residents are becoming less positive about the direction the state is heading. Currently, 55% of New Hampshire adults feel the state is heading in the right direction, 38% think the state is seriously off on the wrong track, and 7% don't know.

Democrats, liberals, and residents of the New Hampshire seacoast are most likely to think New Hampshire is headed in the right direction while Republicans and conservatives are most likely to say things are off on the wrong track.



Granite State Poll Methodology

These findings are based on the latest **Granite State Poll** conducted by the University of New Hampshire Survey Center. Five hundred and fifty-eight (558) randomly selected New Hampshire adults were interviewed by telephone between June 24 and July 1, 2009. The margin of sampling error for the survey is +/-4.1 percent.

The data have been weighted to adjust for numbers of adults and telephone lines within households, respondent sex, and region of the state. In addition to potential sampling error, all surveys have other potential sources of non-sampling error including question order effects, question wording effects, and non-response.
