### LYNCH JOB APPROVAL HITS RECORD HIGH

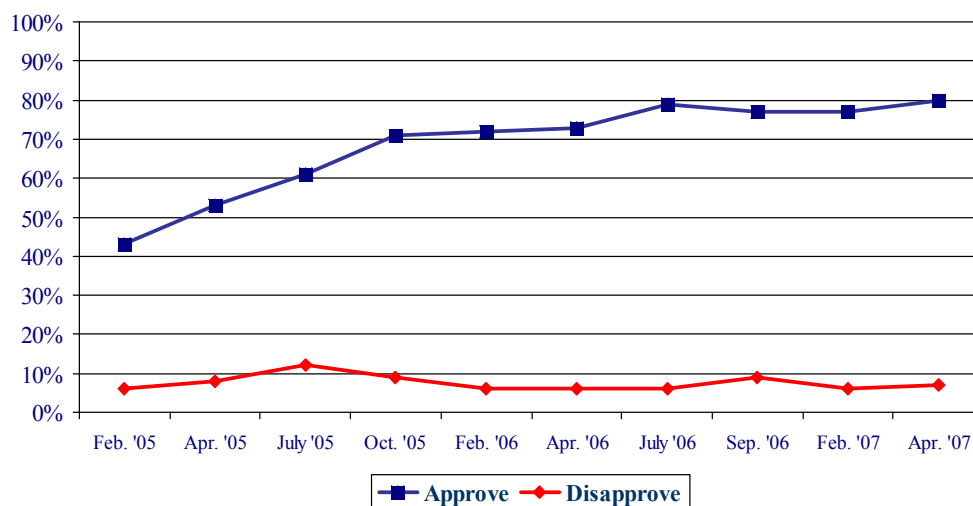
DURHAM, NH – New Hampshire Governor John Lynch continues to enjoy extremely high job approval. There is modest support to change the term of New Hampshire's governor from two years to four years.

These findings are based on the latest **Granite State Poll**,\* conducted by the University of New Hampshire Survey Center. The Granite State Poll is sponsored by CNN and WMUR-TV, Manchester. Five hundred fifteen (515) randomly selected New Hampshire adults were interviewed by telephone between March 27 and April 1, 2007. The margin of sampling error for the survey is +/-4.3 percent.

### Gubernatorial Approval

John Lynch's approval rating as New Hampshire Governor has reached a record high and for the past two years, Lynch has had staggeringly high job approval ratings. In the most recent Granite State Poll, 80 percent of New Hampshire adults say they approve of the job Lynch has done as governor, only 7 percent disapprove, and 12 percent are neutral.

### NH Gubernatorial Approval – John Lynch

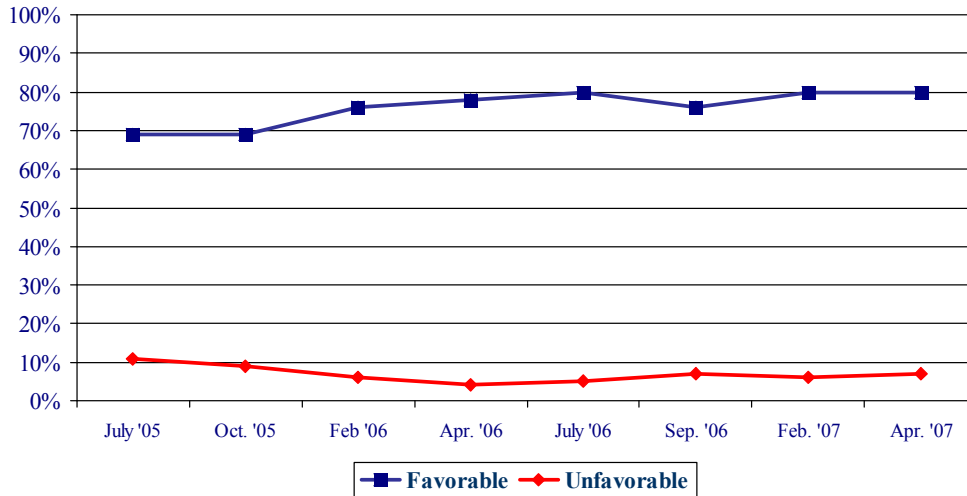


Lynch gets high job approval ratings from all political groups – 86 percent of Democrats approve of the job Lynch is doing as governor, 74 percent of Republicans approve, and 78 percent of Independents. “Lynch’s approval ratings were a major factor in the Democratic takeover of the State Legislature in 2006 and if they stay high, this will help Democrats in 2008 as well,” said Andrew Smith, Director of the UNH Survey Center.

Lynch's personal favorability rating is also very high. In the latest Granite State Poll, 80 percent of New Hampshire residents say they have a favorable opinion of Lynch, only 7 percent have an unfavorable opinion, 9 percent are neutral, and 4 percent say they don't know enough about him to say. Lynch's net favorability rating, the percentage having a favorable opinion minus the percentage having an unfavorable opinion, is +73 percent.

**Favorability Ratings – NH Governor John Lynch**



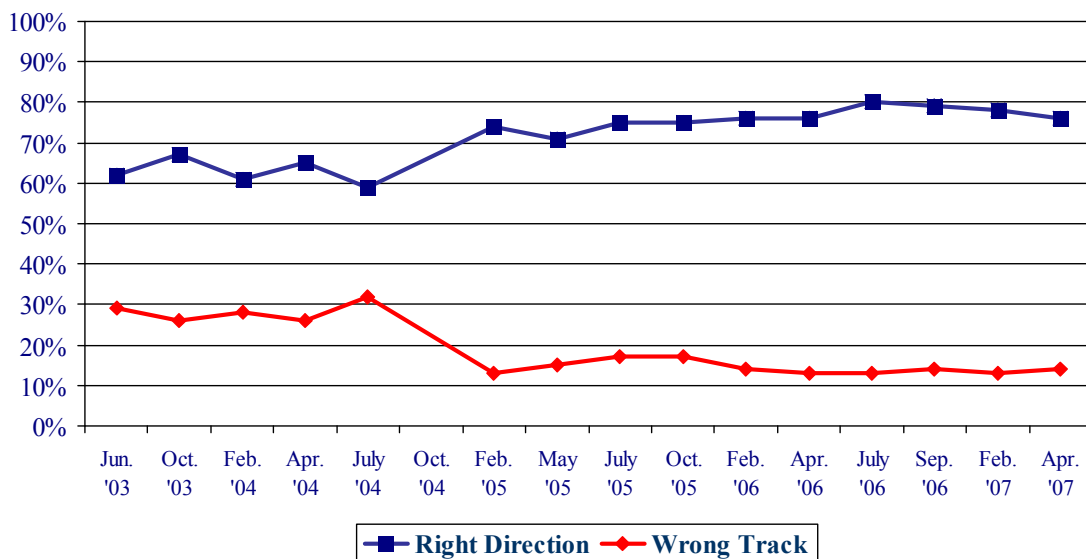
**A 4-Year Term?**

Currently, only New Hampshire and Vermont have 2-year terms for their governors. Recently, there was a proposal in the New Hampshire Legislature that would have extended a governor's term to 4 years. And while this proposal was defeated, a solid majority of New Hampshire adults, 58 percent, favor a 4-year term for governor, 32% oppose, and 9% are neutral or don't know.

**Right Direction or Wrong Track?**

Granite Staters are also extremely optimistic about the future of New Hampshire. Seventy-six percent think things in New Hampshire are generally going in the right direction, only 14 percent think things are seriously off on the wrong track, and 9 percent say they don't know. This indicator of optimism about the state has remained at very high levels over the past two years. By comparison, only 37% of New Hampshire adults believe the United States is headed in the right direction.

### Granite State Poll Methodology

These findings are based on the latest **Granite State Poll**, conducted by the University of New Hampshire Survey Center. The Granite State Poll is sponsored by CNN and WMUR-TV, Manchester. Five hundred fifteen (515) randomly selected New Hampshire adults were interviewed by telephone between March 27 and April 1, 2007. In 95 of 100 cases, the statewide estimates will be accurate to plus or minus 4.2 percent. Results reported for other subgroups have potential for somewhat larger variation than those for the entire population.

The data have been weighted to adjust for numbers of adults and telephone lines within households, respondent sex, and region of the state. In addition to potential sampling error, all surveys have other potential sources of non-sampling error including question order effects, question wording effects, and non-response.
