### BUSH APPROVAL DROPS TO NEW LOW IN NH

DURHAM, NH – President Bush's job approval ratings in New Hampshire have dropped to the lowest level of his administration. Unhappiness with the war in Iraq is now cutting into Bush support among core Republicans.

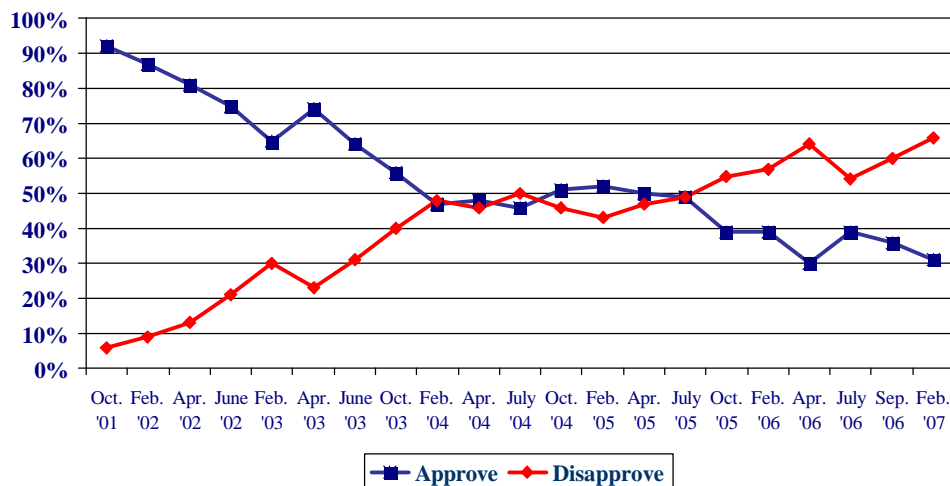
These findings are based on the latest **Granite State Poll**,<sup>?</sup> conducted by the University of New Hampshire Survey Center. The Granite State Poll is sponsored by WMUR-TV, Manchester. Five hundred thirty-eight (538) randomly selected New Hampshire adults were interviewed by telephone between February 1 and February 5, 2007. The margin of sampling error for the survey is +/-4.2 percent.

#### Presidential Approval

Heading into his final two years as President, President George W. Bush's job approval ratings in New Hampshire have dropped to new lows. In the most recent Granite State Poll, only 31 percent of New Hampshire adults say they approve of the job Bush is doing as president, 66 percent disapprove, and 4 percent are neutral. "Bush's low approval ratings hurt New Hampshire Republicans in the 2006 elections," said Andrew Smith, Director of the UNH Survey Center. "If they continue to decline, it will put an additional burden on the eventual Republican nominee for President in 2008."

A further problem for Bush is that Republicans are losing faith in his administration. Currently, only 66% of Republicans approve of the job Bush is doing as President, down from 75 percent in September and 79 percent last February.

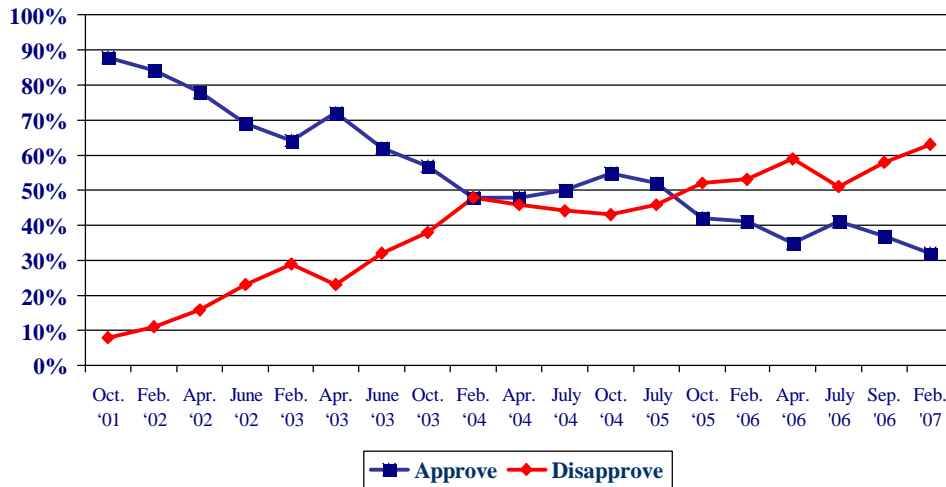
Presidential Approval – G.W. Bush

Bush's personal favorability rating have also reached a new low. Currently, only 32 percent of New Hampshire adults have a favorable opinion of Bush, 63 percent have an unfavorable opinion of him, and 5 percent are neutral. Bush's net favorability rating, the percentage having a favorable opinion minus the percentage having an unfavorable opinion, are at an extremely low -31 percent.

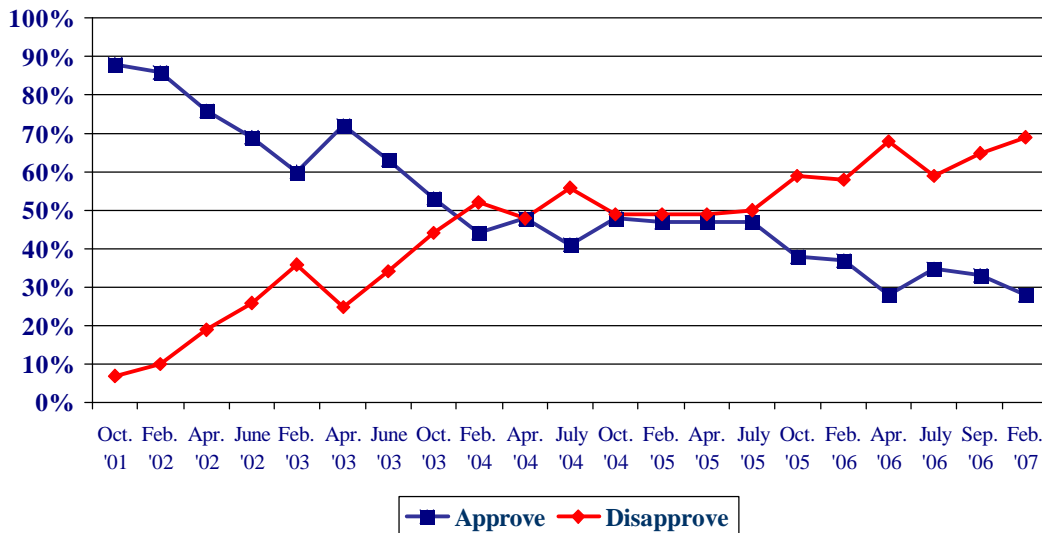
**Favorability Ratings – G.W. Bush**



**Foreign Affairs**

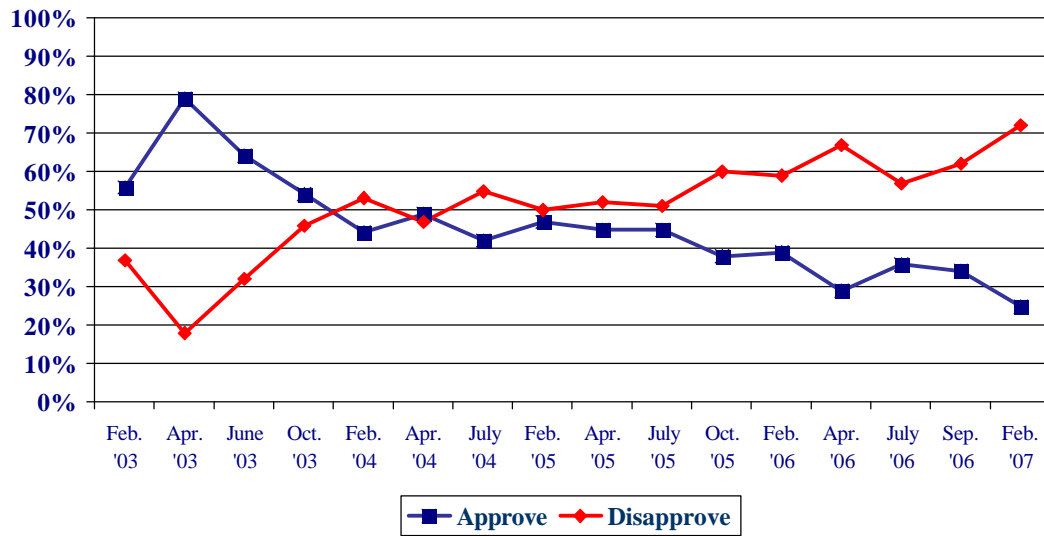
Discontent with the war in Iraq is the major reason Bush's approval ratings continue to slide. When asked about how the President is handling foreign affairs, only 28 percent of New Hampshire adults say they approve, 69 percent disapprove, and 3 percent are neutral.

Looking specifically to Iraq, only 25 percent of Granite State adults approve of the way Bush has handled the situation there, 72 percent disapprove, and 2 percent are neutral. Bush has lost the support of many Republicans for his Iraq policy – only 54 percent of Republicans approve of his handling of the war in Iraq and 41 percent disapprove..

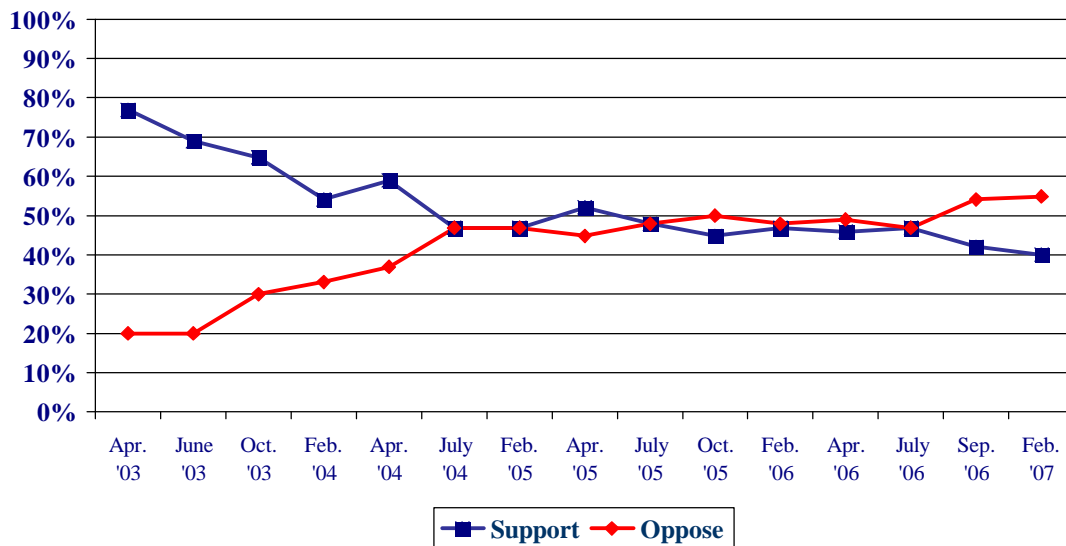
**Bush Approval: Handling Situation In Iraq**



New Hampshire adults were asked specifically if they favor or oppose the recent surge in the number of U.S. troops in Iraq and a large majority disapprove. Only 33 percent of New Hampshire adults favor the surge, 64 percent disapprove, and 4 percent are neutral or don't know. Republicans are the strongest supporters of the surge while 90 percent of Democrats oppose the surge.

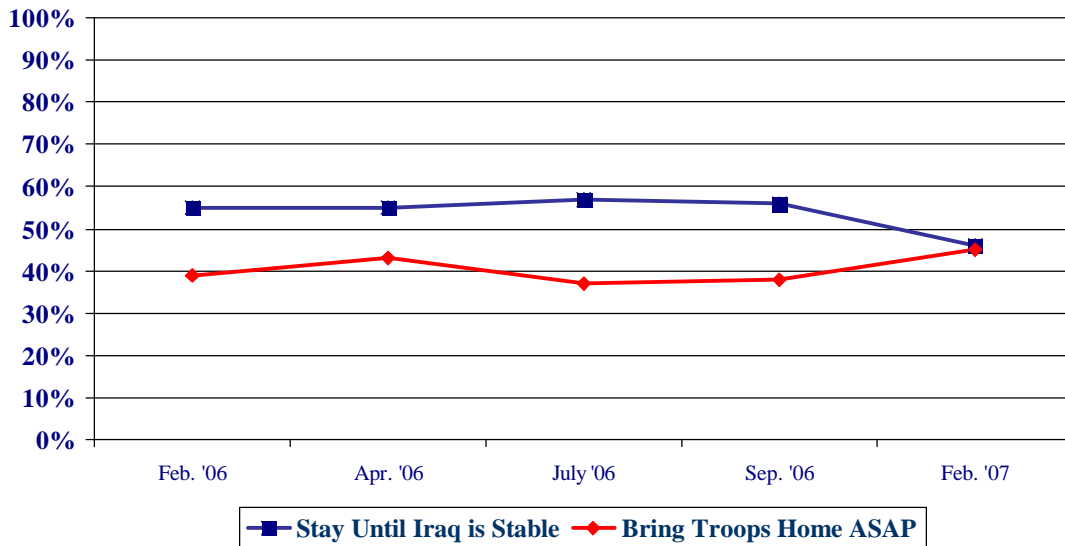
Support for going into Iraq in the first place has also declined in recent months. Currently, only 40 percent support the U.S. having gone to war in Iraq, 55 percent oppose the U.S. having gone to war, and 5 percent are neutral. Support for the U.S. having gone to war with Iraq is at its lowest level since the U.S. invasion.

When asked what U.S. troops should do in Iraq, only 46 percent now think they should stay until the situation has stabilized, 45 percent think the troops should be brought home as soon as possible, and 9 percent don't know. Support for an immediate withdrawal of U.S. troops is at its highest level, in opposition to the recent surge in U.S. forces.

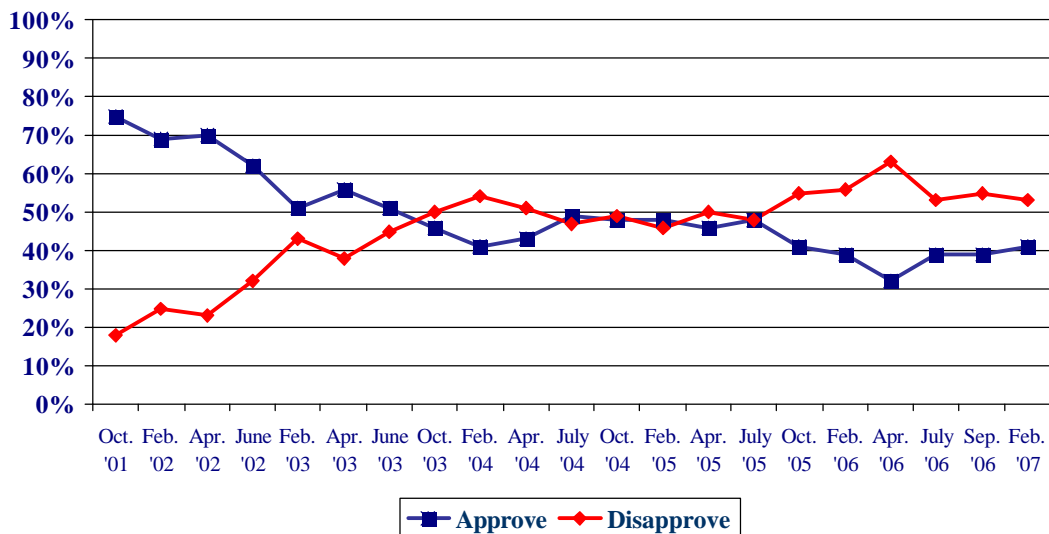
### U.S. Troops in Iraq



### Economic Approval Rating

New Hampshire residents continue to be pessimistic about the economy in the U.S. Even though the U.S. and New Hampshire economies are continuing to grow, only 41 percent of New Hampshire residents say they approve of the job President Bush is doing handling the economy, 53 percent disapprove, and 5 percent are neutral.

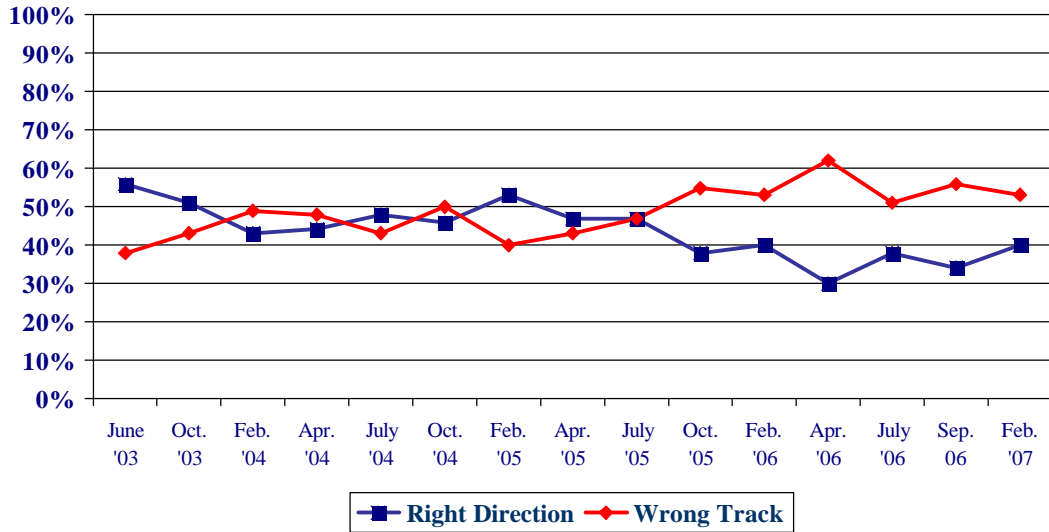
### Bush Approval: Handling the Economy



### Right Track – Wrong Track

New Hampshire residents remain pessimistic about the direction the country is heading. Only 40 percent of New Hampshire residents think that things in this country are generally going in the right direction, 53 percent think things are seriously off on the wrong track, and 7 percent don't know. Only Republicans and conservatives think that the U.S. is headed in the right direction.

### Granite State Poll Methodology

These findings are based on the latest **Granite State Poll** conducted by the University of New Hampshire Survey Center. The Granite State Poll is sponsored by WMUR-TV, Manchester. Five hundred thirty-eight (538) randomly selected New Hampshire adults were interviewed by telephone between February 1 and February 5, 2007. The margin of sampling error for the survey is +/-4.2 percent. Results reported for other subgroups have potential for somewhat larger variation than those for the entire population.

The data have been weighted to adjust for numbers of adults and telephone lines within households, respondent sex, and region of the state. In addition to potential sampling error, all surveys have other potential sources of non-sampling error including question order effects, question wording effects, and non-response.
