NH – MAKE CANADIAN PRESCRIPTIONS LEGAL

DURHAM, NH – New Hampshire adults strongly support the federal government legalizing the purchasing of prescription drugs from Canada.

These findings are based on the latest **Granite State Poll**, conducted by the University of New Hampshire Survey Center. The Granite State Poll is sponsored by the University of New Hampshire. Five hundred forty-two (542) randomly selected adults were interviewed by telephone between April 19 and April 26, 2004. The margin of sampling error for the survey is +/-4.2 percent. Legalize Prescription Purchasing from Canada

For many years, a growing number of seniors in New England have taken the trip north to buy prescription drugs in Canada, where they can be purchased at significantly lower prices than in the United States. Governors in many states, including New Hampshire, have also looked at purchasing drugs in Canada as a way of reducing health care costs for state employees. It is not currently legal under federal law for either states or individuals to buy prescription drugs in Canada, although legislation has been introduced in Congress to permit individuals to buy prescription drugs north of the border.

The US Food and Drug Administration (FDA) has argued that the safety of prescription drugs from other countries cannot be assured. New Hampshire Governor Craig Benson has asked for a waiver from the FDA so that the state could buy drugs in Canada for Medicaid patients and state prisoners. In the latest Granite State Poll, New Hampshire adults were asked if they favored or opposed the federal government making it legal for people to buy prescription drugs from Canada - 81 percent support making this legal, 14 percent oppose, and 5 percent are unsure. Large majorities of people in all political and demographic groups support making the purchase of prescription drugs from Canada legal.

“Governor Benson is smart to push for a waiver on fiscal grounds as it would save the State of New Hampshire a lot of money if prescription costs could be reduced,” said Andrew Smith, Director of the UNH Survey Center. “It is also a smart move politically given public support for the idea.”

As of now, most people in New Hampshire have obeyed the law. Only 4 percent say they have ever purchased prescription drugs from Canada and only 10 percent of adults 65 and over have purchased prescription drugs in Canada.

Granite State Poll Methodology

These findings are based on the most recent Granite State Poll conducted by the University of New Hampshire Survey Center from April 19 to April 26, 2004. A random sample of 542 New Hampshire adults was interviewed by telephone. In 95 of 100 cases, the statewide estimates will be accurate to plus or minus 4.2 percent. Results reported for other subgroups have potential for somewhat larger variation than those for the entire population.

The data have been weighted to adjust for numbers of adults and telephone lines within households, respondent sex, and region of the state. In addition to potential sampling error, all surveys have other potential sources of non-sampling error including question order effects, question wording effects, and non-response.
