Dear Mr. Temianka:

Mrs. Lyngby has asked me to answer your letter of May 10th. It is extremely generous of you to offer to teach Barbara Woodard giving her personal scholarship. However, I am afraid that we cannot let you do that. You see, handling of scholarships is a very difficult thing and since almost no teacher will have a schedule full, everyone will be willing, I think, to teach some of his students at no cost and this would make a great deal of trouble. We have given no student both full scholarship and also a job working for his room and board. Since you have been so nice about everything and

since we would like to do the most we can, we should like to give Barbara Woodard inaddition to a job for her room and board, which is worth \$200, also half her tuition of \$125. That would mean that all she has to pay is \$125, covering her complete tuition as well as her private lessons with you. She would, I am sure, be an asset in the orchestra. All students who have scholarship help or room and board jobs are required to play in the orchestra, if qualified.

It is good news that your article will appear in the June Etude.

Thank you for giving your preference of teaching schedules and we shall arrange everything as much as possible to suit you. I am looking forward very much to the summer and having some time with you all.
