I am in receipt of your note and enclosure of November 22, 1977.

We have recently received several copies of the hate mailing which you transmitted to us. The individual responsible for this venomous anti-Semitism is George Dietz, head of Liberty Bell Publications in Reedy, West Virginia.

Dietz appears to be a rather well-heeled bigot, who has taken upon himself the effort of the coalesce Nazi sympathizers throughout the country. He is responsible for two monthly publications--the Liberty Bell and White Power Report--both of which are predominantly anti-Jewish.

As you might imagine, we are watching Dietz and his various operations very closely.
