Dear Mr. Rabinoff

Enclosed is my check # 7687 in the amount of \$ 114.00 with a copy of refund from Department of Motor Vehicles dated April 13, 1978. Upon receipt of this refund, I immediately wrote my check to reimburse you for the fee you paid. I was going to hand this check to your representative upon delivery of the car, which I thought would certainly be ready by then.

Now; upon return from my trip I tried repeatedly to contact your representative, Mr. Preston Tyree, to make arrangement for the delivery of the car, only to have the girl in the office of James Young Rolls tell me he was not in. On May 3rd, I left word for Mr Tyree to be sure and call me back. I called again on May 4th and again on May 5th only to be told he had left for Las Vegas. On May 15th, the office girl said he was out and I told her to have him call me immediately upon his return as it was most important and I did not intend to call again. On May 17th, Mr. Tyree did call back and I asked him if the car was ready. After discussing the matter, he said they were finishing up certain work and that the car would be ready in two weeks, to call him on May 31st. On May 31st, a Mr. Mike Lasandro of your company called my office. As I was not in, he left word to call him back - which I did, only to be told he had left and would not be back for a day or two. I told the office girl to put Preston Tyree on the phone at once. He came to the phone and when I told him the girl said Mr. Lasandro would not return for a day or two he said that's not so, I just sent him on an errand and he would have him call me. I inquired who Mr. Lasandro was; he said he was the man working on the car and would have him get in touch with me as he was handling it. I called again on June 5th and on June 6th and was told the car was still not ready.


I am at the end of my patience. It has now been well over a year and I have been paying \$40.00 per month for an extra parking space in our garage and insurance on the car and I've never had one hour's use of the car.
