## A Special Announcement

On September 28, 1946, the members of the Valparaiso University Guild who attended the fifteenth annual convention of the Guild were privileged to witness the laying of the cornerstone of Guild Hall. We feel sure that every Guild member was deeply moved by the impressive ceremonies. Here, before our eyes, that which had hitherto been only a dream and a hope began to take shape. Here we saw the first concrete evidence of the goal toward which we are working.

Unless unforeseen difficulties arise, Guild Hall will be completed late in June or early in July, 1947. The Administrative Committee feels sure that every Guild member who can possibly arrange to do so will wish to take part in the dedication of the new dormitory. For this reason tentative plans are being made to hold the sixteenth annual convention of the Guild at the time of the dedication. Since many Guild members will undoubtedly be visitors at the triennial meeting of the Mis-

## Reports of state units . . .

We are presenting herewith the reports of the State Unit meetings. Because of lack of space it has been necessary to condense many of the reports submitted.

#### WISCONSIN STATE UNIT

The air was crisp, the sun bright on this beautiful fall day of October 29, 1946. The mum corsages which were received by each delegate upon registration blended well with the decorations carried out in the colors of the school. It was a day well to be remembered, this first meeting of the Wisconsin State Unit of the Valparaiso University Guild. It was held at the Sherman Park Lutheran Church, and Mrs. W. H. Pruemers presided. A hymn was sung, accompanied by Mrs. Linda A. Mohr. This was followed by a prayer and a reading from Holy Scripture by the Reverend Maurer.

Mrs. Pruemers heartily welcomed the delegates and was happy to see so many out-oftown guests. Said Mrs. Pruemers, "By your presence here today we know that you are interested in Valparaiso University. May your interest ever increase for the youth of today because that means the welfare of posterity. Let no task be too small, nor any service too trivial to give to this institution which will give us our leaders for the church of tomorrow. For what better work could we do than to work for the upbuilding of our Church? Valparaiso is one of the hopes of our Church. Let us keep striving, for there is still so much to be done. We all know that when we build with the Guild, we build for the Church."

The officers of the Unit were introduced, followed by a reading of the minutes of our organization meeting of April 6, 1946. Also, a complete treasurer's report was given.

We should like to pay tribute to our Field Secretary, Miss Lydia E. Schultz, who is the connecting link between the State Unit and the National Guild. Her attendance and cooperation with all chapters has been commendable and outstanding. Miss Schultz gave us some highlights in her annual report and finished by stating that all should work for the good of youth and children.

Chapter chairmen as called upon gave fine reports of projects and growth. A total of 180 reservations was reported, 98 from Milwaukee and 82 out-of-town guests.

The President gratefully thanked these

delegates for their hard work, for their fine projects, and for the great interest they show in Valparaiso.

Mrs. Charles Pretzke, Auditing Chairman, was called upon. She reported the treasurer's books in good order.

Mrs. Pruemers, under new business, introduced the Nominating Chairman, Mrs. Alvin Dobbratz, who presented her slate.. There also were nominations from the floor.

Mrs. E. F. Stegman, our First National Vice-President, then was introduced. She gave a splendid report of the National Convention and praised the fine work of our Field Secretary and State Unit. She stated that Wisconsin was the first to organize and hold its annual meeting and that Miss Schultz was the first Field Secretary to make a complete round of visits to all the chapters of her state.

The group recessed to the dining quarters of the church for a delicious luncheon served by the ladies of the church.

A vocal solo by Joyce Watson Holt, accompanied by Mrs. Linda Mohr; piano selections by Mrs. John Ungrodt; and readings by Miss Jewel Reinke opened the very interesting and stimulating afternoon session.

Mrs. Hoppe, past National President, our speaker, was introduced by Miss Schultz. Her topic was "What the Guild Stands For. She said, "Five years ago a campaign was started for Guild Hall. The work was begun in the spring of 1942. The response was magnificent. \$70,617.47 has been turned over to the University, \$9,000.00 is still owing in pledges. There have been quite a few important developments at the University: new courses in religion, home economics, engineering and law; new faculty members; many returned veterans; redecorated auditorium; and many more too numerous to mention."

Of course, our annual meeting would not be complete without adjusting the wheels which keep our chapters growing, so the following amendments were adopted: ARTICLE 8 on funds and CHAPTER 10 of our National By-Laws.

#### INDIANA STATE UNIT

The fall season and the first Indiana State Unit meeting of the Valparaiso Guild were alike - - both lovely. On Saturday, November 2, 1946, the members of the Mishawaka-South Bend Chapter were hostesses at the noon luncheon and the business session in St. Peter's Auditorium in Mishawaka, Ind.

As the guests arrived they were greeted by the general chairman, Mrs. John Gleason, and two of her assistants, Mrs. Harold Schoch and Mrs. Paul Winkelman. At the registration desk Mrs. O. H. Muenter, Mrs. William Essig and Mrs. W. Otterstein held sway, checking names and passing out clever "V" shaped identification cards with bright little 'mums attached.

The tables in the spacious auditorium were decorated with huge bouquets of yellow and bronze 'mums, and great brown and yellow cornucopia filled with harvest-time fruits and vegetables adorned each table. The ladies of St. Peter's served a most delectable lunch, and credit for its success is due Miss Amanda Fischman and her assistants.

Mrs. E. W. Broders offered the table prayer, and Mrs. Charles Farnsworth, the local Chapter President, welcomed the guests. The meeting was then turned over to the State President, Mrs. E. V. Bartholomew of South Bend, who in turn introduced the speakers of the day.

Miss Ruth Lehman, a talented vocal and piano student at Valparaiso University, delighted us with several solos; and her sister, Miss Katherine Lehman, violinist, Miss Ruth Evens, cellist, and Miss Roberta Esch, piano, further delighted us with their "Tafelmusik."

The Rev. Armin Oldsen, who has on previous occasions endeared himself to members of the Guild with his sermons at Immanuel Lutheran Church in Valparaiso and with his

lectures, spoke to us on "Christian Personality." His fine wit and fluency of speech, as well as his psychology, were again felt in this talk.

The charm of Norway manifested itself in the personality of the next speaker, Miss Gerd Bache, a scholarship student at Valparaiso University and a former student at the University of Oslo, Norway. Her descriptions and anecdotes of Norway were most interesting, and her experiences during the war brought near to us some of the tragedies we in America were fortunate to escape.

After a fifteen-minute recess, which provided opportunity for visiting with friends from other cities, we assembled for the business session. Devotions were spoken by Mrs. Richard Stuckmeyer. Roll call revealed that 73 were presents and that five of Indiana's eight chapters were represented.

Minutes of the organizational meeting in Ft. Wayne in October were read by Miss Lois Sohn, the secretary.

The report of the President, Mrs. Bartholomew, was made in her usual gracious and efficient manner, which tends to strengthon any new organization and should prove a most valuable asset to the Indiana State Unit. In her report she told us the purpose of the State Units. She also told how the latest Guild Convention held in Valparaiso had a threefold inspiration since it was the 15th anniversary of the Guild, the 21st anniversary of the University as a Lutheran institution, and it was the cornerstone laying of the Guild's dream - - Guild Hall. She said Guild members must try to make new contacts, interest new friends, write pastors, and contact several key-women of congregations who are interested in the University and incite them to form new chapters. She suggested that we keep the University before the people through church bulletins and newspaper articles about the activities of the various chapters. She thanked all officers for their cooperation in forming this new State Unit, and she urged that "Build with the Guild" be a challenge. She expressed the assurance that with the help of God the Guild shall not fail.

Mrs. E. F. Stegman, vice-president of the Guild, in giving the highlights of the Guild Convention did so in such a delightful and informative way that we felt we were listening to a charming story, as indeed we were, instead of a report. Her enthusiasm and vision always awakens in us the desire to

work harder to accomplish more and more.

Mrs. E. Kurth, Field Secretary, then made her report, commending the committee for having capably and competently arranged the first State Unit meeting. She recommended that each member contact at least one new member so that each chapter reach an unprecedented enrollment. She told that new chapters are ready to be organized, namely Huntington, LaPorte and Decatur. She read greetings and regrets also from Indianapolis and northeastern Indiana chapters who were unable to be represented because of a flu epidemic. She suggested that ladies in rural communities be contacted to form chapters.

One of the most interesting discussions of the afternoon came when the chapter presidents reported on various activities and projects. These reports revealed the intense activity of the chapters within our state and each chapter president received many unique and profitable suggestions for their "coming attractions."

The latter extended a hearty welcome to the group and said she hoped this meeting would fulfill its purpose of being a connecting link between the national convention and the local chapters, also, that the members would gain a better knowledge of the working of the Guild. She also explained the meaning of the Guild Seal, designed by our chairman, Mrs. Bodenstab, and the slogan suggested by our vice-chairman, Mrs. Ed. Jaeger.

The chairman welcomed six visitors from the Milwaukee group. She also stated that a letter had been received from Miss Lydia Schultz, field secretary for the Wisconsin Unit, expressing her regret at not being able to attend this meeting.

The chapter chairmen were then introduced, and each one was requested to give a short report on the activities in her respective group.

Mrs. A. A. Taube, the Northern Illinois Field Secretary, then reported that the national body now is composed of fifty chapters. Before State Units were formed each of these reported at the National Convention. Now this is eliminated. The local chapters report at the State Unit meetings, which in turn report at the National Convention. She stated she was glad to see so many young and active chapters, all trying hard to meet their goals. One of her duties is to organize new chapters, which in some areas is exceedingly difficult. She asked everyone to give her the names of pastors in whose congregations young people are attending Valpo, in the hope that they may be inclined to help along in this work. Northern Illinois now has eight chapters with Aurora possibly being the next entrant. She offered a copy of the Activities Manual to chapter officers.

Mrs. E. T. Birner, the Field Secretary for Central Illinois, and who is also our National Second Vice-President, was introduced; also our National Treasurer, Mrs. G. E. Penson.

The Nominating Committee then reported that since the present officers had not had an opportunity to exercise their duties, they were requested to run again for their respective offices. This they consented to do. However, since the constitution calls for two candidates for each office, a slate was presented to the convention.

Mrs. W. Harms of Chicago, Mrs.F.H.Lichthardt of Elgin, and Mrs. G. Dennis of Rockford, were appointed as tellers. The ballots were distributed and collected. The meeting adjourned for luncheon, during which Miss Betty Ann Schmeling, a student at Valparaiso University, favored the ladies with several vocal selections, masterfully executed.

That a hearty thanks be extended to all who helped to make the first State Unit meeting a success.

An invitation was then proffered by the Elgin and Dundee Chapters for the 1947 Convention.

The duly-elected officers were then installed by the National Second Vice-President, Mrs. Birner.

After adjournment the Rev. F. Brunn led the convention in a short closing devotion.

held in Zion Lutheran Church, Columbus, Ohio, on November 15, with the Columbus Chapter as host.

The meeting was opened with the singing of the hymn, "We Praise Thee, O God, Our Redeemer, Creator." Opening devotions were conducted by the Rev. O. F. Stolzenburg, pastor of Zion Lutheran Church.

Mrs. Ed. Grugel, president of the Columbus Chapter. graciously extended greetings to the assembly; and Mrs. N. E. Bishop, Ohio State Unit president, welcomed the members of the State Unit in her usual charming manner.

Mrs. Edward Block, secretary, read the minutes of the organization meeting, and Mrs. Fred Nordsiek gave the treasurer's report.

Roll call revealed that all of the chapters of the Ohio State Unit were represented, totaling approximately seventy, not including the Columbus Chapter. The largest single delegation came from Union County, with the Lancaster Chapter second largest in attendance.

Our dream and aim of the past five years, namely, Guild Hall, will soon be realized, and our thanks go to a good and gracious God who has guided, blessed and directed the Guild in her service to the University.

We were pleased to have as our special guest Mrs. E. F. Stegman, first vice-president of the National Guild.

The Open Forum included a report from each Chapter of the State Unit as to some of the highlights of its activities during the past year.

At the close of the reports Mrs. Bishop urged that each Chapter send in a report on its activities to Mrs. E. N. Moore, 1195 Lakeland Avenue, Cleveland, Ohio, who is Activities Chairman.

Mrs. W. N. Hoppe, Cleveland, past president of the Guild, could not be present but

sent a letter of regret which Mrs. Bishop read. She gave the highlights on Guild Hall and encouraged us to rededicate our energies for Guild Hall.

The next item of business was the report of the Field Secretaries. Mrs. Bishop first called upon Mrs. H. W. Bartels, Ohio Field Secretary. Mrs. Bartels said she was proud to be a Field Secretary for Valpo, and commended Mrs. John Barnes for her help. She reported that she is in the process of organizing a new chapter in Van Wert, Ohio, and that a Chapter had recently been organized in Cincinnati, Ohio with approximately 40 members; and that the recently organized chapter in Akron, Ohio, is represented for the first time at our meeting today and has now approximately 110 members. This fine report was highly commended.

Miss Emily Doell, New York Field Secretary, was unable to be with us, and a letter was read from her extending greetings to the assembly and expressing her regrets in not being present.

Mrs. J. F. Woessner, Field Secretary for Pennsylvania, reported that she is trying to organize a chapter in Erie, Pa. She has also written letters to pastors in Philadelphia, York and Lanacster, Pa., in which she has tried to make contacts for an opening to form new chapters. They were all very courteous in their replies and hope to cooperate at a later date. She has also tried for contacts in Washington, D. C., Baltimore, Md., and Richmond, Va. She remarked she believes a personal contact is best and that she is trying hard to lay the ground work and hopes some day to report at least one new chapter.

The Chair then asked that if any of the ladies have suggestions for new chapters, to kindly forward them to the respective Field Secretaries.

After the serving of a delicious luncheon by the ladies of the Columbus Chapter and a pleasant visit with our guests, we were entertained with numerous organ selections by Emma Held Buchsieb, organist at Zion Lutheran Church.

the National Guild to read as follows: Article X, Section 1—Proposed amendments to the State Unit By-Laws must be in complete harmony and accord with the National Guild By-Laws and must be sent to the Administrative Committee of the national body at least 90 days preceding the State Unit meeting. Amendments may be made to the State Unit By-Laws by a two-thirds vote of the members present and voting at the annual meeting.

The resolution was moved, seconded, and adopted.

Mrs. Ruff also moved the adoption of the following resolution:

BE IT FURTHER RESOLVED that the change made by the National Guild in Article VIII, Section 2 be adopted to read as follows: Article VIII. Section 2—Any residue from sums as may be collected over and above an estimated working capital of the State Unit shall be sent direct to the National Treasurer at the close of each fiscal year for the Project Fund of the Guild. The resolution was seconded and carried.

The Nominating Committee, consisting of Mrs. F. J. Schumm, chairman, Toledo; Mrs. John Pohlman, Buffalo, and Mrs. M. P. Thompson, Cleveland, presented their candidates for office.

The Chair then introduced the Rev. Walter Schroth of the Department of Public Relations at Valparaiso University and Field Representative in Western New York and Pennsylvania, who then addressed the meeting.

The Nominating Committee gave the following report:

President, Mrs. N. E. Bishop. Vice-President, Mrs. John Barnes. Secretary, Mrs. Edward Block. Treasurer, Mrs. Fred Nordsiek.

Mrs. N. E. Bishop, chairman, then expressed her thanks to the Columbus Chapter for their hospitality, and a resolution was passed expressing gratitude to all who helped make the meeting a success.

Invitations for the next meeting of the State Unit were received from Mrs. Pohlman on behalf of the Buffalo Chapter, Mrs. Barnes of the Maumee Valley Chapter, and Mrs. Ruff of the Lancaster Chapter. In accordance with the State By-Laws, the final decision as to the place of next meeting is left to the decision of the State Board.

After closing devotions the newly-elected officers were installed by the Rev. Stolsenburg

and the singing of the Doxology brought the Convention to a close.
