On 9-1-88 Det. Sgt. Vince Kremperger, Det. Ed. Favre and Det. Kurt Fensel of Lakewood P.D. requested record check and information on RICHARD EBERLING, DOB 12-8-29.

EBERLING admitted that he had committed thefts of jewelry belonging to Marilyn Sheppard from the home of Richard Sheppard. He also admitted to being the window washer for Sam and Marilyn Sheppard in 1954 and in fact had just washed the windows prior to Marilyn's murder. He stated that he deposited blood in the Sheppard residence when he cut himself while washing windows. Upon EBERLING's arrest in 1959, statements were subsequently taken from him by Sgt. Jay Hubach and Prosecutor Patrick Gareau. Coroner Sam Gerber also interviewed EBERLING.
