Irene and I are pleased with Gerry's success and, quite frankly, to have known both of you as the kids were chasing around under the sun. Our very best to both of you.

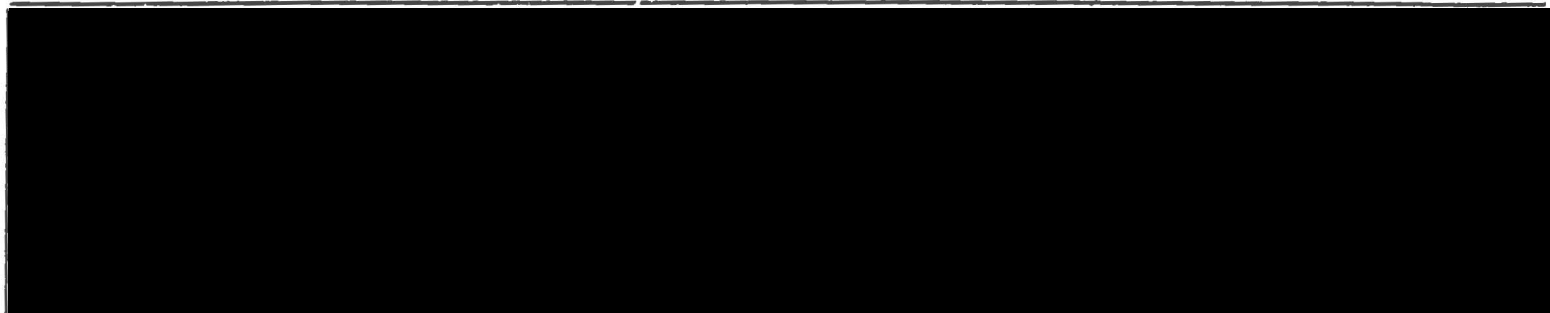
