Of these, 23 are tuition students. 18 of our elementary pupils are attending Moose River school on a tuition basis. This arrangement is very satisfactory in that it takes care of our overflow so that we have not had to open the station school. It also makes a lighter teacher load.

I hope that we can continue this arrangement next year. The only alternative is hiring another elementary teacher and opening another classroom.

### TEACHERS

There have been three changes in the staff although we have only two new teachers.

Mrs. Nichols resigned at the end of the year much to our regret. Mrs. Johnston was transferred to the Primary Grades and I am glad to report is doing excellent work.

Mr. Roland Holden was engaged to teach the upper grades

and already the good effects of a man teacher for the older pupils is apparent.

In the High School Miss Catherine Hanson took the place of Mr. Oliver Ward. Her academic work is very good and I am sure her pupils are progressing.

I would recommend that anyone interested in the work of the High School or grades visit the school and see for themselves how things are going.

The roof was replaced during the summer and several small repair jobs done. The rest of the seat order came so that now all seats are moveable. Several in the primary room are of the old type and rather out of repair so that we probably should add a few soon.

Several new geographies and histories were purchased this year to replace the old Rugg Social Studies tests. The Rugg books may still be used for reference as there is much good material in them but they are hopelessly out of date, not having been revised since long before World War II.

You will see from my financial report a discrepancy between the amount of money raised to pay the overdraft of \$1,020 and the actual overdraft of \$1,204. This was due to an error in addition in last year's report and was found by the auditor. We have therefore still a small overdraft which I hope we can clean up this year.

The auditor suggested that it might be well for the town to vote to re-appropriate the balance in Repairs for this year to be placed in a permanent building and repair fund and that a little be added each year against the time when we shall have to enlarge or build new buildings.

The fine cooperation of school committees, teachers, and citizens this year have been greatly appreciated.

Both teachers are extremely conscientious and are cheerfully putting forth every effort for the best interest of the pupils.

### PUPILS

#### Senior Class, 1949

Three girls plan to enter training for the nursing profession. One girl plans to enter secretarial work. Another girl plans to train for medical secretarial work. One boy plans to become an electrician. The other members are undecided about their future plans at present.

#### Graduates of Former Years

An increasing number of graduates are going on to higher institutions of learning or are taking courses to fit themselves for skilled labor, business or a profession. Very good reports

of this work are frequently received. A few are on the Dean's List (high honors) at College. It is considered an outstanding achievement for a boy or girl from a small high school to make the Dean's List and these students are to be congratulated.

The great majority of those who do not go further with their education seem to find good paying work and to be progressing well vocationally and as good citizens.

## CURRICULUM

Few changes have been made in the curriculum. Units of Consumer, Buying Studies and Family Relations have been integrated with Economics in line with what most other up to date high schools are doing.

## PARENTS

Most parents cooperate very well with the school by encouraging their children in good behavior habits and in developing a serious attitude toward the importance of good school work.

A few pupils sometimes do not seem to realize how tremendously important for their future welfare it is to do serious purposeful school work. Frequent encouragement at home along these lines is very helpful.

## BUILDING AND EQUIPMENT

Mr. Manchester Moore has very conscientiously kept the building comfortably heated and very clean. All floors are thoroughly scrubbed once a week and swept once a day.

A new typewriter has been added making six machines in all now.

## ATHLETICS

Although not in the league several games with other schools have been played. Lang Holden's excellent coaching shows up more and more in the improved basketball that the teams are playing. We are very grateful to Jules Quirion and Leslie Hughey for their assistance in our sports program. We were very fortunate to secure Jules Quirion as baseball coach. I wish to thank all others who have helped in any way.

## RECOMMENDATIONS

1. There should be more storage cabinets.
2. Wiring over front door should be enclosed.
3. More desks and seats should be purchased to replace a few very old desks and seats now in use.
4. A very different arrangement for cloak rooms downstairs would be an improvement.

## CONCLUSION

I wish to thank all parents, citizens, friends of the school, teachers, Superintendent Glenn M. Robinson, and members of the School Board for their splendid cooperation and support.

# Report of Public Health Nurse

January 1 to December 31, 1948

---

Department of Health and Welfare

Division of Public Health Nursing

This has been a year to remember in regard to health programs in Jackman and Moose River, even if one measured the spirit of cooperation, alone. I wish to take advantage of this opportunity to extend my gratitude to all who have contributed of time, thought, and energy.

In February and March, 118 pupils were immunized against smallpox and over 150 against diphtheria. Clinics were held at the Jackman School and the Sacred Heart Academy. It is hoped to avoid such large clinics in the future by having them more frequently. In March and September, hearing tests were given by means of the audiometer. This test often reveals unsuspected cases of poor hearing. Early treatment may prevent permanent damage.

This is the first year that Child Health Conferences have been held each month in the year, rather than for just the summer months. Mrs. Vinal Hughey, of Moose River, has served as chairman of the Child Health Conference Committee, with many assistants from Jackman and Moose River helping in rotation. In this way, no one person has the whole load to carry, and many are given the privilege of helping. At the writing of this report, the average attendance of the Jackman infant and preschool children has been 13 at each of the seven conferences. Thirty children have been protected against diphtheria; 29 against whooping cough; 26 against tetanus or lockjaw; and nine against smallpox. The American Legion has allowed us to use their building for the conferences, though other plans may be made for the winter months.

Now that the program for the health supervision of the infant and preschool children has been more adequately arranged, it

would be well to work out a plan for physical examinations for school pupils. Experience in other places has shown that complete examination of selected grades is the best investment of town funds.

The X-Ray Clinic was held in June with many persons taking advantage of the opportunity. It is doubtful if these clinics will be held every year, after this, due to the decreasing number for whom this procedure is important.

Pediatric, Crippled Children's and Mental Hygiene Clinic Services are available through the Department of Health and Welfare and their benefits are extended to all cases where it is indicated. Home visits have been made to discuss health problems or their avoidance.

The examination was made in accordance with generally accepted auditing standards applicable in the circumstances and included all procedures which were considered necessary. Insofar as could be ascertained within the scope of the examination, the financial transactions of the Plantation appear to have been appropriately handled, with such exceptions as may be noted in the accompanying Comments.

Exhibits and Schedules incorporated in this report present the result of the financial operations of the Plantation for the period designated.

Recommendations are also offered which are believed to be worthy of your consideration.

## COMMENTS

Re: Audit of Accounts — Jackman Plantation

March 2, 1947 to March 1, 1948

### CASH

The cash receipts were checked in detail and found to be recorded correctly. It was ascertained that all monies for which receipts had been written had been deposited promptly. The cash balance of \$7,164.86 at the year end was reconciled with the depository bank and found to be in agreement.

All expenditures were made by check and were supported by properly authorized warrants.

The records of the Treasurer were checked to the date of this examination and were found to be in order.

### ACCOUNTS RECEIVABLE

Accounts receivable in the amount of \$161.81 were checked and found to be in order.

### TAXES RECEIVABLE

The 1947 tax commitment was added and checked, and with the exception of \$2.82 representing a gain in computation was found to be in agreement with the Assessors' records. The total commitment was settled at the close of the fiscal year.

All transactions affecting prior years' taxes were checked and found to be correctly recorded. Taxes outstanding were checked and listed.

### TAX LIENS

All transactions affecting the tax lien accounts were checked and found in order. Tax liens unpaid were examined and listed.

### PLANTATION OWNED PROPERTY

Plantation owned property totalling \$304.90 was checked and found to be in agreement with the records of the Assessors.

## ACCOUNTS PAYABLE

Accounts payable in the amount of \$2.00 represents excise tax due Somerset County.

## BONDS PAYABLE

Bonds payable in the amount of \$7,000.00 are being matured at the rate of \$1,000.00 annually, the last bond to be paid in 1954.

## TRUST FUNDS

The savings pass books of the Cemetery Perpetual Care Funds were examined and listed. Income withdrawn during the year was paid direct by the Treasurer. This money was expended in accordance with the terms of the Trusts.

## EXCISE TAXES

The excise tax receipts were added and checked. It was ascertained that all collections had been deposited with the Treasurer with the exception of three receipts which were omitted in settlement.

## NET SURPLUS

The Net Surplus is as follows:

The Appropriated Surplus of \$5,092.36 is represented by certain appropriation balances which are carried forward to the ensuing year the detail of which is shown on Exhibit D.

The Deficit of \$5,131.08 at the beginning of the fiscal year was reduced by \$2,273.90 as a result of current operations.

## GENERAL

The Tax Collector and Treasurer furnished corporate surety bonds.

Vouchers and pay rolls on file in the Assessors' office were

examined to an extent deemed necessary and so far as could be determined, they appeared to be proper charges and correctly recorded.

Withholding tax and pension deductions were examined.

There are certain items totaling \$642.26 which had been paid by a former Treasurer that have been referred to an attorney for action. These items represented payments of interest costs on state taxes and temporary loans which should not have been necessary had all cash received by the Treasurer been deposited to the credit of the Plantation.

### RECOMMENDATIONS

It is recommended,

- (1) That the withholding tax and pension deductions be handled through the Assessors' records when the pay rolls are paid with final payment to the State Treasurer and Collector of Internal Revenue being made in the same manner as any other expenditures.
- (2) That all transactions affecting Cemetery Perpetual Care Funds be shown on the town records.
- (3) That the Tax Collector use the regular tax receipts for all tax monies received and that one copy of each receipt be submitted monthly to the Assessors together with a copy of the cash sheet.

# Warrant for Annual Plantation Meeting

---

To Fred Achey, Constable of Jackman Plantation in the County of Somerset, Maine,

## GREETINGS:

In the name of the State of Maine, you are hereby required to notify and warn the Inhabitants of the Plantation of Jackman, in said County, qualified by law to vote in Plantation affairs, to meet at Town Hall in said Plantation on Monday, the twenty-first day of March, A. D. 1949, at ten o'clock in the forenoon, then and there to act on the following articles, to wit:

Art. 1. To choose a Moderator to preside at said meeting.

Art. 2. To elect a Town Clerk for the ensuing year.

Art. 3. To see what sum of money the Plantation will vote to raise and appropriate for the Salary of the Town Clerk.

Recommended \$150.00.

Art. 4. To see if the Plantation will vote to employ a Town Manager and fix his compensation.

Art. 5. To see if the Plantation will vote to authorize the Selectmen to hire a Town Manager, and fix his duties in accordance with the Revised Statutes of Maine, 1944, Chapter 80, Section 18.

Art. 6. To elect five Selectmen, three to be known as Assessors for the ensuing year.

Art. 7. To see what sum of money the Plantation will raise and appropriate for the Salary of the Selectmen and Assessors.

Recommended \$900.00.

Art. 8. To choose five Overseers of the Poor for the ensuing year.

Art. 9. To elect a Plantation Treasurer for the ensuing year.

Art. 10. To see what sum of money the Plantation will raise and appropriate for the Salary of the Treasurer.

Recommended \$200.00 from Excise Taxes.

Art. 11. To elect a Plantation Fire Warden for the ensuing year.

Art. 12. To see what sum of money the Plantation will vote to raise and appropriate for the Salary of the Fire Warden.

Recommended \$500.00.

Art. 13. To elect a Tax Collector of Plantation taxes, fix his or her compensation, and it shall be understood that the person elected Tax Collector will be required to make a full and complete settlement with the Treasurer of the Plantation no later than February 20th, 1950.

Art. 14. To elect an Excise Tax Collector, fix his or her compensation, and it shall be understood that the person elected Excise Tax Collector shall be required to make a full and complete settlement with the Treasurer of the Plantation no later than February 20th, 1950.

Art. 15. To see what sum of money the Plantation will vote to raise and appropriate for the Fee of the Tax Collector.

Recommended \$800.00 from Excise Taxes.

Art. 16. To see if the Plantation will vote to instruct the Tax Collector to pay all who pay their taxes in full before June 1st, 1949, two percent of the tax assessed.

Art. 17. To see if the Plantation will vote to charge interest at the rate of six percent on all taxes remaining unpaid after September 1st, 1949.

Art. 18. To see if the Plantation will vote to direct the Selectmen to take possession, for the Plantation, of all real estate upon which liens have been placed and redemption period has expired, and to execute all deeds or other documents as may be necessary to effect this action, also the right to dispose of said Plantation Acquired Property by public sale, such sale to be advertised for two weeks previous to said sale as required by law.

Art. 19. To elect a Constable for the ensuing year, fix his compensation and pass all votes respecting the same.

Art. 20. To see what sum of money the Plantation will vote to raise and appropriate for the Salary of the Constable.

Art. 21. To elect one member of the School Board for the ensuing three years.

Art. 22. To see what sum of money the Plantation will vote to raise and appropriate to pay the Salary of the School Board.

Art. 23. To see if the Plantation will vote to raise and appropriate the sum of Seventy-Five Dollars for Public Health Nurse for the ensuing year.

Art. 24. To see what sum of money the Plantation will vote to raise and appropriate for the Health Officer's Salary.

Art. 42. To see if the Plantation will vote to raise and appropriate the sum of \$1,240.00 for the payment of Interest Charges and Coupon on Bonds.

Art. 43. To see if the Plantation will vote Yes or No to the building of a Sewer on Spruce Street to connect with the Plantation sewer and septic tank located at the lower end of Forest Street, and pass all votes respecting the same.

Art. 44. To see if the Plantation will vote to give Augustus Gagne a quit-claim deed on his property, and pass all votes respecting the same.

Art. 45. To see what sum of money the Plantation will vote to raise and appropriate for Winter Sanding and pass all votes respecting the same.

Recommended \$150.00.

Art. 46. To see if the Plantation will vote to purchase seats for the Town Hall and pass all votes respecting the same.

Art. 47. To see what sum of money the Plantation will vote to raise and appropriate for Advertising for the ensuing year.

Recommended \$100.00 from Excise Taxes.

Art. 48. To see what sum of money the Plantation will vote to raise and appropriate for the Fire Department for the ensuing year.

Recommended \$450.00.

Art. 49. To see if the Plantation will vote to raise the sum of \$25.00 for Memorial Day.

Recommended \$25.00.

Art. 50. To see what sum of money the Plantation will charge Moose River for the use of the Dump.

Recommended \$75.00.

Art. 51. To see what sum of money the Plantation will charge Moose River for Tomb Rental for the ensuing year.

Recommended \$25.00.

Art. 52. To see if the Plantation will vote to raise and appropriate the sum of \$14,875.00 for the maintenance and support of Schools for the ensuing year.

Recommended \$14,875.00.

Art. 53. To see what sum of money the Plantation will vote to raise and appropriate for the Support of the Poor.

Recommended \$2,700.00.

Art. 54. To see if the Plantation will vote to elect a Budget Committee for the ensuing year and pass all votes respecting the same.

Art. 55. To see if the Plantation will vote to authorize the Selectmen and Treasurer to make Temporary Loans in anticipation of taxes and to issue notes thereof or renewal thereof of any notes in place of the original notes when paid to an amount which at any time shall not exceed in the aggregate to the total tax levy of the preceding year, all such notes to mature and to be paid during such current year by taxes, in accordance with the provisions of the R. S. Maine, 1930, Section 83, Chapter 5, as amended.



Art. 56. To see if the Plantation will vote to authorize the Selectmen to accept or reject bids made for Snow Removal on town streets for the ensuing year and pass all votes respecting the same.

Art. 57. To see what sum of money the Plantation will vote to pay the Moderator.

Art. 58. To see if the Plantation will vote to raise the sum of \$100.00 for the Dental Health Clinic.

The Selectmen hereby give notice that they will be in session at the above named Town Hall and place of meeting for the purpose of correcting the voting list from nine o'clock in the forenoon to the time scheduled for the calling of meeting.
