

### Report of the Public Health Nurse—1942 .... OWLS HEAD

A generalized health program has been carried on during the past year. Eighty-nine home visits have been made including school, preschool, infant, antipartums visits. Tuberculin tests, a simple skin test, were given by the District Health Officer in the seventh and eighth grades, and the children showing a positive reaction were X-rayed at the Rockland X-ray Clinic.

A vaccination clinic was held at the Library and thirty-five children received the preventative measure against smallpox.

The nurse wishes to thank the school committee, teachers and Local Health Officer for their cooperation and help.

## School Department

#### Superintendent of Schools Report

To the Superintending School Committee and to the Citizens of Owls Head:

Please accept this my twenty-first annual report on your schools.

As Mr. Dennett declined a reelection as teacher of the Junior High School, Mrs. Ella Gatcombe was employed and has filled the position satisfactorily. Mrs. Gatcomb is a citizen of this town, and a graduate of the University of Maine.

In the other schools the same efficient teachers as taught last year have taught this year.

Substitutes have been employed, at the Ingraham Hill School when Miss Grover has been called away by illness and death in the family, and at the Junior High School when Mrs. Gatcombe was hospitalized in November. It was possible to secure unusually fine teachers as substitutes. In some cases this has been due to efforts of Mrs. Knowlton who especially in the forced absences of teachers has been very active and efficient.

The progress of the schools has been gratifying. Pupils have been cooperative and well disciplined.

Methods employed are sound and approved by educational authorities.

Because of restrictions on all building which have been caused by scarcity of labor and materials the town is permitted to continue the use of the Town Hall building by the Junior High School.

It has seemed necessary to raise the pay of the teachers and janitors.

If the recommendations for school appropriations seem high, it must be understood that with all salaries higher and the prices of fuel and supplies ever on the rise, more money must be forthcoming.

In the case of repairs, it is almost impossible to attend to any but most necessary work.

Some confusion and much difficulty has been experienced in the case of children being excluded for exposure to contagious diseases and returning without the necessary certificate from the Health Officer.

Sometimes children are kept out of school with contagious children's diseases and the fact that the sickness is contagious is not reported at all to the health officer or even to the teachers.

All such cases should be so reported and before a child may lawfully return, permission of the Health Officer must be given.

At the present time there is legislation pending which would help our schools by increased money from the State. We hope that this bill may pass, but can have no assurance at the present time.

At several different times our schools have been

closed for a time and teachers students and loyal citizens have done rationing work for the Government. This has been done well. It is likely that it may have to be repeated. As long as our country is at war, all must serve to the limit and school teachers and the public must be willing to make sacrifices.

In closing I thank all who have assisted and supported our school work.

To the Inhabitants of the Town of Owl's Head

In accordance with the request of your municipal officers, this department, represented by C.G. Hawes has completed an examination of the accounts of your town officials for the municipal year ended December 31, 1942.

In our opinion, based upon such examination, the accompanying exhibits and schedules fairly present the financial condition of your municipality as of February 1, 1943 and the results of its operaations for the period then ended; subject however to a possible shrinkage in the final settlement of tax liens and deeds.

#### COMMENTS

#### CASH

All receipts as recorded were found to have been properly accounted for and deposited in the bank frequently as per summary on Exhibit B.

Expenditures were made by check from warrants drawn by the Selectmen as summarized on Exhibits B and D.

The cash balance reconciled with the bank statements at the close of the municipal year as per detail on Schedule 1. Cash amounting to \$1,998 has been invested in United States Defense Bonds and these investments are shown on Schedule 1-A.

TAX ACCOUNTS

The 1942 tax commitment was added and found to agree with the Assessors' records. The total commitment was accounted for by cash, tax liens and authorized abatements, or was still unpaid as shown by Schedule 2

According to the records, payments received on

prior years' taxes have been credited against the proper items and those still remaining unpaid are also shown on Schedule 2.

All payments received on tax liens and deeds were found to have been applied against the proper items. Those remaining upaid were checked and are listed on Schedules 3 and 4.

The excise taxes were checked from the triplicate copies of the receipts and the amounts specified had been deposited with the Treasurer as shown on Exhibit B. The receipts and disposition of same are as follows:

#### TRUST FUNDS

The trust fund investments were examined and the detail of same is shown on Schedule 5. All income appeared to have been properly accounted for.

This gain together with other additions as shown on Exhibit E, has increased the Net Surplus account from \$7,090.73 to \$8,918.82.

#### GENERAL

The records of dog licenses issued by your Town Clerk indicate collection in the sum of \$59.30 which amount has been paid to the State Treasurer.

A test check was made of paid bills and payrolls and as far as our examination went, all appeared to be proper charges and correctly recorded.

With the exception of cash, cash invested and trust funds, no external verification was made of your asset and liability accounts.





# Town Warrant

County of KNOX, ss:

To Peter K. Reed, a Constable in the Town of Owl's Head, in the County of Knox.

### GREETING:

In the name of the State of Maine you are hereby required to notify and warn the inhabitants of the said Town of Owl's Head, qualified by law to vote in Town Affairs, to assemble at the

Town Hall, in said Town on the 15th day of March, 1943 at ten o'clock in the forenoon to act upon the following articles, to wit:—

Art. 1. To choose a Moderator to preside over the Meeting.

Art. 2. To choose a Town Clerk for the ensuing year.

Art. 3. To hear and act upon the report of the Selectmen, Assessors, Overseers of the Poor, Road Commissioner, Town Clerk, Treasurer, Tax Collector and Superintending School Committee.

Art. 4. To see if the Town will vote to change the Article 4 in the Town Warrant which has to do with the choosing of the Selectmen to read as follows:

Art. 4. To choose three Selectmen, one to serve for three years, one to serve two years, and one to serve for one year.

Art. 5. To choose three Selectmen for the ensuing year.

Art. 6. To choose three Assessors for the ensuing year.

Art. 7. To choose three Overseers of the Poor for the ensuing year.

Art. 8. To choose a Treasurer for the ensuing year.

Art. 9. To choose a Tax Collector for the ensuing year.

Art. 10. To vote yes or no for a Road Commissioner and to choose a Road Commissioner if the vote is yes.

Art. 11. To choose a member of the Superintending School Committee for the ensuing three years.

Art. 12. To see what scale of wages the Town will vote to pay for the ensuing year.

Art. 13. To see what sum of money the Town will vote to raise for Officers' Salaries.

Art. 14. To see what sum of money the Town will vote to raise for Common Schools.

Art. 15. To see what sum of money the Town will vote to raise for School Repairs.

Art. 16. To see what sum of money the Town will vote to raise for School Text Books.

Art. 17. To see what sum om money the Town will vote to raise for School Supplies.

Art. 18. To see what sum of money the Town will vote to raise for High School Tuition.

Art. 19. To see what sum of money the Town will vote to raise for Current Expense.

Art. 20. To see if the Town will raise and appropriate Fifty Dollars (\$50.00) for public health nursing in Owl's Head, said sum to be expended by the State Bureau of Health, for local service.

Art. 21. To see what sum of money the Town will vote to raise for the care of the Poor.

Art. 22. To see what sum of money the Town will vote to raise for Aid to Dependent Children.

Art. 23. To see what sum of money the Town will vote to raise for snow removal.

Art. 24. To see what sum of money the Town will vote to raise for lights.

Art. 25. To see if the Town will vote to raise the sum of one hundred and eight dollars (\$108.00) for the maintenance of improved sections of Third Class Roads, or to be used in conjunction with the State apportionment for construction.

Art. 26. To see what sum of money the Town will vote to raise for construction of Roads and Bridges.

Art. 27. To see if the Town will vote to appropriate the sum of three hundred dollars (\$300.00) said sum to be expended on the cemeteries in the Town of Owl's Head under the supervision of the Selectmen.

Art. 28. To see if the Town will vote to institute a "Planning Board". The Board to be constituted of four (4) members, the first selectman to be a member of the Board "ex officio", for the purpose of passing and deciding on developments within the Town. Three members of this Board to

be elected at this Town meeting. One member for the term of 3 years, one member for the term of two years and one member for the term of one year.

Art. 29. To see if the Town will vote to authorize the Town officials to purchase additional United States Government bonds with part of our present Cash balance.

Art. 30. To see if the Town will vote to authorize the Assessors to rescind any amounts appropriated by the Town for State Aid Highway construction in excess of the amount required to meet State Apportionments.

Art. 31. To see what sum, if any the Town would recommend to take from the joint state aid account for the purpose of applying bituminous surface treatment to State Aid Roads, in excess of the Requirements of Sec. 2, Chap. 132 P. L. 1935.

Art. 32. To see what sum of money the Town will raise for Civilian Defense.

Art. 33. To see if the Town will vote to adopt the following in regard to the collection of taxes:

Taxes shall become due and payable on August First of the current year; a discount of three percent will be allowed if payment in full is made within thirty days of date of tax bills; interest will be charged on all amounts unpaid after August First. Delinquents shall be dealt with according to
