# Report of the Superintendent of Schools

---

TO THE SCHOOL COMMITTEE OF HEBRON:

In this, my second annual report as superintendent of your schools, I wish to thank you for the continuance of those many favors and kindnesses which have been so freely granted since the beginning of my work in your town.

In my last report I recommended that some system of phonetics be used as a basis in the teaching of reading, particularly in the lowest grades. This is now being done, and with very satisfactory results.

A careful development of this plan will, I am sure, eventually produce in the children the ability to read understandingly and to pronounce new words correctly—two things which the majority of all the children cannot do at the present time. I cannot emphasize this point too strongly—that the ability to read understandingly is the very key to success in any line of work in our public or private schools.

Examination of pupils in the subject of arithmetic has brought out three striking points—inability to solve problems, lack of accuracy and lack of rapidity. The first difficulty may be explained in part, at least, as a result of those existing conditions mentioned in the paragraph above, and is by far the most difficult to correct. Accuracy and rapidity may be secured by constant drill, and, as these two really determine one's degree of efficiency, all teachers are instructed to take advantage of every opportunity to provide practice in these important points.

In making the above statements I do not wish to convey the idea that the defects mentioned are peculiar to Hebron or to any town of this union, as I believe them to be the defects that are common throughout the majority of the schools of the land. The fundamental causes for the existence of these defects are undoubtedly many and varied, so much so that I shall not attempt to mention them at this time. I will, however, respectfully ask you, and all who are interested in the welfare of our schools, to give this matter most careful thought.

In regard to the employment of teachers we are confronted with one of the most serious difficulties of our whole school system. The scarcity of labor in other fields is well known to all, but we, on whom is placed the burden of selecting the teachers, realize that the scarcity of labor in this profession is of serious magnitude. We have thus far been exceedingly fortunate in securing good teachers, but what the next few years will bring forth, time alone can tell.

To create in the mind of the child a full realization of the fact that schools are maintained for the purpose of making the boys and girls of today the good and strong citizens of the future is our constant aim, and to this end I would ask for the hearty support of all persons.

# Warrant For Town Meeting

---

To C. W. Cummings, constable of Hebron, in the County of Oxford and State of Maine, Greeting:

In the name of the State of Maine you are hereby required to notify and warn the inhabitants of said town of Hebron, qualified by law to vote in town affairs, to assemble at the Grange Hall in said town of Hebron on Monday, the fourth day of March, A. D., 1918, at ten o'clock a. m., then and there to act on the following articles to wit:

- Art. 1. To choose moderator to preside at said meeting.
- Art. 2. To see if the town will accept the report as printed.
- Art. 3. To choose a clerk for ensuing year.
- Art. 4. To choose a treasurer for ensuing year.
- Art. 5. To choose a chairman of board selectmen.
- Art. 6. To choose a second selectman.
- Art. 7. To choose a third selectman.
- Art. 8. To choose a board of assessors for ensuing year.
- Art. 9. To choose a board of overseers of poor for the ensuing year.
- Art. 10. To choose truant offices for ensuing year.
- Art. 11. To choose all other necessary town officers for ensuing year.
- Art. 12. To see what sums of money the town will vote to raise for the support of poor, roads and bridges for summer work, on roads for winter work, for cutting bushes, for town officers' bills.
- Art. 13. To see if the town will vote to raise the sum of ten dollars for A. A. Dwinal Post for memorial expenses.
- Art. 14. To see what sum the town will vote for free high schools according to the school laws of 1903.
- Art. 15. To see what sum of money the town will vote to raise for the support of common schools for the ensuing year.
- Art. 16. To see what sum of money the town will vote to raise to pay for collecting taxes for the year 1918.

Art. 17. To see what sum of money the town will vote to raise for the salary of superintendent of school for the ensuing year.

Art. 18. To see if the town will vote "yes" or "no" on the question of appropriating and raising money necessary to entitle the town to state aid as provided in section 20 of chapter 130 of the public laws of 1913.

Art. 19. To see if the town will vote to discontinue the road leading by A. J. Hibbs' residence to the corner near the residence of Mary Jane Bearce, by consent of the county or state as the case may be.

Art. 20. To see if the town of Hebron will authorize its selectmen to arrange for and make a transfer of Hebron's interest in the West Minot schoolhouse, so called, in exchange for Minot's interest in the Brighton Hill schoolhouse, so called.

Art. 21. To see if the town will vote to instruct its treasurer by the written consent of the selectmen to hire money for use of town.

Art. 22. To see what sum of money the town will vote to raise for school committee and office expense account.

Art. 23. To see if the town will approve of the list of jurors as written by the selectmen.

Art. 24. To see if the town will vote to raise the sum of five hundred dollars to be expended on the town highway as provided by the last legislature.

Art. 25. To see if the town will vote to raise the sum of fifteen hundred dollars on town debt.

The selectmen will be in session at the Grange Hall on the 4th day of March, 1918, at nine o'clock a. m., for correcting the list of voters.
