This matter is scheduled for oral argument before the Court on Wednesday, February 23, 1994. In reviewing the brief which I submitted on October 29, 1993, I have discovered several mistakes which should probably be brought to the attention of the reviewing judges.

1. On page 16, the page number for the quote for the case of *Kennecott Corp. v. Industrial Commission* is incorrect. It should read "page 308," not "page 385."
