In preparing for oral argument, set for 22 November 2005, the State has come across additional authority in support of the argument at pp. 16-20, of the State's brief, concerning the reliability of a BCI report or rap sheet:

UTAH CODE ANN. § 53-10-108 (West 2004). **Restrictions on access, use, and contents of division records—Limited use of records for employment purposes—Challenging accuracy of records—Usage fees—Missing children record;**

UTAH CODE ANN. §§ 53-10-201 (West 2004). **Bureau of Criminal Identification—Creation—Bureau Chief appointment, qualifications, and compensation;**

UTAH CODE ANN. §§ 53-10-202 (West 2004). **Criminal identification—Duties of bureau;**

UTAH CODE ANN. §§ 53-10-207 (West 2004). **Peace officers, prosecutors, and magistrates to supply information to state and F.B.I.—Notification of arrest based on warrant;**

UTAH CODE ANN. § 53-10-208.1 (West 2004). **Magistrates and court clerks to supply information.**
