WARRANT FOR TOWN MEETING

To: Larry Fox, constable of the Town of Lovell, in the County of Oxford and State of Maine.

Greetings:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of the Town of Lovell in said county, qualified to vote in town affairs, to meet at the Town Hall in said town on Saturday, March 5, 2005, at 9:00 A.M. then and there to act on the following articles, to wit:

Art. 1. To see if the Town will nominate and elect a moderator to preside at said meeting.

Art. 2. To see if the Town will vote to nominate and elect a Town Clerk/Treasurer for the term of three years.

Art. 3. To see if the Town will nominate and elect one member of the Board of Selectmen, Assessors and Overseers of the poor for a term of three (3) years.

Art. 4. To see if the Town will nominate and elect a Building Inspector for the ensuing year.

Art. 5. To see if the Town will make a recommendation to the Selectmen for an appointment of a C.E.O. The appointment is required by Maine State Law.

Art. 6. To see what the Town wishes to do regarding fixing the compensation of the town officers.

Art. 7. To see if the Town will vote to raise and/or appropriate the sum of \$1,000.00 compensation each for the Town Clerk/Treasurer and the Tax Collector for extra hours worked on the Town Valuation last year.

Budget Committee recommends to do so. (12-0)

Art. 8. To see if the Town will nominate and elect one member to a five-year term on the Planning Board. (2010)

Art. 9. To see if the Town will nominate and elect one 1st associate member to serve a term of one year on the Planning Board.

Art. 10. To see if the Town will nominate and elect one 2nd associate member to serve a term of one year on the Planning Board.

Art. 12. To see if the Town will nominate and elect a second member to serve a term of seven years on the Budget Committee. (2012)

Art. 13. To see if the Town will nominate and elect a member to serve a three year term on the M.S.A.D. #72 Board of Directors.

Art. 14. To see if the Town will nominate and elect one alternate for one year term on the M.S.A.D. #72 Board of Directors.

Art. 15. To see if the Town will nominate and elect all other necessary town officers for the ensuing year. (Board of Health, School Fund Officers, School Fund Trustees, Surveyors, Fence Viewers, Fire Wards, Forest Committee members)

Art. 16. To see if the Town will vote to authorize the municipal officers to spend an amount not to exceed 3/12 of the budgeted amount in each budget category of the Lovell annual budget during the period from January 1, 2006 to the first Saturday in March 2006 Annual Town Meeting.

Art. 17. Upon written complaint by the person disturbed, signed and sworn to, any constable, duly qualified law enforcement official, animal control officer or person acting in that capacity of the Town of Lovell may investigate and may give written notice to the owner or keeper of such dog that such annoyance or disturbance must cease. The warning shall be made part of the complaint. Thereafter, upon continuance of such annoyance or disturbance, such owner shall be guilty of a civil violation and upon conviction thereof shall be punished by a fine of \$50.00 for the first offense. Each additional conviction after the first conviction shall be punished by a fine of \$50.00. All fines so assessed and attorney fees shall be recovered for the use of the Town of Lovell through District Court.

Art 94. Will the Town permit the Board of Selectmen and other town boards to revise street names where used in town ordinances and regulations to conform to changes made by the E911 program without public hearings or further town meeting action provided that the revisions do not alter meaning of the ordinances and regulations?

Art. 95. Shall the Lovell Zoning Ordinance be amended in the following manner to allow cluster developments, to strengthen standards for open space preservation, and to promote better subdivision design:

THE LOVELL HISTORICAL SOCIETY

Last year we had a significant increase in our membership. We were joined by 76 new members and 54 new supporters (donors who are not members). By the end of the year we received over \$45,000 in contributions for this project, and now we need to raise an additional \$175,000 to meet the expected cost.

Perhaps the most exciting development last year was the opening of our museum on the first floor of the Kimball-Stanford House. During the Summer our "Summers in Lovell" exhibit was open three days a week, featuring artifacts and images. At the Holiday Open House we again opened the museum, with some of our permanent collection on display. When the weather warms, the museum will have regularly scheduled hours along with special exhibits, we look forward to your visiting.

While all of this has been going on, we have also made great progress in preserving and cataloguing our extensive collection. Donations to our collection increased significantly over the year, as did the number of volunteers helping us. We had a busy year, but it was also fun.

None of this would have been possible without your continued support. So many people have volunteered in so many ways. They have helped index, research, bake, type, plow repair, clean - you name it! We are a completely volunteer organization and thanks to your support we have achieved so much. Thank you all!

THE GREATER LOVELL LAND TRUST

The Greater Lovell Land Trust, established in 1985, has been dedicated to preserving the natural environment of the Kezar Lake watershed and the water quality of the lake.

At present, either through ownership or conservation easement, the GLLT provides permanent protection of close to 2000 acres. Our properties, including the Sucker Brook and Bradley/Heald Ponds Reserves, as well as the Chip Stockford and Sabra-Creeper Hill Preserves have remained open to the public. We also provide stewardship for the Sabattus Mountain State Park and its trails.

Our nature education program is under the direction of Kevin Harding and is co-sponsored by The Maine Chapter of the Nature Conservancy. An evening lecture series as well as numerous docent led hikes on our properties are designed to explore the biological richness and diversity of the Kezar Lake watershed. Both programs have been very popular and will be continued.

The GLLT seeks conservation easements as its primary tool to carry out its mission. We are also promoting non-commercializing easements as an innovative way to insure the preservation of water quality. We appreciate the increased support for our work that we have had from the Lovell community.

Starting this year, 2005, Tom Henderson will serve as our full time Executive Director. We believe Tom's year round presence and availability will enable us to be more effective in carrying out our mission. Tom has been on our Properties Committee and has been chairman of our Land Maintenance and Stewardship Committee for many years. He is familiar with our properties and our easement donors. He was formerly a senior forester with International Paper Company. Tom has not only served as a vice-president of the GLLT, but was also president of the Upper Saco Valley Land Trust.

The GLLT presents an annual education program oriented to conservation and environmental protection. Attendance is not limited to members and all are welcome at this meeting. It is scheduled for Saturday, August 13th, 2005 at 10 a.m. at the New Suncook School. A breakfast starting at 8:45 a.m. will precede the annual meeting.

We hope to extend our membership in the coming year. As always, we would like to increase membership and support from the second and third generation of year round and summer residents. We also need volunteers to work on our committees. Everyone is welcome as we reach out for participation by the community. Join us. There is a lot to be done.

PLANNING BOARD

The Planning Board continued to work begun in 2003 on possible amendments to the Lovell Zoning Ordinance sections governing subdivisions. This work has now been completed, public hearings have been held, and the Board will present it's proposals for adoption at the 2005 annual meeting. If adopted these amendments will improve protection of open space in the Town and allow clustered development in subdivisions.

The Board also prepared recommendations for the Selectmen on it's space need in any future Town office building. Present quarters are cramped and inadequate for the work of the Board, which is true of most other functions housed in the Town Office.

The Board put together a survey and inventory program for all existing piers and docks on town waterbodies. This program is an outgrowth of the amendments to the Zoning Ordinance governing piers and docks adopted by the Town in 2003. A survey questionnaire was mailed to all shorefront property owners in July, and will continue in the Spring of 2005 with a follow up mailing. Response to the intial questionnaire was high and the Board hopes to be able to complete most of the data collected by mail so as to avoid as much as possible the time and expense of an extensive physical survey.

The Board approved applications from six people for conditional use permits in 2004.

Ten public hearings were held by the Planning Board in 2004 on voting issues. Overall turnout at these hearings was good, and they produced numerous comments which proved helpful to the Board in it's work. The Board appreciates the high level of interest in it's activities shown by the turnout. As always the Board welcomes suggestions as to how it can best serve the Town.

CHARLOTTE HOBBS MEMORIAL LIBRARY

Dear Neighbors:

We hope you are as pleased as we are with the expanded services that the Charlotte Hobbs Memorial Library has offered this past year. In addition to winter and summer activities for children and adults, a 44-hour schedule spread over six days and two evenings each week, and an increase in our borrowing period from two to three weeks, we now provide wireless internet access to the entire community along with an ever-growing collection of books, videos, and information resources.

Under the superb leadership of our director, Anna Römer, the Library is experiencing record use. In 2004, our patrons checked out over 17,300 books and tapes, an increase of 14% over last year and 32% over the past two years, at a time when statewide circulation went up less than 2%. Over 2,000 times last year, someone came into the library to use a computer or hook a laptop to the internet. Our children's summer book club grew 25% from 95 to 119 children, and their reading increased 45% from 726 to 1,319 books. Our 213 programs served 5,271 people, compared to 191 programs serving 3,820 people in 2003. And attendance at our children's programs puts us among the top ten libraries in Maine.

There's more good news. We will be expanding our services even more dramatically this year when we put our card catalogue on line and join the Maine State Library Network. The network will provide citizens of Lovell with access to a vast collection of books and materials which you can order from your home computer for delivery to the Hobbs Library twice each week. And our website will go live next month, so log on to www.hobbslibrary.org to learn more about our current activities.

Support from the Town of Lovell has been critical to our success as a community library. Critical too have been the many hours donated by our able volunteers. Without your generosity of time and talents, our programs would not be half as strong and our budget might be twice as large.

This year, we are requesting \$45,000 from the Town to help support the Library in 2005. This amount represents less than 40% of our budget; as in the past, we hope to raise the remaining funds from contributions and grants. But the costs of books, insurance, utilities, and staff are on the rise, and the increase over last year's request reflects these higher costs as well as our expanded services.

During the next three years, we hope that our capital campaign will allow us literally to raise a library by expanding our now-too-small facility. Unless we also raise the funds to buy books and tapes, heat and light the building, and compensate our splendid staff, we cannot continue making the library the vibrant educational and cultural center of our community. We hope that, as in years past, we can count on your approval of our request.

We thank you for lending your support to the Charlotte Hobbs Memorial Library and for recognizing the Library's importance to the people of Lovell.

2004 LOVELL INVASIVE PLANT PREVENTION COMMITTEE REPORT

While our general area continues to be vulnerable to the introduction of invasive aquatic plants, our biannual lake inspection of the Kezar Lake watershed, conducted during 2004 has found no new invasive plant infestations in Lovell's lakes and ponds. Any new infestations would certainly be a threat to the local tourism and the vacation industry in our town. There is an active and on going program to control the spread of milfoil at Cushman Pond which to date has been funded by grants. These efforts are being carried out mostly by the residents of Cushman Pond and their work has been recognized by an award for "Outstanding Volunteer Commitment".

Just beyond our immediate area, new invasive plant infestations have been found in the Songo River from Sebago Lake towards Brandy Pond. For the past several years there has been an average of two new infestations found each year in the state of Maine. In addition, the Maine Volunteer Lake Monitoring Program (VLMP) reports that trained volunteer boat inspectors discovered invasive plants on three boats bound for Sebago Lake and Great Pond in Belgrade. Therefore, the threat to Lovell's most valuable economic resource remains significant and critical.

The Lovell Invasive Plant Prevention Committee (LIPPC) has focused on two programs in 2004:

1. Reversing the downward trend of volunteer boat inspections: Modeled after the organized assistance we've received over the past several years from the staff at Quisisanna, volunteers were solicited from Severance Lodge, Ladies Delight, Conifer, Palmer Lane and other Kezar Lake associations. Inspections rose from approximately 800 in 2003 to 1,300 in 2004, which is a 62% increase.
2. In August of this past year, the "Watershed Stewards Program" for lakes and ponds in our watershed was launched with the distribution of a comprehensive "Stewards Handbook". The primary purpose of this program is to establish a communication network to insure that each water body or major portion thereof, has a contact person who will help to keep others well informed about the threat of undesirable invasive aquatic plants.

The Committee continues to monitor the boat and gear washing stations in Bridgton and we understand that LL Bean has awarded a grant to the Cobbossee Watershed organization to develop a design for a washing station that could be adapted to the needs of many other communities. We plan to follow this program closely as it progresses.

The Committee continues to meet throughout the year (monthly) with very active participation from the members. Hundreds of hours of work are given at no expense to the town. Vice Chair, Gerry Nelson, is in constant contact with public and private organizations (DEP, IF&W, COLA, LEA, VLMP, KLWA, LWRMA and the GLLT) for information and support regarding the invasive plant problem.

After considering LIPPC's expenditures for 2004, and projecting our expenses for 2005, the Committee requests the following funding:

1. \$15,000 to be raised for operating expenses, with the balance from the 2004 operations budget being carried forward.
2. \$20,000 to be available from Surplus to be expended only on an "as needed" basis.

It should be noted that in 2001, the year this Committee began its work in earnest, \$30,000 was raised at town meeting for operating expenses with \$20,000 in reserve from surplus. In subsequent years we carried the balance in the operating account forward, adding more funding as needed and at all times the program was run without going over budget. The amount from surplus which has always been approved at the \$20,000 level has never been used to date.

The spending fluctuations from year to year are primarily due to the cost of the watershed survey (that is an on site examination of the water bodies in the Kezar Lake watershed to search for infestations of undesirable aquatic plants) and a significant increase in paid inspections during 2004. The survey has been conducted every other year beginning in 2002 and the Committee believes that it is a very important part of the overall program, as finding a new infestation in the early stages of development would be crucial in stopping its spread within the infested water body. The Committee continues to work toward the goal of minimizing the number of paid inspections through the solicitation of more volunteers from around Kezar Lake. However, there were approximately nine fishing tournaments on Kezar this past year and it is quite difficult to find volunteer inspectors who are willing to begin work at 5am when the fishing tournaments typically start and thus the need for paid inspectors from time to time.

The Committee is looking into the possibility of installing an inspector's shed at the Narrows boat landing during 2005, to help protect inspectors from the bugs and elements. In addition, a small structure would lend an air of importance and permanence to the inspection process, which as we all know is very important indeed. While we have included approximately \$2,300 in our budget request for the shed, we will seek out funding from the KLWA and it may be possible to build the structure with volunteer help. Other projected costs include the executive director's pay, weed identification training for volunteer inspectors, the publication of manuals for the lake stewards program, and enhanced presentation materials for our educational program.

Lastly, in 2005 the Committee expects to move forward with ongoing plans to replace the old dam at Cushman Pond. An engineered plan for a replacement dam has been drafted and the Committee will work to obtain cost estimates and bring that issue before a town meeting when all of the information on the project has been assembled. The importance of containing and controlling the milfoil infestation in Cushman Pond to prevent the spread into other water bodies cannot be overstated.

In 2004, KLWA members, local residents and staff from Quisisana continued its active campaign to prevent the introduction of invasive species into the lake, eight of the ponds and to control the milfoil weed in Cushman Pond. Thanks to the generous \$50,000 approved by Lovell voters for milfoil protection and funds received from KLWA for the widespread signage project in 2002, no additional funding was needed in 2003 and 2004, but now funds have run low so additional funding will be requested at the 2005 town meeting..

Katrina Soucy continued to coordinate boat checks at the public landings, to promote invasive species education through library and school programs, and, worked with the Volunteer Lake Monitoring Program (VLMP) of Auburn, to schedule weed identification workshops for adults. She reports that no plants were found on boats or trailers all summer which means that boaters are now well aware of the need for boat checks and fully support the effort. Tournament fishermen followed their own strict boat check procedures and fully cooperated.

Thanks to a new program, "Adopt the Lake Day" initiated by Larry Hall of Quisisana, homeowner associations around the lake were asked to "adopt" a particular day or weekend for their members to check boats. As a result, boat checks increased from 804 in 2003 to 1,300 in 2004. In addition to this increase in boat checks, Scott Williams and his staff from VLMP, surveyed the entire lake, all the ponds and found no sign of invasives.

This, of course, is good news, but the fight must go on as long as invasives pose a threat in the watershed. We applaud Gerry & Meg Nelson, Doug & Joanne Faille and Cushman Pond residents for their efforts to control further spread of milfoil in that 32-acre pond. Much labor-intensive work over ten years has kept the spread to a minimum.

Last spring, KLWA contracted with Dr. Katherine Webster of the Dept. of Biological Sciences at U. Maine, Orono, to conduct a zooplankton analysis of Kezar over a five year period. This study will examine factors which have probable or possible impact on the Kezar Lake fishery. Zooplankton samples were collected by Scott Williams and sent to Dr. Webster this fall for analysis. Her first report will be available in the spring

More time was again spent over the summer in opposing the commercial development on Pleasant Point. We are members of the Middle Bay Defense Coalition (KLWA, Greater Lovell Land Trust (GLLT), Quisisana Corp., Farrington Homeowner's Condo Assoc. and several Middle Bay property owners) to address our concerns about the project's negative environmental impact on the area through legal research and testimony at hearings before the Lovell Appeals Board. We are grateful to the Appeals Board for denying the developer's various applications and will continue to oppose his court filings.

At our August meeting, we enjoyed a presentation by Mark Prout of the US Forest Service about restoration of the Great Brook stream and fisheries.

Last summer when Paul Sirois, our lake patrol officer, had to cope time and time again with numerous mechanical problems with the patrol boat, the Trustees decided that after 12 years of extremely hard wear and tear, the boat needed to be replaced. This winter we have been researching used and new boats and will be purchasing a new boat designed specifically for lake patrol



and law enforcement. Funding for this purchase has been sparked by contributions to KLWA in memory of Mike Miller, our former vice president, who died last January. Additional funding has been received from the recent KLWA/GLLT fund raising campaign. These two sources will cover the major cost of the boat. We thank all who have contributed to the effort to continue our lake patrol project with a new, more powerful and efficient boat .

The 2004 loon count recorded 25 adults and 3 chicks which is above average for adults and normal for chicks.

The Committee's goal for 2005 is to post a functional site that will be a central and convenient source of information about the town of Lovell, the activities of town government and local organizations. Two of the committee members are in the process of taking a 45 hour web development course at their own expense, in order to become more knowledgeable about web site design and maintenance.

No funds have been expended from the \$5,000 that was approved for the project at the 2004 Annual Town Meeting and the Web Site Committee requests that those funds be carried over to 2005 with no additional funding requested for the year. We believe that this web site will be an invaluable resource for both resident and non-resident taxpayers.

### **FRYEBURG RESCUE TOWN REPORT 2004**

To the citizens of Fryeburg, Brownfield, Lovell, Stow, and Chatham  
Once again another year has come to a close on the books of Fryeburg Rescue.

We continue to train and keep ourselves current with our certifications as well as upgrading our equipment.

Last year (2003) Fryeburg Rescue responded to 643 calls, this year rescue has seen a sharp increase, 13% in call volume, to 732 calls made.

Fryeburg Rescue treated 136 Motor Vehicle Accident victims, 70 shortness of breath patients, and 59 chest pain patients. Of all the patients that Fryeburg Rescue has treated, Fryeburg and North Fryeburg had a total of 527 patients, Brownfield had 112, Lovell had 54, Stow had 16, Chatham had 15 calls, and we had 8 other calls to outlying towns for mutual aid. We have made several calls on the Saco River this past year and we have had the help and support of the Police Department with the use of the Airboat in responding to these calls.

Lifelight has been very helpful to us as well in responding to calls so that our patients can be transported as quickly as possible to a trauma center.

Fryeburg Fair was also very challenging for us as we responded to 59 calls, which was a significant increase from past years.

We have a wonderful dedicated squad of EMS personnel and without their support as well as the moral and financial support of our local community we would be unable to continue providing emergency services. We still remain as one of the few services left in the state as a volunteer, non-billing service.

We are always looking for people who would like to join our squad. We have applications in the rescue building so if you are interested please stop by and fill one out.



**IMPORTANT****ALL TAXPAYERS SHOULD READ THE FOLLOWING  
REQUIREMENTS AND COMPLY WITH THEM**

Chapter 81, Section 35 of the Revised Statutes of Maine require the Assessors to give notice to bring up lists of taxable property. If no lists are brought in, no claim for abatement.

“Before making an assessment, the assessors shall give reasonable notice in writing to the inhabitants by posting notifications in some public places in town, or shall notify them in such other way as the town directs, to make and bring in to them true and perfect lists of their polls, and all their estates, real and personal, not by law exempt from taxation, of which they are possessed on the first day of April of the same year. If any resident owner after such notice, or any nonresident owner after being reasonable requested thereto by the assessors, does not bring in such a list, he is thereby barred of his right to make application to the assessors, or county commissioners, for any abatement of his taxes, unless he offers such list with his application and satisfies them that he was unable to offer it at the time appointed. The request upon nonresident owners may be proved by a notice sent by mail to the last known address of the taxpayer or given by any other method that brings notice home to the taxpayer.”

**RABIES CLINIC FOR DOGS & CATS**

March 12th at the Fire Station located at the bottom of Hatch Hill and Route 5, from 11:00 am to 1:00 pm. The cost is \$6.00 per animal. Other shots are available. All dogs and cats are required to be vaccinated against Rabies. Licensing will be available at Clinic. Please NO SICK OR PREGNANT DOGS OR CATS and no puppies or kittens for their 1st shots.

**Attention Dog Owners**

All dogs who are 6 months of age, or older, must be licensed by January 1st. Bring with you a current Rabies Certificate, a Certificate of Spaying or Neutering and an accurate description of the dog. It is your responsibility to license your dogs, not the Animal Control Officer. His duty is to dispose of any who are not licensed.

Please see that your dog is under your control - on your own property at all times.
