WARRANT FOR TOWN MEETING

To: Larry Fox, constable of the Town of Lovell, in the County of Oxford and State of Maine.

Greetings:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of the Town of Lovell in said county, qualified to vote in town affairs, to meet at the Town Hall in said town on Saturday, March 4, 2006, at 9:00 A.M. then and there to act on the following articles, to wit:

Art. 1. To see if the Town will nominate and elect a moderator to preside at said meeting.

Art. 2. To see if the Town will vote to nominate and elect a Tax/Excise Collector for the term of three (3) years.

Art. 3. To see if the Town will nominate and elect one member of the Board of Selectmen, Assessors and Overseers of the poor for a term of three (3) years.

Art. 4. To see if the Town will nominate and elect a Road / Public Works Commissioner for the term of three (3) years.

Art. 5. To see if the Town will nominate and elect a Building Inspector for the ensuing year.

Art. 6. To see if the Town will make a recommendation to the Selectmen for an appointment of a C.E.O. The appointment is required by Maine State Law.

Art. 7. To see what the Town wishes to do regarding fixing the compensation of the town officers.

Art. 16. To see if the Town will nominate and elect all other necessary town officers for the ensuing year. (Board of Health, School Fund Officers, School Fund Trustees, Surveyors, Fence Viewers, Fire Wards, 1 one yr term and 2 three yr term on Forest Committee)

Art. 17. To see if the Town will vote to authorize the municipal officers to spend an amount not to exceed 3/12 of the budgeted amount in each budget category of the Lovell annual budget during the period from January 1, 2007 to the first Saturday in March 2007 Annual Town Meeting.

SELECTMEN REPORT

We want to first welcome the new year and hope that it is a blessed and happy new year for each of you.

We have a couple of issues that we feel are critical to us all as they may affect the current future of Lovell.

The first has to do with our roads in town. We have nearly 50 miles of road that must be maintained and upgraded for our future. Larry Fox, our Public Works Director has suggested that we carefully consider major upgrades to some of our older paved roads. Many years ago dirt roads were upgraded by using materials that were readily available such as tree logs and gravel. These roads need to be totally removed and built again with the proper materials. Our feeling is that this issue does need to be addressed but only as we can afford the cost. Larry has an article to raise additional monies just for reconstruction.

The other issue is perhaps less apparent on a daily basis but equally important.

We have had ongoing conversation with GLLT about the removal of certain properties in Lovell from the tax roles by way of conservation easements, trusts etc. Although we do share the overall mission of the GLLT we also need to be ever aware of the delicate balance between “conservation property” and “taxable property” in Lovell. A prime example of this occurred in 2005. Although not tied to the GLLT mission, the Hewn Oaks property was gifted to a state university resulting in an immediate loss of \$15,000 per year in tax revenue. We have much work yet to do to both protect the rural setting that we enjoy here in Lovell and also protect our tax base so that we all can continue to afford to live here.

We all recognize how special our community is and we all need to share in guiding Lovell into the future.

THE GREATER LOVELL LAND TRUST 2005

The mission of the Greater Lovell Land Trust is to preserve the quality of our lands and waters for future generations. Since 1985, over 2,100 acres have been conserved. The GLLT is grateful for the many partners, volunteers, contributing members, donors, landowners and community leaders that have made this possible.

In 2005 we embarked on a proACTIVE land protection program that incorporates the Maine State Beginning With Habitats program. The program identifies maps and rates area habitats for their value to native wildlife and plant species. It is intended to guide town planners, land use managers and local conservation organizations in developing conservation plans for their most valued habitats.

Our Educational Program remains one of our most popular community projects. Attendance at our summer lecture series and guided walks has given us reason to expand the programs offered. The GLLT is pleased to sponsor the summer youth environmental education program led by the Charlotte Hobbs Library. We have increased our involvement with the environmental programs of both Camp Susan Curtis and the Tin Mountain Conservation Center for local youth and families. The GLLT joined with the Kezar Lake Watershed Association to offer a terrific program on loons and eagles for over 200 people at our Annual Educational meeting, in August. Our winter program included wildlife tracking, snowshoeing and cross country skiing at the GLLT properties at Heald and Bradley Pond, Sucker Brook, Ladies Delight and Kezar Outlet Fen and a presentation of the USFS Great Brook Restoration Project. In 2005 the GLLT inaugurated the publication "Land Trust Notes" focusing on interesting topics about wildlife, habitats and traditional human interactions. We invite guest columns and suggestions for topics from interested citizens for future volumes.

Previous generations have passed to us healthy and vibrant natural communities, by embracing a land stewardship ethic that remains alive and well with our citizens. We appreciate the opportunity this ethic presents for conservation, a chance so many communities have lost forever. Currently, the GLLT holds easements on 784 acres of public and privately owned lands, 669 acres of which are working forest and farmlands. The GLLT owns 1,343 acres of forest and wetlands which are open to the public for traditional uses including hunting and fishing. These properties also support forestry and wildlife management, and endangered species and water quality protection. The GLLT remains a committed partner for healthy human and natural communities through conservation.

PLANNING BOARD 2005

During the year the Board prepared further amendments to the Zoning Ordinance clarifying the responsibilities of the Board, defining the rules regarding home occupations, piers and docks, and building permit fees. These proposals will be presented for voter action at the March 2006 Town Meeting.

The Board received two applications for subdivisions last year, the first such applications we have had since 1996. One is for a development on the shores of Farrington's Pond, and the other is for development of the Dallinger property at the corner of route 5 and Sabattus Road. Our review of both projects is proceeding well and should be completed early in 2006.

Four parties applied for conditional use permits in 2005, and the Board after public hearings approved two of these. Two were withdrawn prior to Board action.

The Board also worked on several requests from owners of buildings in the Shoreland Zone. These buildings did not meet setback requirements, and the owners wished to move them to new foundations. Agreeable solutions were reached, with each of these owners to bring the structures into better conformity where lot limitations precluded full conformity with town standards.

As always, we welcome suggestions from the community as we continue our efforts to conserve the scenic and environmental assets of our town.

2005 WEB SITE COMMITTEE REPORT

The Web Site Committee met on several occasions in 2005 and two of the members took a course in web design at Central Maine Community College in Auburn this past spring, to better understand the nature of web design and to produce a draft version of the town web site to present to a professional design firm as an example of the committee's vision for the functionality of the site.

The Committee recommended and the Selectmen agreed to enter into a contract with Axon Design & Marketing of Portland, Maine (the same company that has produced the Greater Lovell Land Trust and Charlotte Hobbs Memorial Library web sites) and this action was taken subsequent to the final Budget Committee meeting at which time the \$5,000 approved for the job had not been expended. That amount has now been committed and so the warrant to carry over the \$5,000 to the 2006 town budget should be rescinded in favor of a request to raise \$1,000 for any additional work that may be required for the site in 2006.

We expect that the site will be activated for public access and use sometime in the spring of 2006 and we anticipate that the URL will be www.lovellmaine.info.

When completed, the site will have information about the various elected and appointed town officers, departments, and committees, will contain downloadable documents such as permit applications, ordinances, records of committee meetings, town reports, proposed ordinance changes, a comprehensive events calendar, links to other useful sites, etc. The emphasis will be on content and user friendliness and content will be largely dependent upon cooperation from town officials, town committees and local organizations who will be asked to update their information on a regular basis.

KEZAR LAKE WATERSHED ASSOCIATION ANNUAL REPORT - 2005

In 2005, KLWA members, local residents and staff from Quisisana, working throughout the watershed with Lovell's Invasive Plant Prevention Committee, continued its active campaign to prevent the introduction of invasive species into the lake, eight of the ponds and to control the milfoil weed in Cushman Pond. Thanks received from Lovell voters and the KLWA members in 2002, no additional funding was needed in 2003 and 2004. Additional town funding was received in 2005 and will be requested again in 2006.

Katrina Soucy continued to coordinate boat checks at the public landings, to promote invasive species education through library and school programs. She

has been working with the Volunteer Lake Monitoring Program (VLMP) in Auburn to schedule weed identification workshops for adults in Lovell. She reports that no plants were found on boats or trailers all summer which means that boaters are now well aware of the need for boat checks and fully support the effort. There were about 1,035 inspections. 45 KLWA members and local residents participated in the checks plus 14 Quisisana staff. Scott Williams and his professional staff from VLMP have surveyed the lake and ponds and found no invasives. As a result of this comprehensive effort, Lovell's boat check program has been cited as one of the best in the state.

We applaud Gerry & Meg Nelson, Doug and Joanne Faille and Cushman Pond residents for their successful efforts to control further spread of Milfoil in that 32 acre pond. Much labor intensive work over 12 years has kept the spread to a minimum. Their work on Cushman is being used as a model for other small ponds in the state.

We continue to oppose the commercial development applications on Pleasant Point, which are now being heard in Superior Court, by closely monitoring the proceedings and attending court hearings when required.

The highlight of 2005 was the acquisition of our brand new 16' Boston Whaler lake patrol boat with a 115hp, 4-stroke Mercury motor. This boat replaces our 12 year old boat which died of old age. This boat is fully equipped for law enforcement and safety needs with all the necessary ropes, cleats and lights and loud speaker, etc. It is a pure delight to Paul Sirois, our super capable lake patrol officer and has been welcomed by KLWA members and all boaters on the lake, even those he's had to flag down for violations. While using the new boat, in August Paul was able to rescue and tow a boat with a family and young children aboard as it was about to crack up on the rocks near Elephant Rock. He said he couldn't have done that in that old boat.

Funding for this purchase was from the KLWA/GLLT fund raising campaign last year and contributions to KLWA in memory of Mike Miller, our former vice president. We thank all who have contributed to the effort to continue our lake patrol program. We are the only lake association in Maine fortunate enough to have the support to maintain such an important lake patrol and safety project.

The 2005 loon count recorded 13 adults and 3 chicks which is way down from the usual number of adults due to a London-type pea soup fog the day the official count, when visibility was less than zero. One of the counters even had to use a compass to get back to her dock. Many more adults were sighted later in the month, but can't be added to the official record.

2005 CHARLOTTE HOBBS MEMORIAL LIBRARY

Dear Neighbors:

As the Charlotte Hobbs Memorial Library marks its 98th year in our building, we have even more good news than usual to report! We continue, of course, to serve you for 44 hours each week. We continue to offer wireless Internet access along with a growing collection of books and audio-visual materials. We continue to create stimulating programs for people of all ages and diverse interests.

The success of these services is visible in our increasing number of patrons. While many libraries report declining attendance, we broke records once again in 2005. Our circulation reached 18,829 items, an increase of 55% since 2001. Non print circulation nearly doubled in that period, and computer use jumped from 1,483 in 2002 to 2,493 in 2005. In this electronic age, the Library is becoming even more important to our community.

But these statistics are only part of the story, for the Charlotte Hobbs Library now extends beyond its own walls. Last March, we introduced our website, www.hobbslibrary.org, where you've been able to learn about our activities, our history, and our capital campaign, and to renew books, contact the staff, and offer suggestions.

And that was just the beginning! As of Valentine's Day 2006, you can browse both our local catalogue and the entire Maine State Library Network from home, work, or school. From over a million titles held by seventy libraries, you can order books that will be delivered to the Hobbs Library each week. (If you have not yet picked up your new library card, please stop by!)

To be sure, the Library has changed over these 98 years in ways that even the visionary Charlotte Hobbs could not have imagined. But some things will never change. We will always offer a warm welcome to everyone who comes through our doors. Our staff will always do its best to serve your needs. Our programs will always respond to our community's interests. And we will always offer you a rich selection of new books and audio-visual materials.

Always, that is, if our community continues its support. As a non-profit organization, we depend crucially on the Town of Lovell to keep our doors open. This year, we are requesting \$45,000 from the Town to help support the Library in 2006, the same amount that was asked and appropriated by the Town for 2005. This sum represents just over 40% of our budget. As in the past, we hope to raise the remaining funds from grants, donations, and the efforts of our dedicated volunteers and local businesses who make possible our monthly raffles, our concerts and sales, our benefit luncheons and dinners, and of course our widely attended Arts and Artisans Fair.

We in Lovell are extremely fortunate to have Anna Römer as the innovative director of our library along with an excellent staff. We are fortunate too to have a topnotch Board and many talented volunteers who spend untold hours

all year to keep the Library afloat. We hope that, as in years past, you will support our request to the Town so that we can continue to serve the people of Lovell this year and into our second century.

2005 LOVELL INVASIVE PLANT PREVENTION COMMITTEE REPORT

There were two main Committee goals for this year's invasive aquatic plant program: The first was to continue to inspect boats and gear at Kezar Lake public landings during the busy hours. The second goal was to step up our Stewards program in which we now have a local representative at each water body in the Watershed. The boat monitoring went well. We checked just over 1,000 boats during 2005 and while the total number of inspections was down from 2004, most committee members attribute the decline to the wet weather in the spring and early summer months. We had 9 small fishing tournaments, the largest having 40 boats. We had very good cooperation on the part of the boaters with few complaints and lots of support.

We continued our Adopt-a-Saturday program in which local groups manned the Narrows boat ramp on Saturdays. Quisisana adopted every Friday and Sunday and residents of many Kezar Lake homeowners associations conducted boat inspections on Saturdays. Maynard Craig inspected boats during the early morning hours when volunteers are not readily available. We had over fifty dedicated volunteers giving a few hours each for the cause and two paid inspectors. The committee members and boat inspectors are hardworking and committed!!! If we have more volunteers come forward, we will be able to expand our hours next year.

Our Steward program has continued in two directions: Education on identifying the invasive aquatic plants – and - circulating information on what to do if you find a suspect plant. The Stewards have started to go door-to-door, distributing pamphlets of information. Next year, the Stewards will be offered a plant identification workshop so that they will be able to recognize these undesirable invasive plants. Our last plant survey administered on each water body by plant biologists found no invasive plants except of course, Cushman Pond but we must remain vigilant!!

During the past year the Committee was instrumental in recruiting Water Quality Monitors for each of the seven viable water bodies in the Watershed, (Bradley Pond, Cushman Pond, Farrington Pond, Heald Pond, Horseshoe Pond, Kezar Lake & Trout Pond) and we arranged training and certification by the Volunteer Lake Monitoring Program (VLMP) at the Environmental Center in Auburn. Data from this program goes into State and National databases and provides an early warning system by documenting significant changes in water quality in water bodies that are in need of increased surveillance.

The Committee continues to monitor the progress of the project being carried out by the Cobbossee Watershed Group to design and build a boat wash station. This project, funded by L.L. Bean is planned for startup during the 2006 season and will serve as a demonstration installation for developing operating procedures and instructing boaters. It will also serve as a model for any lake groups who are interested in building wash stations in their areas.

The Committee welcomes any new volunteers interested in participating in the very important boat inspection program and also to take advantage of the outstanding training programs being planned for invasive plant identification. Please feel free to contact the LIPP Committee or the Selectmen if you would like to join.

Grant Funds acquired in the name of the Town of Lovell and the Kezar Lake Watershed Association (KLWA), along with a \$2,000 grant from Maine Department of Environmental Protection (DEP) and the Lakes Environmental Ass'n (LEA) continue to support the intensive, on-going program to control invasive milfoil in Cushman Pond. This program continues to be a success story as only a few new plants are found and removed on each of the five dive-days conducted each season.

The Committee expended a bit over \$11,000 for its general operations last year and this year the town will be asked to carry over the balance of slightly more than \$9,000 and raise an additional \$13,000 for a total of \$22,000 to be available for 2006 operations. The reason for the anticipated increase in expenditures for 2006 is the cost of the bi-annual biological lake survey, in which a team of lake biologists survey the lakes and ponds within the Kezar Lake Watershed, searching for new infestations of undesirable aquatic plants. The theory behind this investigation is that the sooner an infestation is found, the better the chances of control or eradication – before the invasive plants have a chance to gain a strong foothold or are further spread by boats. There are ongoing discussions within the Committee about the possibility of training volunteers to either assist or replace the lake biologists in order to keep expenditures to a minimum, however no local group of qualified inspectors exists at this time.

In addition to this year's request for \$13,000, the Committee is asking that the voters approve the expenditure of \$20,000 to be taken from surplus, on an "as needed" basis and with the approval of the board of Selectmen, in the event of an infestation emergency that may require a rapid response. The town has approved this expenditure in each year of the Committee's existence, however it has never been necessary to spend these back up funds to date.

In closing, we would like to thank all of our local volunteers. Protecting our water bodies is an ongoing, time consuming task and we have been fortunate to have strong local backing year after year. We have a highly dedicated Committee and a caring group of volunteers who know that keeping our lakes and ponds the way Mother Nature intended is a tremendous amount of work but very rewarding.

Once again another year has come to a close on the books of Fryeburg Rescue. We continue to train and keep ourselves current with our certifications as well as upgrading our equipment.

Fryeburg Rescue responded to 669 calls this year.

We have made several calls on the Saco River this past year and we have had the help and support of the Police Department with the use of the Airboat in responding to these calls.

Life Flight continues to assist us with our calls and they are an extremely valuable service to have supporting us.

Both United Ambulance and North Conway Ambulance have provided us with Paramedic coverage when we require it.

Fryeburg Fair continues to be very challenging for us as we responded to a significant number of calls during that week.

We have a wonderful dedicated squad of EMS personnel and without their support as well as the moral and financial support of our local community we would be unable to continue providing emergency services. We still remain as one of the few services left in the state as a volunteer, non-billing service.

This year we are embarking on a huge financial project. We are in need of replacing our oldest ambulance 503 and we are also going to replace our crash/extrication truck 504. The total cost for these will be about \$240,000.00.

We have started to apply to the USDA for a Rural Development Grant and we will be sending out a fund raising letter to help us with this effort. We have been very honored by the past support we have received from the community and are in hopes that we receive your support again.

We are always looking for people who would like to join our squad. We have applications in the rescue building so if you are interested please stop by and fill one out.



Dear Friends & Neighbors:

The 122<sup>nd</sup> Maine State Legislature finds itself enveloped with over 450 proposals to change or add to Maine's existing policies. Close scrutiny of these submissions is needed to make certain our State's citizenry is not exposed to further unnecessary regulations, methods of taxation, or the ever increasing cost of health insurance. It has been my focus from day one to hold State government accountable, while seeking to provide constituents with an environment in which they can live comfortably, prosper, and raise a family. Seeing that our young people have a quality education is not enough. As policymakers, priorities need to be set with an emphasis on encouraging economic development that will in turn stimulate the creation of jobs with higher earnings and good benefits.

In the opening days of the Second Regular Session we have witnessed some lawmakers unenroll from the ranks of the Democratic caucus citing dissatisfaction with how their own party leaders have lost touch with average Maine voters as the reason for their changing party affiliations. This in turn has altered not only the composition of the House of Representatives, but also the makeup of several Joint Standing Committees. Membership in the 151 member House is now comprised of 74 Democrats, 73 Republicans, one green, and three unenrolled.

As a result of these adjustments, I have been assigned to a second joint standing committee. In addition to my serving on the Criminal Justice & Public Safety Committee, I am now given the opportunity to broaden my influence in the legislative process as a member of the Inland Fisheries & Wildlife Committee. This panel has jurisdiction over the Department of Inland Fisheries and Wildlife; hunting; fishing; trapping; recreational and hunter safety; fisheries and wildlife research; fish hatcheries; wardens; licensing; ATVs; snowmobiles; boat registration; and whitewater rafting. There is much to be learned; however, I have faith in my new colleagues offering me their own expertise to aid in the process of becoming more familiar with the group's agenda.

My work to heighten convictions and enhance the prosecution of child pornography offenders is ongoing. A January 25 Joint Order instructing the Joint Standing Committee on Criminal Justice & Public Safety to report out, to the Senate, a bill to establish a computer crimes unit within the Maine State Police Crime Laboratory in order to combat child pornography and child abuse will most certainly coincide with the legislation I submitted during the First Regular Session. I look forward to the Committee's deliberations on this bill, as emphasis should be placed on penalizing these criminals to the highest extent possible.

In the weeks to come, I would encourage you to contact me and share your thoughts on those issues under consideration by the Legislature you feel are of the greatest significance. Only through open communication with my constituency can I effectively voice your concerns.

**IMPORTANT****ALL TAXPAYERS SHOULD READ THE FOLLOWING  
REQUIREMENTS AND COMPLY WITH THEM**

Chapter 81, Section 35 of the Revised Statutes of Maine require the Assessors to give notice to bring up lists of taxable property. If no lists are brought in, no claim for abatement.

“Before making an assessment, the assessors shall give reasonable notice in writing to the inhabitants by posting notifications in some public places in town, or shall notify them in such other way as the town directs, to make and bring in to them true and perfect lists of their polls, and all their estates, real and personal, not by law exempt from taxation, of which they are possessed on the first day of April of the same year. If any resident owner after such notice, or any nonresident owner after being reasonable requested thereto by the assessors, does not bring in such a list, he is thereby barred of his right to make application to the assessors, or county commissioners, for any abatement of his taxes, unless he offers such list with his application and satisfies them that he was unable to offer it at the time appointed. The request upon nonresident owners may be proved by a notice sent by mail to the last known address of the taxpayer or given by any other method that brings notice home to the taxpayer.”

It is your responsibility to license your dogs, not the Animal Control Officer. His duty is to dispose of any who are not licensed.
