Message of the President:

It is important that this branch of the public service should be subjected to the supervision of such professional skill as will give it efficiency. The expense attendant upon such a modification of the Executive Departments would be justified by the soundest principles of economy. I would recommend, therefore, that the duties now assigned to the agent of the Treasury, so far as they relate to the superintendence and management of legal proceedings on the part of the United States, be transferred to the Attorney-General; and that this officer be placed on the same footing, in all respects, as the heads of the other departments—receiving like compensation and having such subordinate officers provided for his department as may be requisite for the discharge of these additional duties. (1829-30.)

The attention of Congress was called on a former occasion to the necessity of such a modification of the office of the Attorney-General of the United States as would render it more adequate to the wants of the public service. This resulted in the establishment of the office of Solicitor of the Treasury; and the earliest measures were taken to give effect to the provision of the law which authorized the appointment of that officer and define his duties. But it is not believed that this provision, however useful in itself, is calculated to supersede the necessity of extending the duties and powers of the Attorney-General's Office. On the contrary, I am convinced that the public interest would be greatly promoted by giving to that officer the general superintendence of the various law agents of the government, and of all law proceedings, whether civil or criminal, in which the United States may be interested, allowing to him at the same time such a compensation as would enable him to devote his undivided attention to the public business.
