#### Governance

#### **Fiscal Affairs**

Chair Sprague reported that he had received a memorandum stating that if Federal Funds were cut, then WMKY would most likely lose NPR. He reported that this committee would be sponsoring a resolution protesting such cuts.

# **Professional Policies**

Chair Wilson presented PAd-9: Review of College Deans and Department Chairs for a second reading. Motion passed.

Motion was made to suspend the rules and vote on the following resolution regarding Janet Gross: "WHEREAS Janet Gross was a Senator as early as 1985; and WHEREAS she was Chair of the Professional Policies Committee on 1988-89; and WHEREAS she was Chair of the Faculty Senate in 1989-90; and WHEREAS she became a member of the Professional Policies Committee again in 1993; and WHEREAS it became necessary for her to resign from the Senate, because she has been appointed Interim Chair of the Department of Nursing and Allied Health Sciences; BE IT RESOLVED that the Faculty Senate recognizes and appreciates Janet Gross' dedication and superb contributions to the Senate and the University." Motion seconded and passed unanimously.

Chair Reeder reported that the committee was working on evaluation instruments for assessing the work of the President and Vice President.
