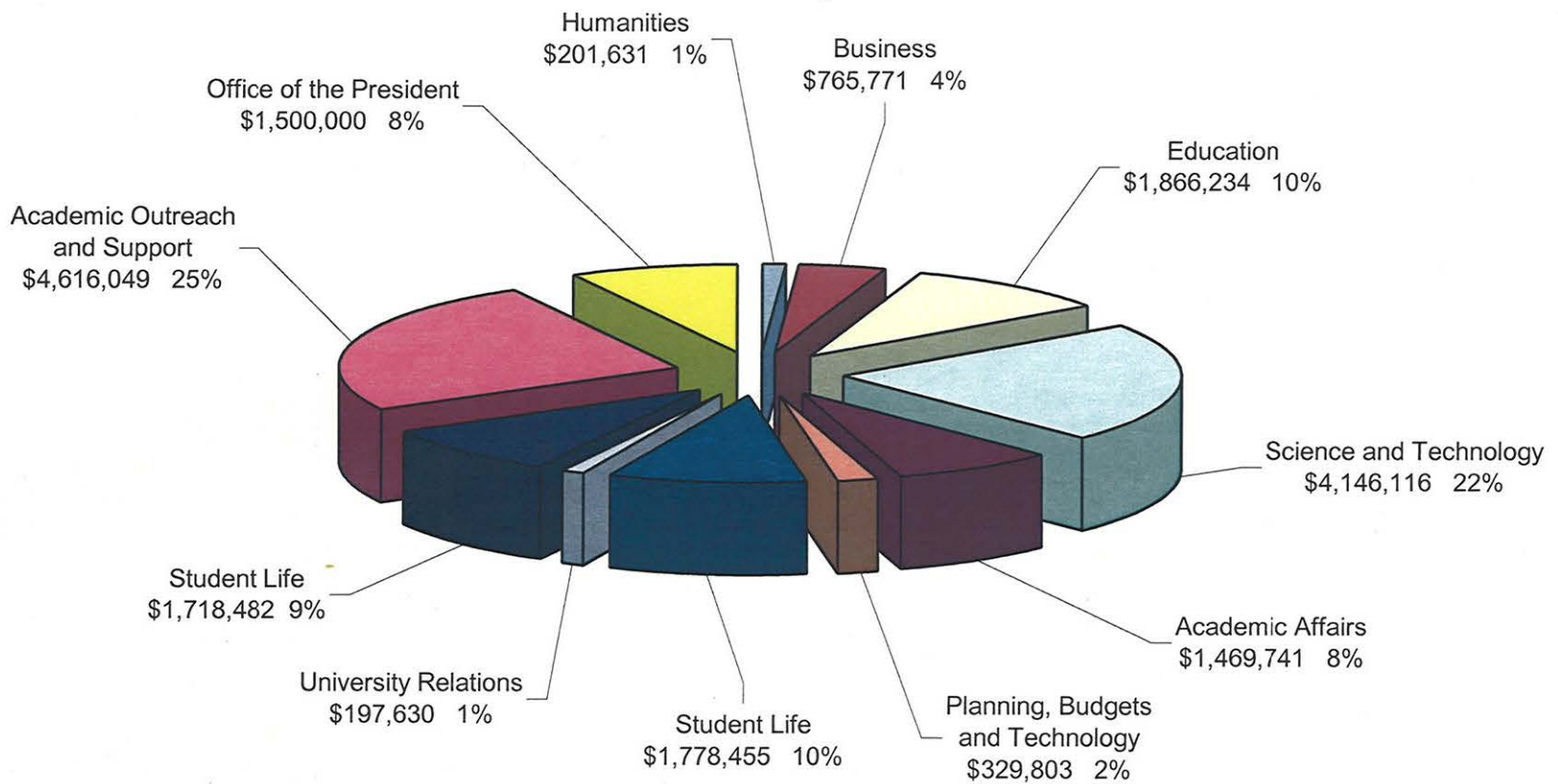

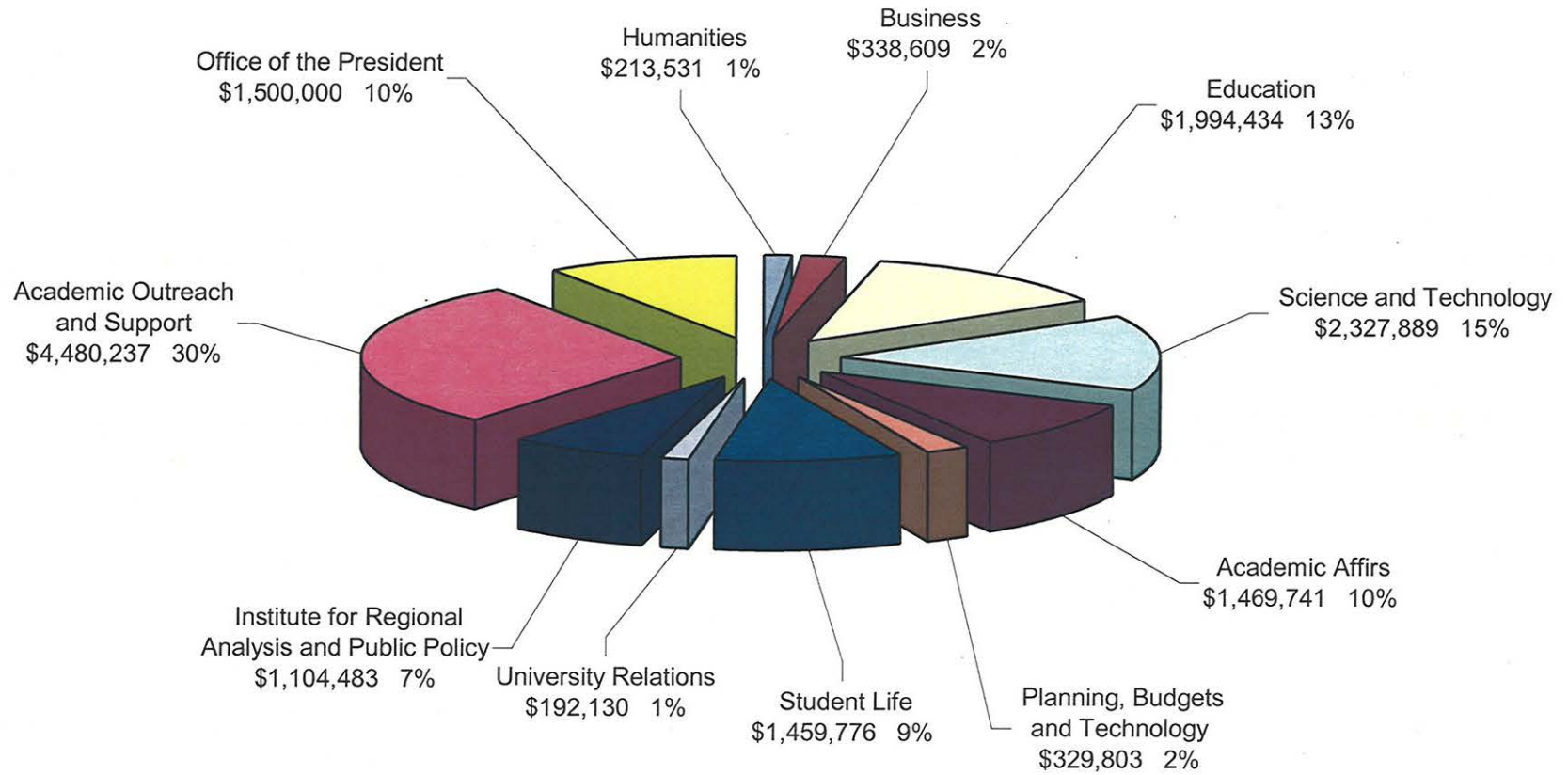

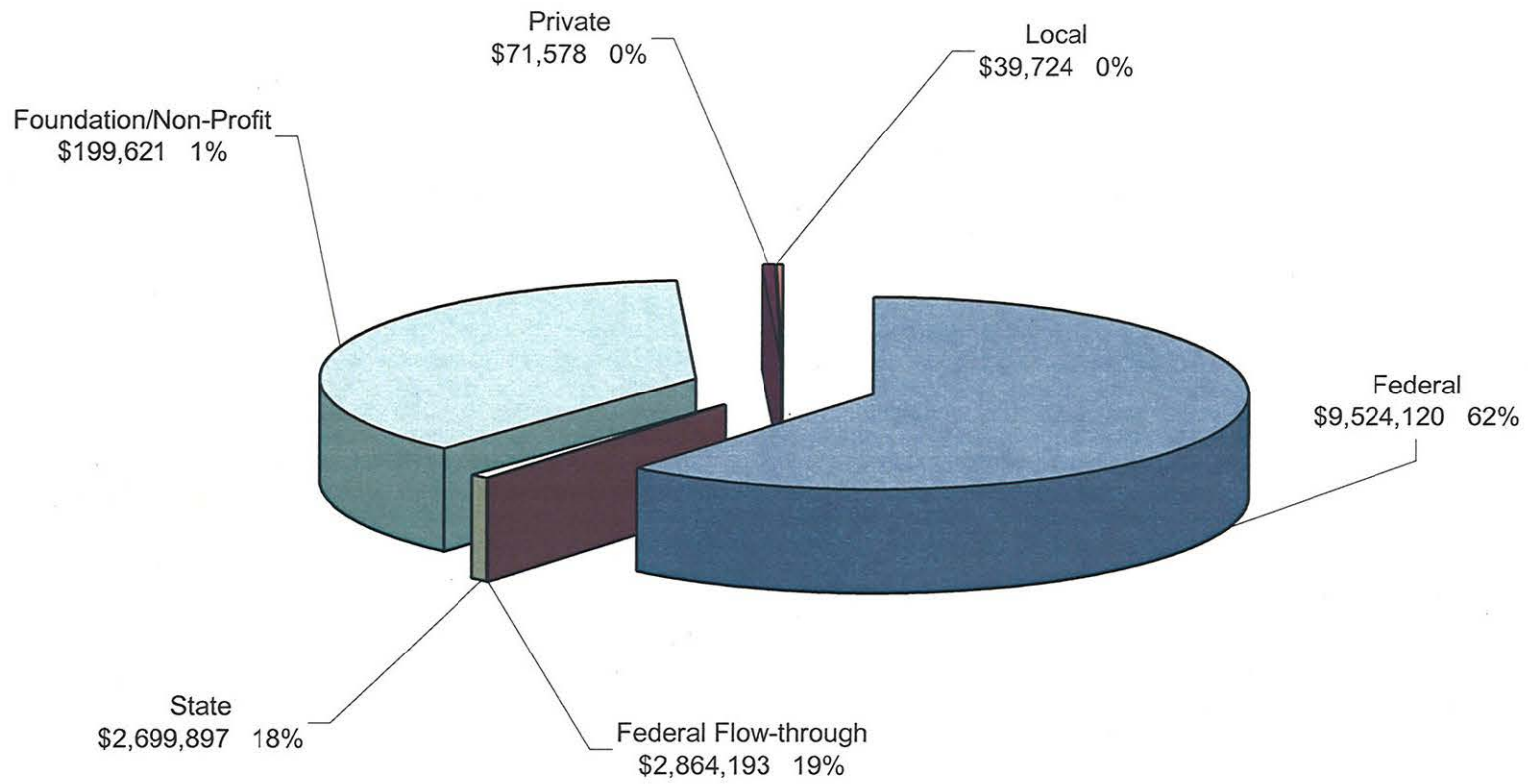
**SUMMARY OF PROPOSALS SUBMITTED

July 1, 2006 through June 30, 2007**



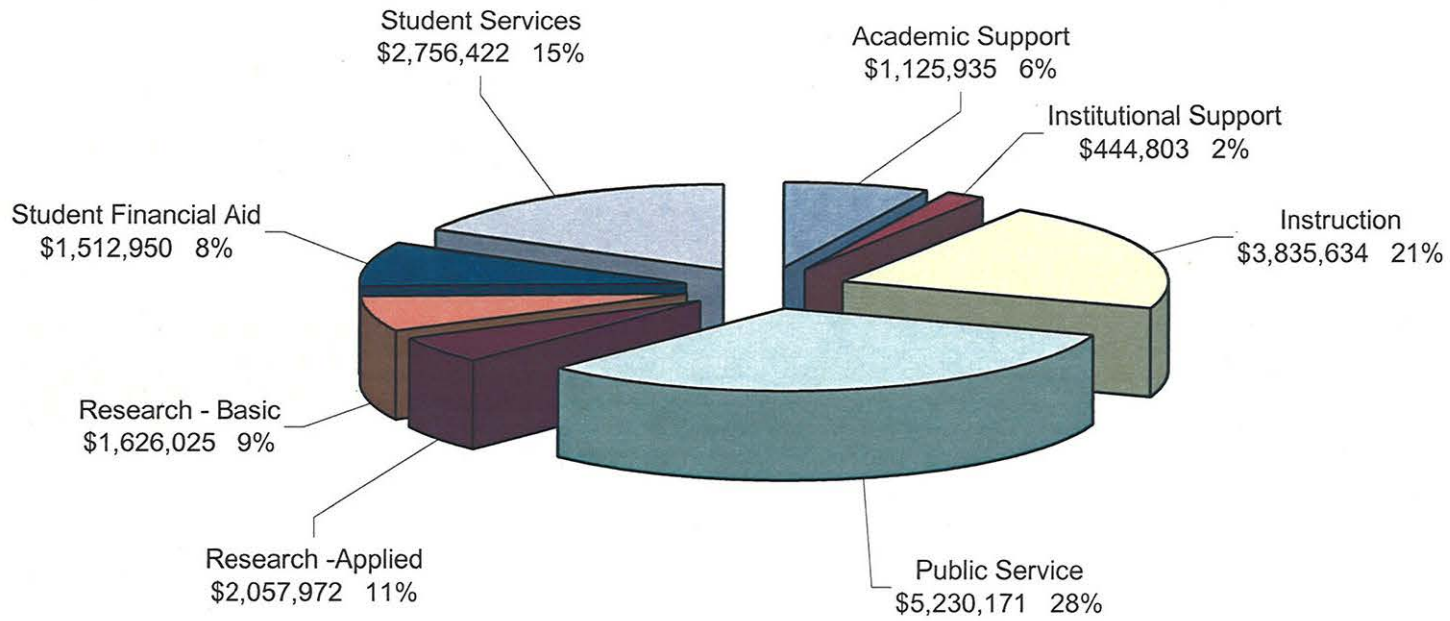
**SUMMARY OF PROPOSALS FUNDED
