TO ALL WRITER MEMBERS!

IN ORDER TO RECEIVE CREDIT FOR AN UNPUBLISHED WORK, A MEMBER MUST FILE A COPY OF THE MANUSCRIPT WITH THE SOCIETY. SUCH COPIES WILL NOT BE RETURNED, EXCEPT IN THE CASE OF SYMPHONIC ORCHESTRAL SCORES OF WHICH ONLY ONE COPY EXISTS. IN THIS CASE, THE SOCIETY WILL ARRANGE TO HAVE THE SCORE PUT ON MICROFILM AND WILL THEN RETURN THE ORIGINAL TO THE WRITER.

THIS SOCIETY WILL ENDEAVOR TO KEEP A RECORD OF ALL MANUSCRIPTS. BUT CANNOT TAKE ANY RESPONSIBILITY FOR THEIR PRESERVATION.

IT CANNOT ACCEPT LEAD SHEETS FOR REGISTRATION. EVERY WORK MUST BE AT LEAST IN THE FORM OF A PIANO ARRANGEMENT.

IN GIVING CREDIT FOR UNPUBLISHED WORKS, THE WRITERS CLASSIFICATION COMMITTEE MUST TAKE INTO CONSIDERATION THE FACT THAT THE WORKS ARE NOT GENERALLY AVAILABLE TO ALL LICENSEES. SUCH WORKS WILL RECEIVE ONLY A FRACTION OF THE CREDIT GIVEN TO PUBLISHED WORKS AND WORKS OF A SYMPHONIC CHARACTER WHICH ARE REGULARLY AVAILABLE ON RENTAL FOR THE USE OF ALL LICENSEES.

THE SOCIETY CANNOT CLEAR UNPUBLISHED WORKS FOR RADIO BROADCAST-ING (EXCEPT SUCH WORKS AS SYMPHONIC WORKS REGULARLY AVAILABLE ON A RENTAL BASIS) UNLESS REQUESTED TO DO SO BY PARTICULAR STATIONS OR NETWORKS FOR SPECIFIC PROGRAMS. BEFORE SUCH CLEARANCE IS GIVEN, THE WRITER MUST WARRANT TO THE SOCIETY THAT HE IS THE ORIGINAL COMPOSER OR AUTHOR OF THE WORK, AND THAT HE WILL INDEMNIFY THE SOCIETY AGAINST ANY LOSS THAT THE SOCIETY MAY SUFFER BECAUSE OF WARRANTING SUCH WORKS TO ITS LICENSES.
