TOURO ALUMNUS RANKS AMONG TOP SPECIALISTS IN CHILD CARDIOLOGY

A member of the first graduating class of Touro College in 1975, Dr. Ira Parnes recently discussed some issues that are on the minds of many pre-medical students and reminisced about his early days at Touro College.

“Those were very exciting times at Touro College,” Dr. Parnes remembers. “The facilities were poor, but our spirits were high. The student body was very motivated and determined to make the program a success.” Dr. Parnes was originally attracted to Touro College because he wanted to remain in a yeshiva atmosphere, and he appreciated the unique opportunities a new institution and small college setting presented.

His transition from a small private college to the much larger SUNY-Downstate where Dr. Parnes received his medical education, was not a smooth one. “It was quite a shock to enter a lecture hall with 200 students when I was used to smaller classes,” Dr. Parnes said. But that was not the most difficult adjustment he had to make as a medical student. “The hardest part was accepting the reality that it is impossible to master all of the material.” Even though Touro had given him a strong foundation in the basic sciences, “there was just too much material to learn,” he recalls.

Dr. Parnes has never regretted his choice to become a physician, “Not even for a moment. I love what I do,” he said. And, not surprisingly, that was his advice to all pre-med students:

“Love what you’re doing. To tell you that you need good grades and good MCAT scores to get into medical school is obvious. But if you love what you are learning, then everything else will fall into place.”

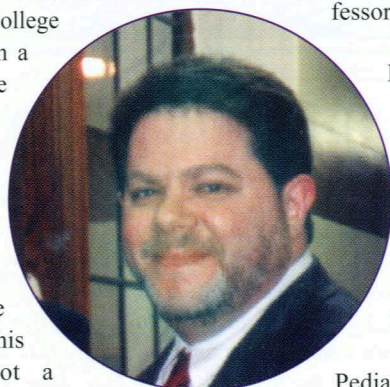
And for Dr. Parnes, things “fell into place” easily. Following a residency at Brookdale Hospital in Brooklyn, Dr. Parnes held a fellowship at Boston’s Children’s Hospital, where he became Director of the Heart Transplantation Program. He also served as assistant professor at the Harvard Medical School.

In 1996, American Health Magazine ranked Dr. Parnes as one of the top three specialists in the United States in the field of Pediatric Echocardiography. Dr. Parnes was also listed among the best specialists in the field by New York Magazine in 1999.

Currently, he is director of Pediatric Cardiology at the Mount Sinai Medical Center.

Asked his opinion on what the biggest challenge facing the medical profession is, Dr. Parnes responded: “The economic pressures are so great today that it is easy to forget why you went into medicine in the first place. You almost have to approach medicine with a religious fervor to remain committed to your moral and ethical principles.”

But being an observant Jew helps, he added. “As a person with a higher sense of purpose, you have an easier time keeping your priorities straight, even in the face of pressures.”

HARVARD LAW SELECTS MINZER, '99 VALEDICTORIAN

Naftali Minzer, valedictorian of the class of 1999, was accepted to Harvard University Law School for September 2000, Dean of Students Robert Goldschmidt has announced. Naftali was also admitted to Columbia Law School.

At Touro in Flatbush, Naftali completed an accounting major and compiled a perfect 4.0 average. He has passed all four parts of the CPA Examination.

While working toward his college degree at Touro, Naftali continued his studies at Yeshiva Torah Vodaath, where he is still enrolled in Spring 2000.

In all, sixteen seniors in the 1999 class received acceptances to prestigious law schools, including Columbia, The University of Chicago, The University of Pennsylvania, Georgetown, Boston University, Fordham and Rutgers.

Mr. Greengart, a senior of the class of 2000, has been admitted to New York University School of Medicine, Mount Sinai Medical Center, and SUNY Downstate School of Medicine.

GRADUATES SCORE AGAIN AT TOP ON CPA EXAM

For the second consecutive year, Touro College has earned top rankings in the nation based on the percentage of its graduates passing sections of the Uniform CPA Examination, Dr. Bernard Lander, president of the college, has announced.

Touro graduates again ranked first in the United States on the Business Law Section with an exceptional passing rate of eighty percent. Touro ranked second on the Financial Accounting and Reporting (FARE) section of the exam with a passing rate of sixty percent. Touro placed fifth on the Accounting and Reporting, Other Areas (ARE) portion of the test.

PERFECT SCORES

Touro salutes Yossie Klein, Shmaya Eichenstein, and Rina Hoffner for passing all four sections of the CPA Examination on their first attempt in November 1999.

Touro was the only college in New York State to achieve top five national ranking, according to results released by the National Association of State Boards of Accountancy (NASBA) for the November 1998 test. Other top ranked schools included the University of Pennsylvania, Rutgers University, the College of William and Mary, and the University of Wisconsin.

Touro alumni who have become CPAs are employed by major accounting firms in New York, New Jersey, Illinois, Maryland, and Israel.

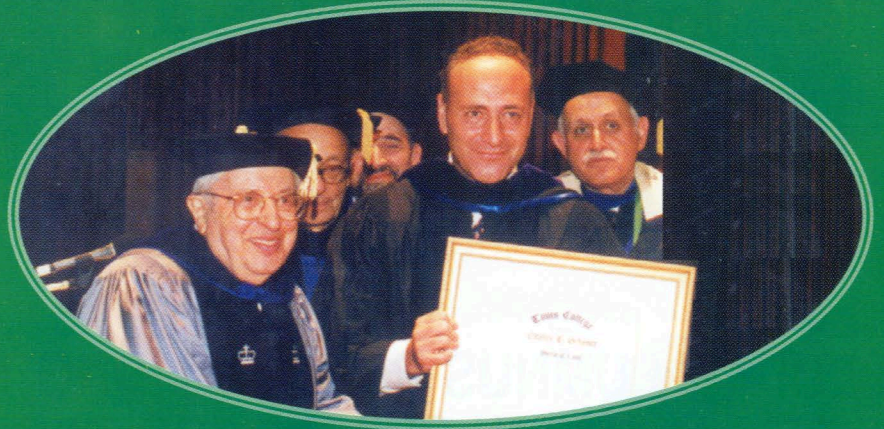
In addition to its CPA program, Touro in Flatbush offers majors in economics, finance, management, management/ marketing, and management information systems.

SIMCHA FELDER '80 RUNS FOR CITY COUNCIL

On March 7, more than 200 community leaders turned out to support Simcha Felder's candidacy for City Council in a district covering Boro Park and a section of Flatbush. Rabbi Nossan Sherman, General Editor of Artsroll, praised Simcha's honesty and sincerity. Elections are scheduled for November 2001.

Chief of Staff to Assemblyman Dov Hikind for the past four years, Simcha served previously as legislative liaison with Controller Alan Hevsei and was a manager for 10 years in the New York City Department of Finance.

So how did this former yeshiva bachur make good? If you ask him, he gives a great deal of credit to Touro College. "I never thought of going to college," explains Simcha, "and would not have, had Touro not existed. Touro established a school in the

When he is not as home with his wife Elana (nee Cheifetz) and kids, or at work, Simcha enjoys teaching management courses at Touro. "I appreciate the opportunity to take a personal interest in my students," says Rabbi Felder. "This is my way of saying thank you to Touro."

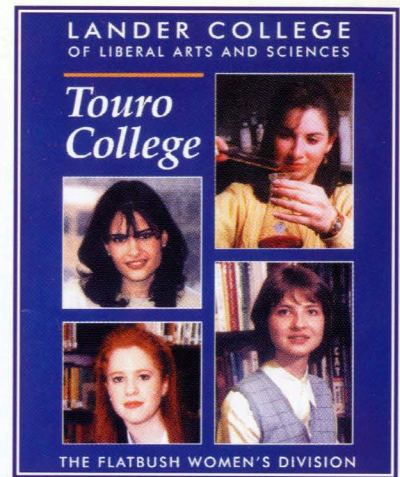
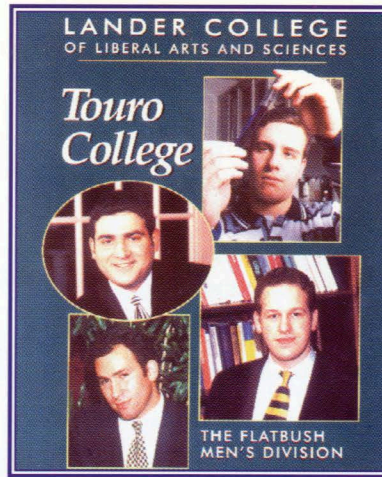


This year, we have added a major in mathematics for women and a major in speech and communications for men.

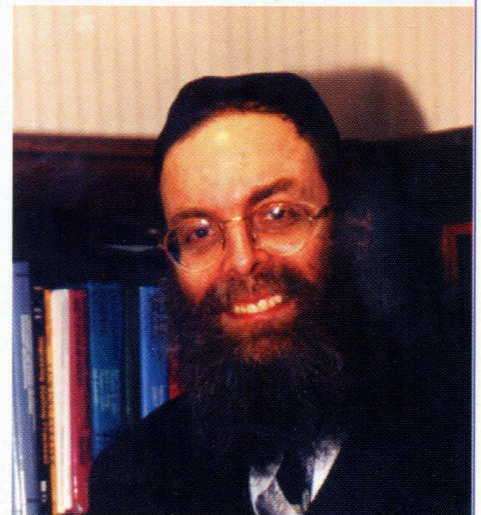
Dr. Cohn's two daughters, Chana and Sara, are enrolled at the Flatbush Campus of Touro College.

32 Excel on Teacher Certification Exam

Touro College graduates achieved an exceptional pass rate of 100% on the Liberal Arts and Sciences portion of the New York State Teachers' Certification Examination during the 1998-1999 testing cycle. All candidates for licensure are required to pass this test.

Among the students who earned teacher's certification are Chanie Zilberberg, Valedictorian of the Flatbush Women's Division, and S' Rivky Goldschmidt, both of whom are currently pursuing master's degrees in teaching reading at the Graduate School of Education at Fordham University.

In all, 32 Touro students passed their certification examination during this testing cycle.

STUDENT SOCIETIES IN THE NEWS

The Health Science/Pre-Medical Society and the Political Science/Pre-Law Association, two very active student clubs at the Flatbush Campus, recently elected new officers to leadership positions.

Michael Tyberg (men's division) and Faige Mandelbaum (women's division) both pre-medical students, were chosen as presidents of the Health Science Society. The society, with a membership of more than 80 students, plans to publish a scholarly science journal in May.

Edward E. Neiger (men's division) and Ruchie Freier (women's division)

were chosen as the presidents of the Pre-Law Association. This year, pre-law students have participated in a variety of field trips, meetings with judges and political leaders and a conference with partners at Willkie, Farr and Gallagher, one of the most prestigious law firms in the nation. A visit involving a case hearing before the United States Supreme Court in Washington is scheduled for late March and will include a

conference with one of the Justices of the Court. The Political Science Association also sponsors the annual *Pre-Law Journal*.
