Dear Janice and Jimmy:

I can certainly appreciate the distressing situation with which you are faced in the case of the abused child. As you may know, child abuse is becoming quite a problem these days in our country. I have just had personal experience with such a situation in recent weeks.

Your best approach is probably to contact the Child Welfare Division of the State Department of Public Welfare in your city. You could report the address and the name of the family to a Child Welfare Worker who would in turn take it from there and probably visit the child's teacher and make other inquiries in the neighborhood. The other possibility would be to report this to the police, who in many communities also have a way of investigating situations like this. My first preference, however, is to go to the Child Welfare people with whom the responsibility for handling such things is charged.

You should be very careful about your name being used in this matter. Without the official status of a Child Welfare Worker or some officer of the court, the family could become extremely hostile to you. This, of course, is not to preclude you from taking some action, but it is to ask you to be extremely careful in the way you share this information with the authorities involved.

One other thought would be that if this family is a military family, the matter should be reported to the Base Commander's office. There must be some person in charge of the general conduct of all army personnel and dependents that Jimmy would know to contact. If, however, this is a civilian family the matter should probably go directly to the Child Welfare division of the State Department of Public Welfare. They handle this kind of thing often and will know how to proceed.

We think of you often and appreciate so much our friendship. We hope that we will have an opportunity to visit with all of you again before any move of yours out of Texas. Watch for a time when you can come and spend a week-end with us. We would love to have you.


