Thank you so much for the kind attention the eldership there gave my recent request of release from a commitment for a gospel meeting this year. You will remember in the letter that I explained why the confusion had arisen in my schedule. In our previous correspondence of several months ago, I indicated a date but received no confirmation from you. Due to a very, very busy schedule I had to use that time or allow myself to become overscheduled, and therefore, not hearing from you on a confirmation, simply assumed that you did not desire the meeting after all. This does occur often and I always act on this basis with other churches as well.

There is no possible way for me to be with you this year for a full week's gospel meeting. Those in charge of my schedule have said that it cannot be. I could possibly be with you on any given Sunday for a special Bible School drive or some other special reason for wanting an outside speaker for one Sunday only. My schedule demands that I be in the office here in Abilene working with radio sermons as much as I possibly can.

I am not at this present time scheduling any further meetings. You very graciously asked about April 1969 or October 1971. One of those years you may have a special need arise and want to request my involvement in that effort, but due to the changing nature of our evangelistic demands, I find it advisable not to schedule any further meetings on a long-term basis.

I appreciate so much your understanding of my situation. It is a very difficult and burdensome one. However, you men are not foreigners to grave responsibility. I appreciate the work being done there by the church, and the leadership you are providing it. If the future holds any opportunities for us to work together, I will be grateful.
