### FROM INTERIM DEAN STEINMAN

I thought you might be interested in learning about this year's incoming class:

The class numbers 345 students (out of 2,400 applicants), with 242 attending the Day Division and 103 attending the Evening Division. The class is made up of 190 men (55 percent of the class) and 155 women (45 percent of the class), and minority students constitute 15 percent of the class. Our entering students hold undergraduate degrees from 131 different colleges and universities (a list of those schools is printed at the back of this week's *Record*), and the entering class includes 43 students with graduate degrees.

Twenty-eight percent of the students in our entering class are from out-of-state. In addition to Illinois, the following home states are represented: Alaska, Arizona, California, Colorado, Connecticut, Florida, Indiana, Iowa, Kansas, Louisiana, Maryland, Massachusetts, Michigan, Minnesota, Mississippi, Missouri, New Jersey, New York, North Carolina, Ohio, Pennsylvania, Tennessee, Texas, Virginia and Wisconsin, as well as the District of Columbia and Puerto Rico. Five students, including two Fulbright Fellows, are seeking a Master of American Legal Studies degree. They come to us from Bulgaria, Indonesia, Japan, Liberia and Sweden.

To all of you, both new and returning students, I wish a fulfilling and successful year.

### Student Directory/Privacy Form

The student directory listing names, local addresses and phone numbers will be published in September. If you do not wish to have this information published, you must fill out a privacy form, available in the Registrar's Office, Room 306, by Sept. 7.

### Add-Drop

If you have a tuition balance from either the spring or summer semester, the new computer system will prevent you from making a program change. Your account must show a zero balance to allow you to make any program changes. Adds to open courses will be accepted in the Registrar's Office, Room 306, through Friday, Aug. 31. Drops will be accepted from courses other than required or clinical courses until the final exam or paper due date with a decreasing tuition refund.

#### Fall '90 Graduates

Students who expect to complete the requirements for the J.D. degree at the end of this fall semester must submit a graduation declaration no later than Friday, Sept. 7 in the Registrar's Office, Room 306. There is no commencement ceremony in January, but you may participate in the official ceremony in June.

#### Student Activities Fee

The student activities fee for the fall 1990 semester has been set at \$25 by the Student Activities Finance Board. This fee will be included in your tuition statement.

#### **Loan Checks**

Those students who are expecting to receive a loan check other than Perkins/NDSL should check the lists posted on the second floor bulletin board. When your name is listed your check is available in the Registrar's Office, Room 306. You will be expected to sign your loan check over to IIT in its entirety. If you expect to receive a refund, it will be available in the Registrar's Office within three to five days of signing over your loan check.

#### Student Insurance

All full-time day division students must have health insurance coverage. IIT offers very basic insurance coverage for \$149 per year, payable in two equal installments. You will be automatically billed for the student insurance if you want the plan, and no response is required. If you choose to decline the insurance, your declination must be received by the Bursar's Office no later than Friday, Sept. 28. Declination forms are available in the College Office, Room 301.

Evening students also may be covered by the plan if they desire. However, evening students are not automatically charged; you must sign up for the plan. Applications are available in the College Office. If you have been given permission to take more than 11 hours, you will be charged for the insurance automatically. If you do not want the insurance, you must fill out the declination form and return it by the deadline stated above.

### **Lockers Opened**

Locks were cut off and the contents removed from lockers on Aug. 6. If you had not removed your lock and contents from the locker you used last year, see custodian Kelly Courtney to reclaim your belongings.

If you do not do so by Friday, Sept. 14, all materials recovered from lockers will be disposed of.

Lockers that do not have locks on them by Friday, Sept. 7 will be considered vacant. The Registrar's Office will reassign lockers considered vacant on Monday, Sept. 10 to any student who does not have a locker at present.

### RESEARCH ASSISTANTS WANTED

**Professor Marc Grinker** is seeking a research assistant to work with him on an article examining the use, misuse and avoidance of medical knowledge by courts in HIV-testing cases. The working thesis is, in

part, that the standard HIV test, which has virtually no prognostic or diagnostic value, can no longer be considered constitutionally permissible if mandated in isolation from other tests (assuming that it ever should have been under any circumstances). This conclusion is based in part on the medical profession's development of new tests for certain advanced diagnostic markers. These advanced tests, which have both prognostic and diagnostic value, are not being required by courts in upholding mandatory HIV testing regimens (by certain government employers, for example). Thus, the law in this area has not kept pace with medical advances. Interested students should stop by Professor Grinker's office, Room 214, or call him at ext. 7546.

#### **COMPUTER LAB ETIQUETTE**

These rules are mostly common sense, but they are necessary so that we can continue to deliver excellent computing services to all students.

Absolutely NO food or drink is allowed in the computer labs.

Always log completely out of Kentnet when you are finished using the computer.

The library computer lab (room 416) closes 15 minutes before the library.

You cannot reserve a computer by leaving your books. If you are going to do research in the library, logout. If you are going to take a meal break, logout.

Clean up your space! Do not leave paper or garbage in the computers labs.

These rules are simple, common courtesy. As students and professionals we expect your cooperation so that we may devote our time to improving services.

### TOP TEN QUESTIONS OF THE WEEK

1 How do I login to Kentnet?

Login names are different from last year. Your login name is your first initial plus the first seven <u>letters</u> of your last name. In case of duplicates a '1' or a '2' will be added to the end of the login name. Your password has been reset to your social security number.

2 What's going on with printing?

We have recently upgraded the file server and the operating system that runs Kentnet. Kentnet is much faster than last year. We are still working out some problems with printing and hope to have them solved by next week. To print on the dot-matrix printers in the computer labs, you do not have to 'release' your print jobs at the printer servers like last year. This is a temporary situation. When it is fixed, you will send print jobs to the printer server and release them from the printer server to start printing.

3 Can I call Kentnet from home?

Not yet. That capability is on the

agenda for this semester.

4 When I access LEXIS from home, am I making a long-distance call?

No. The phone number built into the LEXIS software is in downtown Chicago.

5 Can I take home more than one CALI lesson on a single diskette?

No. Different CALI lessons use files with the same name. This means that you must keep each lesson on a separate diskette or put each lesson in its own subdirectory. We are working on a method where the lessons are copied to your diskette in compressed format. This will enable you to put several lessons on a single diskette.

6 Can I download with WESTLAW?

We have not yet received all the details about law student WESTLAW access. When we do, we will publish an information sheet that will be available on the literature table outside room 643.

7 Can I send electronic mail to the my law professors?

Yes. Their login names are formed the same way that student login names are formed.

8 If the labs are for students, why do you close them for classes?

The computer labs are unique classroom environments that we use to train students in LEXIS, WESTLAW and other sophisticated tools. We pay careful attention to lab scheduling and paper due dates to prevent conflicts.

9 The bookstore doesn't have Framework.

There was a glitch in the availability of Framework for early this semester. The bookstore should be receiving new copies of Framework soon.

10 I have a Macintosh, what should I do?

You should attend the Apple Macintosh Users at Chicago-Kent meeting on Tuesday, August 28 at 12:00 in room 643.
