#### **FACULTY NEWS**

**Professor Fred Abbott's** essay "Trade and Democratic Values" will be published in the inaugural issue of the Minnesota Journal of International Economic Law and Policy. The essay examines the current political movement toward managed trade policy in the United States in the context of a successful U.S.-lead post-World War II strategy to promote democratic and peaceful government (as well as global prosperity). The essay suggests that the current preoccupation of U.S. trade policy-makers with short-term economic dislocations in the United States may prove short-sighted on both economic and political grounds.

**Professor Randy Barnett** was interviewed for WTTW's "Chicago Tonight" which aired Wednesday, February 5. The topic was the State's Attorney's Office primary election contest.

Professor Randy Barnett delivered a paper at a conference on *Risks and Wrongs*, a new book by Yale Law School Professor Jules Coleman that is forthcoming from Cambridge University Press. The conference was held at the University of San Diego Law School and the papers will be published in a symposium issue of the *Harvard Journal of Law and Public Policy*. Besides Professor Coleman, other participants included law professors Larry Alexander (U.S.D.), Richard Craswell (U.S.C), Stephen Perry (McGill), Margaret Radin (Stanford), Alan Schwartz (Yale), Kenneth Simons (Boston University), and philosophers Richard Arneson (U.C.S.D.), David Gauthier (Pittsburg) and Jean Hampton (Arizona). Professor Barnett's paper was entitled, "Rational Bargaining and Contract: Default Rules, Hypothetical Consent, the Duty to Disclose, and Fraud." (He sincerely hopes to come up with a better title before publication.)

**Professor Howard Eglit** was named a Fellow of the Buehler Center on Aging of McGaw Medical Center, Northwestern University.

**Professor Kling** continues to serve as an authority source for coverage of the Dahmer insanity trial by the media -- print, TV and radio.

Eight Chicago-Kent faculty members have been included in the 1992-93 edition of Who's Who in American Law: Lloyd Cohen, Stuart Deutsch, Howard Eglit, Philip Hablutzel, Linda Hirshman, Gordon Hylton, Ronald Staudt, and Dan Tarlock.

#### **ALUMNI NEWS**

1988 Chicago-Kent graduate Kenneth B. Moll was just named partner in his law firm, which last week was renamed McDowell, Moll, Fitzgibbons & Drew.

In his first year of practice, Moll won \$4.5 million in a DPT (Diptheria Pertussis Tetanus) suit - the nation's highest award involving the childhood tetanus vaccine. Moll next agreed to handle the case of a Florida woman who believed her silicone-gel breast implants were making her ill. The case won him more additional breast implant suits, a full two years before the FDA halted production of the breast implants a few weeks ago.

Moll started with his law firm in 1988 by answering a job ad posted at Chicago-Kent for a temporary clerking position.

David Rappaport, who graduated from Chicago-Kent in the early 1980's, was the lead plaintiffs' counsel in the recently settled litigation over the 1989 United Airlines crash in Sioux City, Iowa. Rappaport has his own law firm in Highland Park, and began his law career at Katz, Friedman, Schur & Eagle, a union-side labor law firm.

#### FYI - BLACK HISTORY MONTH

This is one of a series of articles provided the Chicago-Kent Community by the Black Law Students Association in celebration of Black History Month.

#### Did You Know the Contributions of Thurgood Marshall?

A celebration of Black History Month is an annual 28 day event in February but everyday that African-Americans live is a recognition of the legacy of a strong and courageous people who survived the pernicious degradation of slavery and oppression. This month we are celebrating those well-known and unknown faces who sacrificed their lives to obtain for my generation, the access to the fundamental rights of life, liberty and the pursuit of happiness. Looking back historically, while the white majority and new immigrants were building their financial empires based on the "boot-strap" philosophy of America, especially during the Industrial Revolution, Black people, even though purportedly emancipated, were still struggling for the right to own property, be educated, to use public accommodations, and the right to vote. In spite of the blood and loss of lives of people, i.e. Nat Turner, Medgar Evers, Jimmie Lee Jackson, Martin Luther King, Emmett Till and all of those known and unknown, we still have to struggle against racism today in America and South Africa. Regardless of the ongoing struggle, we are an enduring people, perhaps, akin to Bulls Michael Jordan, who can jump higher than anyone else to overcome insurmountable odds.

Clearly, no celebration of Black history would be complete without an auspicious tribute to the Honorable Thurgood Marshall who gave a lifetime of commitment to civil rights and used his legal genius to be a trailblazer in making the United States Constitution an honest document. Justice Marshall is best known as the NAACP Legal Defense Fund Attorney who masterminded the victory in <u>Brown v. Board of Education</u> which proclaimed that the "separate but equal" law that governed the United States from before 1896 to the <u>Brown</u> decision in 1954 as inherently unequal and unconstitutional.

He is born in Baltimore Maryland on July 2, 1908 with great beginnings. It is said that his great-grandfather was an African slave whose defiance gained his freedom. Thurgood's mother was a school teacher in an all Black elementary school and his father was a steward in a white segregated country club. Just from being Black in America, he learned what segregation was but, more importantly, he learned how to fight it.

Judge Marshall began his fight with his education. In 1933, he graduated Magna Cum Laude, first in his class from the all-Black Howard University Law School in Washington, D.C. and was admitted to the Maryland Bar. As he continued his fight against racism and discrimination, he achieved his first legal victory by winning the right for a Black man to be admitted to the white only University of Maryland law school in <u>Pearson v. Murray</u>, 169 Md. 469 (1935). Later, he prepared the brief and assisted in the litigation of <u>Missouri ex. rel. Gaines v. Canada</u>, 305 U.S. 337 (1938) where the Court held that the State was obligated, within its borders, to provide a legal education for a Black law school applicant thereby desegregating the University of Missouri Law School. It is said that <u>Pearson</u> established the principle of equalization in maryland and <u>Gaines</u> expanded its application to the entire nation. When I look back in time to the centuries of denial of education and discrimination in admittance of Black to professional schools, it is no wonder that African-Americans are under-represented in the law schools and legal profession but I am grateful to Thurgood for opening the door.

In spite of his outstanding contributions, not only to Blacks but also to this country, Judge Marshall is conspicuously ignored in the law school text books and treatises on constitutional law. However, I am sure that it does not offend him in that he knows, more than anyone else, that he lived his life making a difference for all of us.

As the Director of the NAACP legal Defense and Education Fund, Thurgood Marshall became the most outstanding civil rights attorney in America. In the face of threats to his life from white segregationists, he persisted in impacting on civil rights at every level. For example, in <u>Shelley v. Kraemer</u>, 344 U.S. 1 (1948), Thurgood fought discrimination in housing where State courts were barred from enforcing racially restrictive

Court held that segregation in restaurants at interstate buys terminals were unconstitutional and in violation of the law. He took 32 cases to the United States Supreme Court on behalf of the Legal Defense Fund and of those 32, he won 27.

Uncontrovertedly, Thurgood Marshall was a brilliant lawyer and in September 1961, he was nominated by president John Kennedy to a judgement in the United States Court of Appeals, Second Circuit. However, wrath against his civil rights victories prompted Southern racist Democrats to delay his confirmation for almost a year. Regardless of the resistance, Justice Marshall was appointed U.S. Solicitor General by president Lyndon B. Johnson in 1965, and successfully argued before the Court to uphold the 1965 Voting Rights Act in the well-known case, <u>South Carolina v. Katzenbach</u>, 383 U.S. 301 (1966). In a historical and unprecedented action, president Johnson became the first president in the history of the United States to nominate a Black man to the highest court in the land. In a well-deserved victory, the Honorable Thurgood Marshall was sworn in on october 2, 1967, as the first African-American and the ninety-sixth Justice of the United States Supreme Court.

Justice Marshall is known for the eloquence of his dissenting opinions. As a matter of record, it was rare to find Justice Marshall vote among the majority. Perhaps, not given his proper credit as one of the most magnificent Supreme Court Justices of our time, we know that Justice Marshall had already been to the "mountain top" when he ascended to the Supreme Court. After all, his relentless legal genius had already changed the law of the United States and charted the course of civil rights.

Recently, the Honorable Thurgood Marshall retired from the Bench. As a beneficiary of his sacrifices and achievements, I am honored to have lived in his lifetime. he is an icon, not only in the history of civil rights, but also in the history of the United States. It is a privilege to honor Justice Marshall, a precious jewel in the history of African-Americans.

FINANCIAL AID AND NEED-BASED SCHOLARSHIPS

The 1992-93 Financial Aid Form (FAF) and the Chicago-Kent College of Law, Illinois Institute of Technology Financial Aid Application are now available in the Office of Admissions and Financial Aid, Suite 230. An information packet to assist you in completing the forms is also provided.

This is a long memo, but it is one you need to read. Your financial aid, whether a loan and/or a need-based scholarship, depends on it.

Once again, that time has arrived for you to begin the process of applying for financial aid for next year. Please take note of the calendar of important dates below; I suggest that you save this memo for later reference.

We have prepared an information packet to assist you in the application process. Please be sure to read through the **entire packet**. These packets, along with the FAF and Chicago-Kent College of Law Financial Aid Application, can be obtained in Suite 230 of the new building.

Recent congressional legislation has made an important change in the federal student loan programs: borrowers age 21 or older will be required to undergo a credit check before any loans are approved. **This may affect your ability to borrow student loan funds.** Information regarding credit reports is provided in the information packet; please read it carefully. Additional information will be announced in The Record as it is received.

**Take special care in reading the FAF instructions.** The school code for Chicago-Kent College of Law is <u>1654</u>. Please note that this is NOT the code listed in the FAF packet.

To be eligible for all forms of financial aid you must meet the deadlines listed on the following page.

## By April 1

- 1. The FAF should be <u>received by</u> the College Scholarship Service (CSS) no later than April 1. A pre-addressed envelope is enclosed with the FAF instruction booklet. Plan to mail it in sufficient time to meet the deadline.
- 2. Your Chicago-Kent College of Law Financial Aid Application should be received by the Chicago-Kent College of Law Office of Admissions and Financial Aid no later than April 1. The Office is located in Suite 230 in the new building.
- 3. Financial Aid Transcripts must be sent to all previously attended colleges or universities by April 1, <u>if</u> this is the first time you are applying for financial aid at Chicago-Kent.

## By June 1

- 1. After you file your FAF, you will be sent a Student Aid Report (SAR) by the College Scholarship Service (CSS). All pages of your Student Aid Report should be in your financial aid file at Chicago-Kent College of Law by June 1, even though it will say that you are not eligible to receive a Pell Grant (Pell Grants are for undergraduates only). Do not send any corrections on your Student Aid Report to CSS; send the SAR to the Office of Admissions and Financial Aid as is and attach any corrections on a separate sheet of paper. Make sure that you sign the report where indicated.
- 2. If you are selected for Verification, you will be asked to submit copies of your tax forms and a Verification Worksheet. These materials and your SAR must be returned before a financial aid award will be determined for you.
- 3. You should sign and return your financial aid award letter to the Office of Admissions and Financial Aid by June 1, or within three weeks if received after June 1.

## By July 15

1. You are expected to turn in student loan applications from the lender of your choice by July 15. If you are unsure of a lender, contact the Office of Admissions and Financial Aid at (312) 906-5180. Loan applications for the Law Access program will be available in the Office of Admissions and Financial Aid, Suite 230. You can also obtain a Law Access loan application by calling Law Access directly at (800) 282-1550.

We are ready to help if you need assistance -- just call the Office of Admissions and Financial Aid at (312) 906-5180. Above all, please do not put this off (especially doing your taxes).
