FROM DEAN MATASAR

The following is some additional biographical information about new instructors you may have noticed on the schedule of courses for next fall:

Assistant Professor Evelyn Brody is a 1981 graduate (magna cum laude) of Georgetown University Law Center, where she was Case & Notes Editor of *The Tax Lawyer*, the law journal of the ABA Tax Section. She received her undergraduate degree in comparative literature at Yale College, having spent two years at M.I.T. Professor Brody has practiced with the Washington, D.C. firm of Arnold & Porter and the Madison, Wisconsin firm of Michael, Best & Friedrich. Since 1988, she has been attorney/advisor to the Tax Legislative Counsel in the Office of Tax Policy, U.S. Treasury Department. Professor Brody is an experienced and very well-respected expert in the area of taxation. She is the lead author of *The Partnership Tax Practice Manual* and co-authored *A Guide for Wisconsin Nonprofit Organizations*. Professor Brody will be teaching Corporate Tax in the Fall and Partnership Tax in the Spring.

Visiting Professor Jerry Dworkin is currently a Professor of Philosophy at the University of Illinois. He received his bachelor's degree from the City College of New York and his Ph.D. from the University of California at Berkeley. Professor Dworkin has written primarily in the areas of ethics and political philosophy, including philosophy of law. In 1988, his book, *The Theory and Practice of Autonomy*, was published by the Cambridge University Press. Professor Dworkin will be teaching Justice in the Fall.

Visiting Professor John Hart Ely, Robert E. Paradise Professor of Law at Stanford University and 1990-91 Chicago-Kent Centennial Visiting Scholar, will be returning to the law school for the Fall 1992 semester. Professor Ely is one of the country's most distinguished constitutional law scholars. He is the author of *Democracy and Distrust: A Theory of Judicial Review* (1980), a leading work on its topic and winner of the Order of the Coif triennial award for the best book published in any field of law during 1980-82. Symposia on *Democracy and Distrust* have been published in the *Ohio State Law Review* (1981) and the *Virginia Law Review* (1991).

From 1982 until 1987, Professor Ely was Richard E. Lang Professor and Dean at Stanford. He was named Robert E. Paradise Professor of Law in 1988, and since that time also has been a senior research fellow at the Hoover Institution on War, Revolution, and Peace, based at Stanford. Professor Ely has taught at Yale and Harvard Law Schools. In 1987, he was Lee Juan Yew Distinguished Visitor at the National University of Singapore, and, during 1978-79, he was a fellow at the Woodrow Wilson International Center for Scholars at the Smithsonian Institution.

Among his other professional activities, Professor Ely was staff attorney in 1964 to the President's Commission on the Assassination of President Kennedy, and, during 1964-65, he was law clerk to U.S. Supreme Court Chief Justice Earl Warren. During 1975-76, he was general counsel to the U.S. Department of Transportation.

Professor Ely received an LL.D. in 1988 from the University of San Diego, an LL.B. in 1963 from Yale Law School (*magna cum laude*, *Yale Law Journal*, Order of the Coif) and an A.B. in 1960 from Princeton University (*summa cum laude*). In 1965-66, he studied as a Fulbright Scholar at the London School of Economics and Political Science. He has lectured and written widely on numerous constitutional law topics. During the Fall semester, Professor Ely will be teaching Constitutional Law.

Visiting Associate Professor Barry D. Matsumoto, currently is Associate Professor of Law at the University of Iowa College of Law, will be visiting the law school for the Spring 1993 semester. Professor Matsumoto received his B.A. and J.D. from the University of Washington, where he was a member of the *Washington Law Review*. He was an associate with the Seattle law firm of Bogle, Gates, Dobrin, Wakefield & Long from 1970 until 1972, when he joined the Japanese American Citizens' League as its Washington representative. Professor Matsumoto joined the faculty of the University of Iowa in 1974, and has visited at the University of Virginia and the University of Durham, United Kingdom. He has taught Constitutional Law, Environmental Law, and Local Government, among other courses. Professor Matsumoto will teach Property and State & Local Government.

Visiting Assistant Professor Ann Southworth has been a Bigelow Teaching Fellow and Lecturer in Law at the University of Chicago Law School since 1991. From 1989 until 1991, she was a staff attorney for the appellate section of the civil division of the U.S. Department of Justice, and she spent one year as a staff attorney for the Washington Lawyers' Committee for Civil Rights Under Law. Professor Southworth was a litigation associate for the Washington, D.C. law firm of Morrison & Foerster for three years, and, prior to that, was clerk to the Honorable Stanley A. Weigel, U.S. District Court, Northern District of California, for one year. She received both her B.A. in political science and her J.D. from Stanford, where she served as associate editor of the *Stanford Law Review* and spent the first semester of her final year as an intern at Oxford University. Professor Southworth will be teaching Civil Procedure 2 in the Fall and The Legal Profession in the Spring.

FALL, 1992 REGISTRATION INFORMATION

Registration Begins Tonight

Registration for the Fall, 1992 semester begins tonight for Evening Division students. Registration instructions and the final Fall, 1992 schedule of classes are available outside the cafeteria and in the Registrar's office. Make sure to use the schedule in the Registration Information publication, not the preliminary schedule.

Immunization Records

Over 70 students will not be permitted to register because holds were placed on their records by the university for failure to submit immunization records. The names of these students are posted on the administrative bulletin board. Students on the list are urged to immediately call Jim Novak at IIT, 567-3300, to make arrangements to submit the required records so the hold will be released in time to register without loss of priority.

Additions and Corrections to the Registration Information and Schedule of Classes

Prof. Kevin Smith will teach Evidence in the Evening Division at 6:00 p.m. on Monday and Wednesday. The section number is 273-051-03; the final exam will be Tuesday, December 22 at 6:00 p.m.

Section 052 of Legal Drafting, page 15 on the Evening Division Schedule taught by Prof. Miller, will meet from 5:35 to 7:25 p.m. instead of 7:35 to 9:25 p.m.

Privacy and the Law. This seminar examines the law as it relates to personal privacy in the home, the workplace, education, and the like. It develops the history of the privacy concepts in law and philosophy. It, then, covers case law as well as statutory law in a state, federal, and international context. Finally, it hypothesizes the legal possibilities for future movement on a variety of privacy issues. A seminar paper as well as a class presentation are required.

Graduate Tax Courses, page 5: All graduate tax courses are two credit hours. J.D. students may register for these courses if they have completed Personal Income Tax and have at least a 3.00 GPA. Students with GPAs between 2.50 and 3.00 may take these courses with the permission of Prof. Sherman.

Hospital Law, page 6: The course meets on Monday and Thursday at 12:50 p.m., not Tuesday at 7:35 as indicated on the course description. The course is correctly listed on the schedule and the grid.

Intellectual Property 1 - Patents, page 6: The course description is correct, but the time and instructor listed with it are incorrect. The course is correctly listed on the schedule as meeting on Wednesday and Friday from 11:20 to 12:40 and will be taught by Prof. Hannay and Parkhurst.

Corporate Tax at 7:35 p.m., page 17: This section is being taught by Prof. Gerry Brown; Prof. Brody is teaching the day section at 10:40 a.m.

Justice - TBA, page 17: Prof. Dworkin is teaching this section.

CORRECTION TO THE PRELIMINARY SPRING, 1993 COURSE INFORMATION

International Law was incorrectly listed on the Spring, 1993 Day Division schedule. Prof. Bart Brown will be teaching International Human Rights on MWTh at 11:45 in the spring, not International Law.

The tentative time for Gift & Estate Tax on the Evening Division schedule should be 7:35 MW, not 6:00 p.m. It was listed correctly on the grid.

FROM THE REGISTRAR

If you have an outstanding balance you may not register for the Fall semester unless you have an approved "Petition for General Unpaid Tuition Policy Exemption."

Registration with a Tuition Balance

The final payment for the Spring, 1992 semester was due on Wednesday, April 1.

Except as set forth above, students will not be permitted to register if there is an outstanding tuition balance, including the payment due on April 1, 1992.

Please note the Registration Policy will not be waived in order to allow a student to meet a registration deadline. Therefore, we urge you to allow yourself sufficient time to complete the paperwork (it usually takes 1-2 days to process requests for approval).

Procedure for Registering with an Outstanding Tuition Balance. Students should complete the "Petition for General Unpaid Tuition Policy Exemption" form in order to be considered for registration with a past balance. Copies of the following verification information must be submitted along with the petition application:

1. Letter from the loan source (IIT Financial Aid Office, bank, etc. NOTE: A copy of the bank loan application\confirmation is required for GSL and SLS loans), and
2. Registrar's letter confirming the current outstanding tuition balance amount.

Petition forms may be picked up at the Registrar's Office, Suite 220, or the Administration and Finance Office, Suite 265. Please submit application forms to Dawn Rupcich, Assistant Dean of Administration and Finance, Suite 265.

A student will be allowed to register with an outstanding tuition balance only if he/she has been approved to receive:

1. A Guaranteed Student Loan (GSL).
2. Perkins Loan (NDSL).
3. Supplemental Loan for Students (formerly ALAS).
4. Law Access Loan, and/or
5. other institutional loan/s (bank, etc.)

Students will not be allowed permission to register for any reason other than those listed above.

June 1992 Graduating Seniors

Applications to take the Illinois State Bar Examination are now available in the Registrar's office, Suite 220. The Certificate of the Dean is automatically completed and sent to Springfield for all graduating seniors.

CHANGING DIVISIONS

The list of students who received permission to transfer divisions is posted on the second floor administrative bulletin board. These students should submit their Fall semester registration form to the Registrar to obtain a new Fall semester priority number.

First-year Evening students who received permission to transfer to the Day division must take Justice & the Legal System and Civil Procedure 1 and 2 in the Evening division during the 1992-93 academic year. These students should see Dean Chapman to plan the rest of their schedules.

There is a widespread misconception of the proper way to set up merge letters for the letters of recommendation that many of you are requesting from the professors. The following is the correct way:

The Honorable William Morse
Supreme Judicial Court of Maine
142 Federal Street
P.O. Box 368
Portland, Maine 04112-0368{END FIELD}
Judge Morse{END FIELD}
{END RECORD}

Notice there are only TWO END FIELD codes - at the end of the address and after the name for the salutation - and then an END RECORD. That is all that is needed.

Also, when setting up your list, please thoroughly proofread your document. There have been times where lists have included deceased judges, two different spellings of names or wrong addresses.

FACULTY NEWS

Professor Philip Hablutzel testified before the Legislative Committee of the Illinois State Bar Association on April 10 on Senate Bill 1429, which would create Limited Liability Companies in Illinois. Prof. Hablutzel represented the Illinois Secretary of State's Corporation Acts Advisory Committee which drafted and submitted the proposed Act to the Illinois General Assembly. He has been a member of the LLC Task

Force of that Committee for the past three years. Also on April 10, Prof. Hablutzel's short paper on the history of the drafting of the Illinois General Not-For-Profit Corporation Act of 1986 was presented at the mid-year meeting of the Business Law Section of the American Bar Association in Orlando, Florida. The paper was part of the materials for a two-hour program presented by the Model Nonprofit Corporation Subcommittee.

Professor Fred Abbott appeared on a panel with Judith Bello, former General Counsel of the U.S. Trade Representatives's office, at the Symposium on Legal Aspects of International Trade and Investment in the 1990s in Washington D.C. on April 1. He discussed the GATT dispute settlement mechanism now under consideration in the Uruguay Round multilateral trade negotiations.

Professor Lloyd Cohen presented his views on creating a market in transplantable organs before a panel of the National Kidney Foundation on April 9th. Professor Cohen gave a 15 minute interview on the same subject for BBC television.

Professor Randy Barnett did a radio show on the 9th Amendment with WBEZ Radio April 8th.

LEGAL WRITING TEACHING ASSISTANTS FOR 1992-93

Applications are now being accepted for Legal Writing Teaching Assistants for the year 1992-93. Only students who will be graduating in June, 1993 may apply. Teaching Assistants work closely with the Legal Writing Professors in preparing and grading assignments, and with students in drafting and revising their work. Applicants should have received superior grades in their Legal Writing courses and have a strong interest in helping other students to master the skills of legal research and writing. Membership on Law Review or Moot Court is desirable, but is not a requirement of the job. Teaching Assistants receive two hours of credit each semester and salary equal to the tuition for two credit hours each semester.

VIRUS ALERT!!

☛ Attention all students:

There has been a recent outbreak of the *Antitefonica* virus on the computers at Kent. This particular virus attacks the partition table of disks. So far, this virus has been removable from hard disks, but is practically incurable on floppy disks.

To protect your data from damage, I have instituted scanning of the hard drive of every computer in the student areas. This will cause you a slight delay when logging in. When logging out, the computer will do a much more thorough scan of the hard drive for viri. You do not have to sit at the computer during this process.

☛ Protect your home computer!

To insure that your home computer has not been infected, you should download the virus scanning software from Kentnet. To find this menu selection, choose "Kentnet Services" from the main menu, then choose "Virus Protection Software".

For Best Results: Use the menu selection for making a bootable disk to use on your home computer. You will need a blank disk for this purpose; any data on the disk you insert will be destroyed.

The disk that you use for virus scanning should be write protected as soon as you remove it from the computer.¹ At home, you will need to boot your computer with the diskette that you prepared at Kent. To do this, you should start with the power OFF. Insert the disk into drive A: of your computer, then turn the power on. Your computer should not produce the same menu or startup screen that you are accustomed to seeing, since it's reading startup information from the floppy disk instead of the hard drive inside your computer.

☛ Check your floppy disks!

Since re-infection of Kentnet computers can occur easily from virus-infected floppy disks, you should check all of your disks to determine whether or not they are carrying the *Antitefonica* virus. This menu choice is also under "Virus Protection Software" on the "Kentnet Services" menu. It will allow you to check multiple diskettes one after the other.

⊗ If your diskette has a virus:

Bring it to someone in the computer center immediately; we'll see if we can salvage your data from the diskette.

¹ WRITE-PROTECTING A DISKETTE: To write-protect a 3-1/2" diskette, just slide the plastic tab to the open position; this tab is in the lower right-hand corner of the diskette as you look at the BACK of the disk. To write-protect a 5-1/4" diskette, you need to place a write-protect tab over the cut-out area in the upper right-hand side of the disk. (Scotch tape works pretty well if you don't have a write-protect tab)
