# FROM DEAN MATASAR

One of the great joys, and great sorrows, of being the Dean is the semester-ending ritual of reading teaching evaluations of one's colleagues.

On the good news front: students continue to give very positive reviews of most of their courses and teachers. It is gratifying to read that nearly every faculty member is ranked by some student as "the best teacher I've had in law school." It is equally gratifying to find our faculty with average grades of A- (or at worst, B+).

On the bad news side, some courses did not go well last semester. Whether due to material that was not presented well or due to a teacher's or student's inadequacy, a few courses failed to provide meaningful stimulation. Rest assured that your concerns about classes are not invisible. I will speak with teachers in courses that are not succeeding. I will share your concerns with faculty members. Moreover, I encourage you to go directly to faculty members to share your concerns as well.

Faculty members must be prepared for class. They ought to be open-minded and fair. They ought to treat each student with respect. They ought to grade papers and exams promptly and be willing to discuss their evaluations with students. They ought to be willing to answer questions both in and out of class. Faculty members must not engage in discriminatory conduct and they should avoid relationships with students that take advantage of students or create appearances of impropriety.

The Association of American Law Schools, in its "Statement of Good Practices by Law Professors in the Discharge of Ethical and Professional Responsibilities" reinforces these last two duties:

Discriminatory conduct based on such factors as race, color, religion, national origin, sex, sexual orientation, disability or handicap, age, or political beliefs is unacceptable in the law school community. Law professors should seek to make the law school a hospitable community for all students and should be sensitive to the harmful consequences of professorial or student conduct or comments in classroom discussions or elsewhere that perpetuate stereotypes or prejudices involving such factors. Law professors should not sexually harass students and should not use their role or position to induce a student to enter into a sexual relationship, or to subject a student to a hostile academic environment based on any form of sexual harassment.

Sexual relations between a professor and a student who are not married to each other or who do not have a preexisting analogous relationship are inappropriate whenever the professor has a professional responsibility for the student in such matters as teaching a course or in otherwise

evaluating, supervising, or advising a student as part of a school program. Even when a professor has no professional responsibility for a student, the professor should be sensitive to the perceptions of other students that a student who has a sexual relationship with a professor may receive preferential treatment from the professor or the professor's colleagues. A professor who is closely related to a student by blood or marriage, or who has a preexisting analogous relationship with a student, normally should eschew roles involving a professional responsibility for the student.

I encourage our faculty to continue its good work and strive for even greater competence in the classroom. If anyone believes that a faculty member has not performed his or her duties at the highest level, share that assessment with the faculty member or one of the law school's deans.

# CBA Sponsors Large Firm Matching Program for Minorities: Deadline for Applications is February 3rd!

For the third year, the Chicago Bar Association is sponsoring a special project to provide large firm, summer associate opportunities for first-year Illinois law students who are members of groups, such as African American, Hispanic and Asian, that have been historically underrepresented in large law firms. The goal of this program is to expose students from traditionally underrepresented groups to the large law firm environment by participation in a law firm's summer program.

Chicago-Kent College of Law has accepted the CBA's invitation to participate in the program. Chicago-Kent will provide the CBA with the names of two to three students selected from the categories of groups described above 1) who are interested in being a first-year summer associate at a large firm and 2) whom the law school believes would benefit most from the experience.

The CBA will randomly match Chicago-Kent with a participating law firm. The firm will then interview the Chicago-Kent candidates and select a single student to take part in its Summer Program. The availability of a law school-law firm match will of course be dependent upon an adequate number of participating law firms. The hope is that there will be at least nine participating law firms so that each Illinois law school can be matched to a firm.

Any student wishing to be considered should submit a letter, addressed to Assistant Dean Judith Saunders, explaining why he or she is interested in serving as a summer associate at a large firm and providing any other information that would be useful in the application process. Applicants should attach a resume.

This application packet will be reviewed along with first-semester law school grades and other indicia of past performance. Your law school professors also will be contacted. Based on the available information, the law school will select the two to three candidates who show the most potential to excel in this program and refer those students to the CBA. The dean has appointed several faculty and staff members to act as the selection committee.

Applications should be submitted to Assistant Dean Saunders' office no later than 5:00 p.m., Wednesday, February 3, 1993.

## **New Illinois Compiled Statutes Partially Implemented**

As of January 1, 1993, Illinois officially has a new numbering system for statutes, known as the Illinois Compiled Statutes or ILCS. The Illinois Supreme Court has issued a rule providing, that until January 1, 1997, the Revised Statutes are allowed to be cited instead of or in addition to the Compiled Statutes. At the moment, only a few volumes of the new Smith-Hurd Illinois Compiled Statutes Annotated have been published; these are available in the library. A competing publisher's (Michie Company) set of annotated statutes is promised for the end of March 1993. Meanwhile, cross reference tables and a set of the unannotated compiled statutes are available. Students who need to supply ILCS parallel cites should seek assistance from the reference librarians.

# **AAUW Fellowships for Minority Women Law Students**

The American Association of University (AAUW) Educational Foundation makes fellowship awards to minority women historically underrepresented in law, medicine and business administration. This year they are extending the application deadline for the Selected Professions Fellowship Program to encourage applications from a greater number of eligible women. The new deadline is February 15, 1993, when all material must be in the AAUW Educational Foundation Office in Washington, D.C.

Fellowships range from \$5,000 - \$9,500 for one academic year; they are not renewable. Academic work during the fellowship year must be full-time. Fellowship funds may be used for dependent care if essential in facilitating the candidates's pursuit of her educational study or research. Approximately 20 - 25% of the Selected Professions Fellowship applicants have been funded annually.

There is a fairly lengthy application procedure that must be followed; the new deadline is February 15, 1993. If you would like additional information and a packet of materials, you can pick them up in the Office of Admissions and Financial Aid, Suite 230.

#### Dupage County Chapter of the Justinian Society of Lawyers Scholarship

The DuPage County Chapter of the Justinian Society of Lawyers is awarding a minimum of one \$1,000 scholarship to a law student who meets the following criteria:

- 1. Must have completed at least one semester of law school
- 2. Must be of Italian extraction
- 3. Must demonstrate academic achievement

FINANCIAL AID AND NEED-BASED SCHOLARSHIPS

The 1993-94 financial aid application forms are now available in the Office of Admissions and Financial Aid, Suite 230.

Once again, that time has arrived for you to begin the process of applying for financial aid for next year. Please take note of the calendar of important dates below; I suggest that you save this memo for later reference. Your financial aid, whether a loan and/or a need-based scholarship, depends on it.

We have prepared folders containing the applications, as well as information to assist you with the application process. Please be sure to read through the entire packet. There recently have been several changes to the financial aid application process, so those of you who have borrowed in the past will find some new forms and procedures this year. The application packets can be obtained in the Office of Admissions and Financial Aid (suite 230).

<u>Please note that the April 1st deadline occurs during spring break</u> (the dates of spring break are March 28 - April 4). If you plan to leave town, please be sure that you arrange to have your application materials in the Office of Admissions and Financial Aid by April 1st.

To be eligible for all forms of financial aid you must meet the deadlines listed below.

## Calendar of Important Dates:

#### By April 1

1. The Free Application for Federal Student Aid (FAFSA - this is a new form), as well as the FAF, if you are filing that as well, should be <u>received</u> by the College Scholarship Service (CSS) no later than April 1. A preaddressed envelope is enclosed with the FAFSA and FAF instruction booklets. Plan to mail it in sufficient time to meet the deadline.

- 2. Your Chicago-Kent College of Law Financial Aid Application should be received by the Chicago-Kent College of Law Office of Admissions and Financial Aid no later than April 1. The Office is located in Suite 230.
- 3. Financial Aid Transcripts must be sent to all previously attended colleges or universities by April 1, if this is the first time you are applying for financial aid at Chicago-Kent.

#### By May 15

- 1. After you file your FAFSA, you will be sent a Student Aid Report (SAR) by the College Scholarship Service (CSS). All pages of your Student Aid Report should be in your financial aid file at Chicago-Kent College of Law by May 15, even though it will say that you are not eligible to receive a Pell Grant (Pell Grants are for undergraduates only). If you need to make corrections to your SAR, be sure to send a photocopy of the SAR, with all corrections indicated, to the Office of Admissions and Financial Aid at Chicago-Kent. Send the original to the address indicated on the back of the SAR. A revised SAR will be mailed to you approximately 2 weeks after the corrections are received at the processor. Make sure that you sign the report where indicated.
- 2. If you are selected for Verification, you will be asked to submit copies of your tax forms and a Verification Worksheet. These materials and your SAR must be returned before a financial aid award will be determined for you.

#### By July 1

- 1. You are expected to turn in student loan applications from the lender of your choice by July 1. If you are unsure of a lender, contact the Office of Admissions and Financial Aid at (312) 906-5180. Loan applications for the Law Access program will be available in the Office of Admissions and Financial Aid, Suite 230. You can also obtain a Law Access loan application by calling Law Access directly at (800) 282-1550.
- 2. You should sign and return your financial aid award letter to the Office of Admissions and Financial Aid by June 1, or within three weeks if received after June 1.
