

### CARDENAS BATTERED

Monitor Terror and Gunboat Machias Silenced Forts at Cardenas--Ships Not Damaged.

### INVASION OF CUBA NEXT

Spanish Fleet Sailed from Cape Verde Islands Today--French and German Consuls Protest Against Bombardment of Matanzas.

New York, April 29.—A dispatch to a Wall Street news agency says that the monitor Terror and gunboat Machias has bombarded Cardenas, killing many Spaniards, but after an hour's firing the batteries of the enemy were silenced. An Evening Post special from Key West says: "Reports from the blockading fleet this morning were to the effect that the bombardment of Matanzas on Monday was followed yesterday by the bombardment of Cardenas, east of Matanzas, on the north coast of Cuba. At that station were the monitor Terror and gunboat Machias. A shot from shore batteries provoked them to fire back. For two hours Cardenas withstood the bombardment, then the ancient guns which did no damage to the ships suddenly grew silent."

**Will Hunt the Spanish.**  
New York, April 29.—A special to the Journal from Washington says: "The board strategic recommends that as soon as it becomes apparent that the Spanish fleet does not intend to cross the Atlantic, that the Canary Islands in the Atlantic and one of the Balearic Islands in the Mediterranean, probably Minorca, be seized by the United States as bases of supplies. If the Spanish fleet does not come to us the board has decided that, to end the war, the United States ships must attack Spain at home."

**Will Be Shot for Treason.**  
A Key West special says: A sailor on the monitor Puritan has been convicted of treason. He is a Spaniard. He was caught filing the lock to the magazine, found guilty by a drum's head court martial and sentenced to be shot.

**Small Favors Thankfully Received.**  
Key West, April 29.—A small Spanish ship, Engracia, was captured by the United States gunboat Newport, off Cardenas yesterday and was brought here this morning.

**Marines in Key West.**  
The troop ship Panther arrived here this morning from Hampton Roads with 800 marines, conveyed by the Montgomery.

**Searching for Coal Schooners.**  
The battleship Indiana has gone to search for the two coal schooners that are 14 days overdue here.

**Invasion of Cuba Contemplated.**  
Chattanooga, Tenn., April 29.—The entire eight batteries of artillery, besides the Twenty-fourth Infantry and four companies of the Ninth Cavalry, break camp today under orders to proceed to Tampa, Fla., at once. Although no intimation of the ultimate destination of the troops has been given out here, there is no doubt in the minds of the officers that the immediate invasion of Cuba, or at least the capture and occupation of some Cuban seaport, is in contemplation. In order to open a line of communication with the Cuban forces and to act in co-operation with those forces in the immediate relief of the starving reconcentrados, and in driving the Spanish forces from the island.

**First Regiment Marching.**  
New Orleans, La., April 29.—The First Regiment hardly got its tents in position here when it was ordered to proceed to Florida immediately, whence it will be sent to Cuba.

**Tenth and Twelfth Regiments Go to Tampa.**  
Mobile, Ala., April 29.—The Tenth and Twelfth regiments of Infantry will break camp at 5 o'clock today and leave at 7 p. m. for Tampa.

**Preparations at Chattanooga.**  
Chattanooga, April 29.—Quiet preparation is being made for the shipment out of the Second Cavalry as well as the Ninth.

**Want to be on the Safe Side.**  
Hong Kong, April 29.—A steamer chartered by the banks here has gone to Manila to bring away the specie there.

**Refugees From Cuba.**  
Kingston, Jamaica, April 29.—Over 400 German and British, Cuban and American refugees arrived at this port this morning from Santiago de Cuba.

**Spanish Fleet Sails at Last.**  
St. Vincent, Cape Verde, April 29.—The Spanish fleet sailed this morning in a southerly direction.

**French Neutral.**  
Lisbon, April 29.—A neutrality decree was published today. It forbids the equipment of privateers in Portuguese waters.

**Spanish Fleet Has Sailed.**  
St. Vincent, Cape Verde, April 29.—The Spanish fleet sailed in a southerly direction at 8:30 o'clock this morning. A dispatch from St. Vincent says that four Spanish cruisers and three torpedo boat destroyers are presumed to have gone toward Cuba.

**Spanish Vessels Collided.**  
St. Vincent, Cape Verde Islands, 7 p. m.—There has been a collision among the vessels in the Spanish fleet and some have returned here.

**Spanish Anasias Reports.**  
Madrid, April 29.—The official announcement says that the fortifications of Matanzas did not suffer by the bombardment of the American ships and not one man was killed or wounded. The Imparcial says one mule was killed.

**Another Madrid Rumor.**  
Rumors are current here again that Russia and Germany will assist Spain. All is quiet here. The newspapers belittle the work of the American fleet at Matanzas.

**More Fakes.**  
The United States fleet is not expected to reach Manila until Sunday. The Spanish fleet is divided in two and has been re-enforced by a large auxiliary cruiser.

**French and German Consuls Protest.**  
Captain General Blanco, in his report of the Matanzas bombardment, says that the French and German consuls here have entered protests, on the ground that no previous notice of an attack was given.

**France Preparing for a Fight.**  
Paris, April 29.—It is announced that extraordinary naval and military prepara-

tions are displayed throughout France. All ships recently mobilized are kept in fighting trim. Reserves expect to be called out.

**Afraid of Ciphers.**  
Manilla, April 29.—The Philippines government has forbidden the use of cipher dispatches.

**Prices Advancing.**  
London, April 29.—Lead and sugars are advancing rapidly owing to the war.

### STOCK NOTES.

Droughts in New South Wales have decimated the stock there.

Sheep are given the preference by stock raisers in San Miguel county. The lambing season is on at Lake Arthur where the Jaffa-Prager-Miller sheep are herded.

John Stone of Chaves county, has finished lambing 1,000 ewes on alfalfa and reports 100 per cent increase.

Charles Russell, manager of the Orendonk ranch, near Lamy, will move his family to the ranch next month.

Chaves county stockmen will feed their own lambs this year. Last season 9,000 head were shipped from that county.

The Kansas and Colorado sanitary boards have approved of the sanitary inspection of cattle and the new law is now in force.

C. W. Haynes has moved 300 head of cattle from the Capitan Orchard company's inclosure near Roswell to his pastures on the Rio Honda.

Frank Grest has purchased 25 head of Hereford bulls, at Colvater, Kan. They will be used to improve his range cattle on the Blue Water ranch, in Dona Ana county.

The Maxwell Land Grant company has purchased 30,000 head of cattle from southern New Mexico and Arizona points and placed them on their Colfax county range.

Cattle buyers are requesting an extension of time on contracted April deliveries, because banks refuse to advance money on account of the war with Spain.

P. J. Towner, territorial cattle inspector, has inspected 24,961 head of cattle that passed over the Santa Fe road eastbound during the past month. Of the number, 15,369 were inspected during last week.

About 125,000 feeding lambs and weathers will be shipped to Colorado and Kansas feeding points from Clayton this year. A great number of them will be drifted across the country from southern New Mexico and Texas.

R. F. Barnett has purchased 140 thoroughbred mares, with young colts, 30 yearlings, 30 yearling mules, 2 imported Cleveland bay stallions, 3 thoroughbred jacks and a jenny of the American Pastoral company of Amarilla. The stock will be delivered to his Chaves county ranch, May 15.

Farmers and stockmen in the territory are sowing a vast amount of alfalfa this year and it is estimated that the yield will be fully three times as much as last year. This means that a greatly increased number of sheep and lambs will be fed in New Mexico for the market instead of sending them to Colorado and Kansas. It is only a matter of time before the cost of feeding elsewhere will be done away with and New Mexico will produce a profusion of feed for the stock in the territory.

An exchange says of horse breeding: "Every day the reports from centers of horse breeding and horse dealing show that the demand for good horses is out of all proportion to the supply. The several classes that are wanted are bringing readily such prices as are satisfactory to the producer. But more than ever before, the active demand is for certain well defined types. Common scrub horses are just as worthless now as ever and it is simply a foolish waste of grass to raise them at all. The country would be better off if canneries could be started to use up all of them and sell them to any of the foreign people who have no prejudice against horse meat."

### WASHINGTON NEWS

Democrats Opposed the Issue of Coin Bonds--Wanted Silver Seigniorage Coined Instead.

### ALL AMENDMENTS DEFEATED

House Military Affairs Committee Decides to Increase Number of Volunteers at Large--Admiral Sampson's Laconic Report of Bombardment.

Washington, April 29.—In the house Mr. Bland (Dem. Mo.) discussed the bond feature of the revenue bill. The Democrats, he said could never agree to issue any more "coin" bonds, which would be construed under a Republican administration to mean nothing but gold. He argued the advisability of the immediate coinage of the silver seigniorage.

During the afternoon the debate on the war revenue bill was continued. Mr. McMillin offered an amendment to strike out the bond provision and insert an income tax provision. Mr. Walker (Mass.) offered an amendment to make the bonds redeemable after one year and payable after three years. It was defeated.

**All Amendments Defeated.**  
All amendments offered by the silver men to the bond provision of the war revenue bill were defeated. Mr. McMillin's amendment to substitute an income tax for the bond section was defeated by a vote of 123 to 143.

The war revenue bill passed the house, the vote standing 181 to 129.

**Adjourned Until Monday.**  
The senate today adopted the conference report on the naval appropriation bill and then adjourned till Monday.

**Causes of Democratic Seniors.**  
Democratic seniors caucused this afternoon to decide upon the course to be pursued regarding the war revenue bill, especially with reference to the bond provision.

**Number of Volunteers Increased.**  
The house military affairs committee has agreed to increase the number of volunteers to be raised from the United States at large from 3,000 to 13,000. This will allow the enlistment of 10,000 yellow fever immunees.

**General Deficiency Bill.**  
Secretary Alger has submitted deficiency estimates of \$34,000,000 to cover the additional army expenses to July 1, and that amount will be included in the general deficiency bill.

**Admiral Sampson's Brief Report.**  
Secretary Long has received a brief dispatch from Admiral Sampson reporting the firing on Matanzas. The admiral says a few shots were thrown at the defenses, but gives no details.

**Cuba Will Be Invaded.**  
The United States troops are hurrying from all points to Tampa today, preparatory to invading Cuba. They will probably leave Tampa on Sunday for Matanzas.

**Train Robbed in Texas.**  
San Antonio, Texas, April 29.—The east bound mail train on the Southern Pacific was stopped by six masked highwaymen last night at Comstock, 200 miles west of San Antonio, and the mail and express cars were blown open with dynamite. Nobody injured.

### SANTA FE LAND TITLES.

Attorneys of the City Should Prepare Bill for Introduction in Congress--Delegate Ferguson's Letter on Subject.

The rejection of the land grant upon which the city of Santa Fe is located, by the United States Supreme court leaving unsettled titles to real estate in the city, efforts have been and are being made to secure legislation in congress which will quiet all titles to tracts of land and lots on the land formerly supposed to be within the Santa Fe land grant. At the meeting of the board of county commissioners of Santa Fe county held April 12, a resolution was passed requesting Delegate Ferguson to introduce a bill for that purpose in the house. A copy of the resolution was sent Mr. Ferguson by County Clerk Romero, to which the following reply has been received:

Mr. Atanacio Romero, Santa Fe, N. M.

Washington, D. C., April 19, 1898.  
My dear Sir—I have received your favor of April 12th inclosing the resolutions of the board of county commissioners of the county of Santa Fe. I am well aware that legislation by congress is necessary to properly settle the titles to real estate in the city of Santa Fe, and I have been not only ready, but quite anxious to press that matter to a conclusion in congress. For two reasons, however, I have not yet introduced the bill. The first is, that it was thought advisable to wait until all the grants as claimed, which seemed to affect the titles, should be passed on by the land court. Lately that has been practically done, as I was informed by Mr. Reynolds here in Washington. By the second reason why I have not introduced the bill is this: That Mr. Spies and Mr. Gildersleeve both promised to prepare a bill which would be in the opinion of the lawyers of Santa Fe, both acceptable to all the people of Santa Fe, and also one that would most certainly accomplish the purpose and fully protect the titles. These gentlemen have not yet sent me a draft of such bill. I relied on it that they would send me a bill, and therefore have not myself made the exhaustive study that would enable me, unaided, to prepare a bill such as would protect the titles. You and the board can see the advantage of having such bill prepared by Santa Fe lawyers, who, presumably, know all the technical points to be guarded.

I assure you, and through you also, the board of county commissioners, of my profound respect and appreciation, and of my anxiety as well as readiness to render any service in my power either to the city of Santa Fe or to the county of Santa Fe, whose interests they are elected to guard.
