THE ELECTIONS.

A List of the Candidates from Various States Balloted for To-day—Many Tickets in the Field.

NEW YORK, Nov. 8.—The elections to-day are for 111 presidential electors. All will be chosen by the several states at large except in Michigan, where two will be chosen by the state at large and ten by congressional districts. There will also be elected the national house of representatives, except in Oregon, where this election has taken place, and state legislatures, which will choose twenty-two United States senators, one senator having already been elected in Rhode Island and one in Vermont. The national tickets represented are the Republican, the Democratic, the People's party, the Prohibition party and the Socialist Labor party. In New York city, city and county officers are being elected.

NEW JERSEY.—Four candidates for governor are being voted upon to-day and eight congressional candidates for each party. The candidates for governor are: Republican, John Kean, Jr.; Democrat, George T. Wetzel; People's, B. J. Bird; Prohibition, T. J. Keeney.

THE ELECTION IN NEW HAMPSHIRE.—The interest in the election is the most intense of years, as New Hampshire is now regarded as a pivotal state. J. B. Smith, R.; L. F. McKimsey, D.; William O. Hayes, Peop.; Edgar L. Carr, Pro., are the gubernatorial candidates. The candidates for congress are: First district, Henry W. Blair, R.; Chas. F. Stone, D.; second district, Henry N. Baker, R.; H. W. Parker, D.

MISSOURI CANDIDATES.—The citizens of this state are to-day voting for electors for governor, lieutenant governor, secretary of state and fifteen congressmen. The gubernatorial candidates are: William Warner, R.; William J. Stone, D.; J. Sobeski, Pro., L. Leonard, Peop. For lieutenant governor: Ralph Mueller, R.; J. B. O'Mara, D.; W. S. Crouch, Pro.; G. W. Williams, Peop. For secretary of state: H. T. Akhre, R.; A. L. Lonsou, D.; E. E. McClelland, Pro.; David B. Page, Peop. The legislature to be chosen to-day will elect the successor to United States Senator Cockrell, D.

PENNSYLVANIA WILL CHOOSE CONGRESSMEN.—Philadelphia, Pa.—Pennsylvania is electing a legislature, which will choose Senator Quay's successor, and thirty congressmen. All four parties have electoral tickets in the field.

ELECTION IN SOUTH CAROLINA.—Columbia, S. C.—In this state there is practically no opposition to the Democratic ticket headed by T. R. Tillman for governor.

QUIET IN RHODE ISLAND.—Providence, R. I.—Melville, R., and O. Lapham, D., are the congressional candidates in the 1st and 2d districts. In the 2d, all four parties have electoral tickets in the field.

IOWA'S VOTE.—Des Moines, Iowa.—Iowa to-day votes for electors for secretary of state and eleven congressmen. The candidates for congress are: First, J. H. Gear, R.; J. J. Searley, D.; 2d, G. THE ARKANSAS ELECTION.—Little Rock, Ark.—Arkansas votes for electors and for six congressmen. All four parties have electoral tickets in the field.

ALABAMA'S ELECTION.—Montgomery, Ala.—Alabama has only Democratic and People's party electors in the field. It votes for nine congressmen.

WHERE ROGER Q. MILLS VOTES.—Austin, Texas.—Texas elects governor and state officers and thirteen representatives in congress. For governor, Andrew J. Houston, R.; James S. Hogg, D.; George Clark, bolting D.; D. W. Pendegast, Pro.; T. L. Nugent, Peop. Four electoral tickets are in the field.

FOR ELECTORS AND CONGRESSMEN.—New Orleans, Louisiana.—Louisiana will elect six representatives in congress. Four electoral tickets are in the field.

MARYLAND'S CONTEST.—Baltimore, Md.—Maryland elects six representatives in congress and a legislature to choose a United States senator, vice Hinton, appointed pro tem.

IN WATERBURY'S STATE.—Louisville, Ky.—Kentucky elects elector representatives in congress. Four electoral tickets are in the field.

MAJOR VOTES HERE.—Richmond, Va.—Virginia elects ten representatives in congress. The legislature will elect United States senator, vice Hinton, appointed pro tem.

INDIANA'S ELECTION.—Indianapolis.—Indiana to-day votes for federal electors, governor, state officers, thirteen congressmen and a legislature to choose a successor to Senator Turpie, D. The candidates for governor are: Ira J. Chase, R.; Claude Matthews, D.; A. Worth, Pro.; Larry Templeton, Peop. For lieutenant governor: Theodore Shookery, R.; Mortimer Nye, D.; C. W. Culbertson, Pro.; T. S. East, Peop. For secretary of state: Aaron Jones, R.; W. R. Myers, D.; J. McCormick, Pro.; J. L. Hobson, Peop.

Had Mrs. Bartlett not been placed where resignation was the only refuge from disaster, Bernillo and Valencia county would have united in a special and general display that would have brought those two counties into the prominence they deserve. As it is, we are at the mercy of an apathetic, money-grubbing, impulsive board that deserve the unqualified condemnation of every reputable citizen in the territory. -Albuquerque Times.

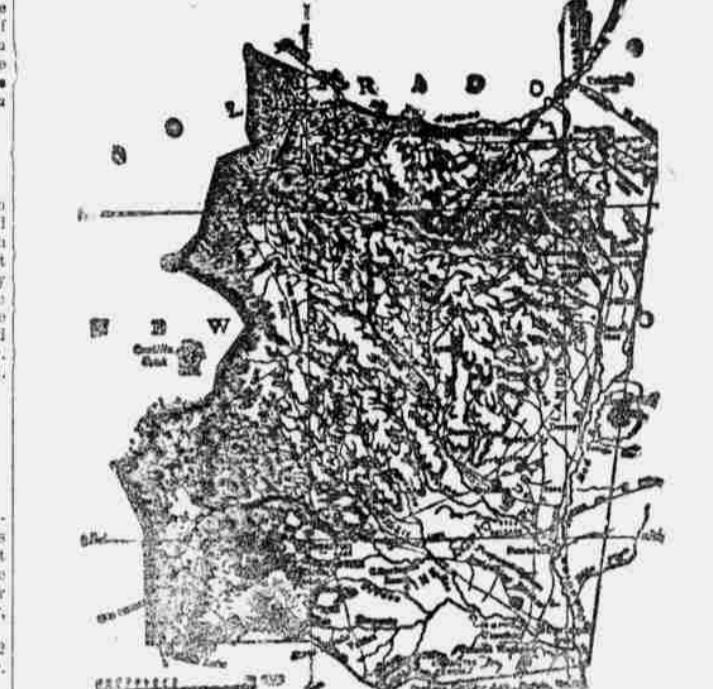
