FRANK'S DEFENCE.

An Exciting Day in the Missouri Attempt to Defeat Justice.

Gen. Jo. Shelby, Sir, Gets Drunk and Makes a Scene in the Court Room.

Frank, His Mother, and His Sisters and His Cousins and His Aunts.

All Testify That He Was Everywhere Else but at the Winston Robbery.

The James Trial.

GALLATIEN, August 31.—In the Frank James trial the defence continued their line of impeaching the state's witnesses. James Demasters, a justice of the peace, testified that at the corner's inquest on the body of Wood Hite Mrs. Bolton testified that she had not seen Frank James for two years and that at her father's house.

GEN. SHELBY'S RACKET.

Col. Phillips then arose and stated that General Shelby desired to make a statement to the court. When the general came in he saluted the court with courteous bow and said: "Anything that I may have said or done yesterday may have offended the dignity of the court; I regret it exceedingly; as to other parties I have no regrets."

Judge Goodman replied: "General Shelby, your conduct yesterday in appearing before the court in an unfit condition, and showing an insubordinate spirit, was reprehensible in the extreme, as it was not only in defiance of the dignity of the court, but calculated to prejudice the interests of the defendant. As you are a man of national reputation and enjoy the respect and confidence of a large number of the people of Missouri, I can only say that I was much astonished at your very reprehensible action yesterday. It is in testimony that you have drawn a pistol, right in the verge of the court, which is in itself contempt of court."

General Shelby, answering: "That, sir, is false." The court—"The marshal of Lexington testified to it under oath." General Shelby—"Then he lied."

The court—"The court is amply satisfied with your apology to it, but your attitude towards the attorneys for the state yesterday, in answering in a threatening and offensive manner and talking of calling them to personal account can not be overlooked."

The court then fined Gen. Shelby \$30, which he paid and passed out of the court room.

J. C. Mason, Annis Duval, W. D. Rice and James Duval all impeached the testimony of the friends and relatives, testifying they had heard them say they had not seen Frank James for years, and that he had gone south with John F. Samuels, a half brother of Frank James, testified that in May, 1881, he saw Jesse James with Dick Liddell at his mother's house; heard Jesse and Dick Liddell both say they had left Frank in Kentucky; there was striking family resemblance between Wood Hite and Frank James. On August 31, Frank James was at his house with his sister. He found him there on his return from a trip to Texas. He next saw him yesterday in jail. Witness was rigidly cross examined. He did not make a good witness. Recross.

THE MOTHER OF THE GANG.

Mrs. Zerella Samsel, mother of the James boys, testified she had lived in Clay county, Missouri, near Kearney, four years. The defendant is 41 years old. As to Jesse's death she showed much feeling and answered in a sobbing voice, "Jesse was at my house in May, 1881, accompanied by Dick Liddell. I asked Jesse where Frank was. He told me he had left him in Kentucky. I commenced crying and said, 'Son, you know he is dead, and you might as well tell me.' He said, 'No, he is alive and in Kentucky,' and then Dick Liddell spoke up and said, 'I know something. Jesse was in and out of the house with Dick Liddell and the Hites until the Winston robbery. The last time I saw them there on the farm I met him at Independence seven years ago this fall, when Sheriff Brown came to my house and shot at him.' Cross-examined, she said she did not see Frank during the summer of 1881, thought him dead. Witness recalled the departure of a wagon in August, and admitted she had furnished a bonnet and apron to the outfit.

"Why did you do that?" asked Prosecuting Attorney Wallace.

"Because they wanted to pass one of the gentlemen off for a lady, so you folks could not catch them by the scolding reply, given with muchunction."

Mrs. Susan Palmer, a sister of Frank testified that in 1881 she resided in Clay county, that her brother spent three months of the summer at her house. A rigid cross examination failed to shake the witness' testimony.

After a recess of fifteen minutes the defendant took the witness stand.

FRANK JAMES' TESTIMONY.

He showed no trepidation, but looking the jury squarely in the face, gave in a clear, distinct voice his testimony, which was substantially as follows:

"I am the defendant in this case; in the winter of 1876 I went from Missouri to Tennessee; came to Nashville in July, 1877; I rented a farm near the White creek neighborhood; in 1880 was logging for the Indiana company; it was hard work, and my health becoming impaired, I moved into Nashville to go into other business. First met Jesse there after I went to Nashville. It was in a store. He stepped up and spoke, but we called no names. He said he was living in Hampden county, Tennessee, and buying grain. I saw Bill Ryan in 1879; did not see Dick Liddell, Ryan and Jesse together very often. I left Nashville first to look for a livelihood for my family; secondly to get away from these parties. We went to George Hite's, a relative in Kentucky. Regarding the officers' appearance near Hite's, three men approached and Jesse said, 'They are after us.' I said, 'No, they can't be after us.' Then Dick Liddell said, 'Jesse and I borrowed a couple of horses at Nashville, and they are after us.' The officers passed and didn't come back. Wood Hite followed them a short distance. It was said there was a strong resemblance between Wood Hite and myself. We went from Hite to Logan county, Kentucky, and Jesse and Dick went away. I don't know where. No arrangement was made between them and me to rob the express

FATAL ACCIDENT AT RATON.

Eddie Curran Shoots and Kills Himself.

RATON, N. M., August 31.—Eddie Curran, a fourteen year old son of James Curran, of this place, formerly employed in the railroad shops here, made with a horrible accident this morning, which resulted in his death. He was at work on a ranch on the Sugarite, five miles east of town, and last night borrowed a shotgun, which he loaded and took to his sleeping apartment. This morning while his companions were out feeding the cattle they heard the report of a gun, and on going to the house found Eddie breathing his last with the gun close by and a frightful wound in his head. It is supposed that he was examining the gun, and in some way it was discharged with the above result.

Texas Fever in Michigan.

DETROIT, August 31.—Texas cattle fever has broken out in the herd of a milkman in the western part of the city. The whole herd of twelve is infected and several are already dead. A herd of forty steers brought in by a Genesee county farmer for feeding, some two weeks ago, has also been attacked by the disease and a few have died already.

Can't Pay in Orders on Themselves.

ALEXANDRIA, La., August 31.—Suits have been brought against the Bethlehem company by a large number of former employees to recover amounts deducted from their wages at the end of each month in payment of bills incurred by the company's store. Railroad Accident.

RAVENNA, O., August 31.—Today a defective switch threw off the rear truck of a passenger of the Cleveland & Pittsburgh express. The coach was dragged some distance, scattering the sides of several cars of local freight on the side track, and killing John Kerabagh, of Home-orth. A freight brakeman standing on the platform, and the passenger, were escaped with a severe slaking up.

A New Deal in Passenger Immigration.

ATLANTA, August 31.—Two assisted pauper Irish immigrants were sent back to Canada today. They stated that 1,100 others came over in the same ship, all expenses paid by the British government. The plan is to ship them to Canada, and from there to the United States at different points. A large number have been sent back to this country recently.

No D. & R. G. President Yet.

NEW YORK, August 31.—Nothing was done at the directors' meeting of the D. & R. G. Railroad Company today. The regular monthly meeting will be held Monday next, when some action in the matter of the presidency will be taken.

Steamship Missing.

MOYRA, August 31.—The steamship Ludwig is sixty days out from Antwerp, and her owners have abandoned all hope of her safety. There were seventy on board, twenty-four of whom were passengers.

Opposed to Art.

WEST POINT, Miss., August 31.—John Simons, a small farmer living ten miles from West Point, was shot dead by a traveling photographer, who had pitched his tent near Simons' house.

Gen. J. A. Eakin, colonel and assistant quartermaster general, stationed at Louisville, was placed on the retired list yesterday. He will be succeeded by Col. Rufus Saxton.

The operators who returned to work for the Rapid telegraph company at Boston did so at an increase of seven per cent, and have been reduced to the amount paid before the strike.

At Bloomington, Ill., last night seven Norman horses, recently imported, were smothered in a burning barn. Loss \$30,000.

The ball and supper given to the officers of the United States frigate Vandallia, at Montreal, by the citizens last night, was one of the most brilliant entertainments ever witnessed in that city.

General Brien Rider, of St. Louis, who killed O'Brien at Hot Springs, Arkansas, was shot dead yesterday at Benton, where the case was taken on a change of venue.

The court martial for the trial of the cadet charged with having beaten yesterday at Annapolis. The first cadet tried was Trappell. He pleaded guilty. S. B. Winson was next called. He pleaded not guilty and witnesses were then examined.

NEW YORK, August 31.—Governments steady. Railroads firm. Stocks were flat, at least by the pretty wide fluctuations in Louisville & Nashville and Northern Pacific, but on the whole the advance established yesterday of 1/2 to 2 per cent on the general list was more than maintained, and about 11:30 prices were 1/2 per cent above the closing figures of last night, though this advance was lost at 12 o'clock and partly regained again before 12:30. In the last half hour the market was strong throughout and many of the stocks made the highest price of the day. The general advance of the day over last evening's figures was 1/2 to 2 per cent. Sales 366,000 shares.

His friends are busy attempting to swear Frank James out of the Winston robbery. If necessary they will testify that no such man was ever born.

The county commissioners meet Monday to consider the court house subject in all its bearings. The question which now agitates an interested community is, "What shall the verdict be?"

Well posted politicians are declaring that in the coming election in Maryland the republicans will secure a majority in both branches of the legislature and elect a United States senator. If that should occur no other political phenomena need excite special wonder or surprise.

The management of the Pacific Express have decided to make Albuquerque the point at which supper will be taken in future, and the Journal entuses over this fact to the extent of a column, and declares "the benefit to be gained by making this an eating station is incalculable." The statement is true. It is "incalculable," being so infinitesimal as to defy the ingenuity of an expert to figure it out. The outlook in Albuquerque must be blue when as small a matter as this is magnified into a sensation.

Gen'l. J. O. SHELBY got drunk and made a show of himself by insulting the judge and threatening the attorneys at the Frank James trial, yesterday. He apologized to the judge and paid \$10 for the satisfaction he experienced in playing the blackguard toward the lawyers. A mild course of jail, would have been a more adequate punishment for the offense. Any where else except Missouri, this would have been imposed even on the great general. In that court however, dignity appears to be at a discount. The wonder is the judge did not compel the lawyers to apologize to the general.

For curiosity or in the interest of science or art, the body of Shakespeare is to be exhumed in order to ascertain whether the skull agrees in conformation with the bust and pictures of the poet now in vogue, and which have been accepted as correct. The desecration should not be permitted. The orthodox officers are good enough for the millions of his admirers, even if they do not exactly decontaminated the wondrous brain. No physical discovery can add to or detract from the priceless legacy he bequeathed us in his works. Let us continue to feast on them, remembering the features of the author we have always known, and let the honored bones rest.

PARNELL intimates that at early day he will make another draft on Irish-American generosity for funds. Simultaneously with this John Devoy, editor of the Irish Nation, charges O'Donovan Rossa, who handled most of the immense skimming fund, with being a traitor, and the chances are he can prove it if he tries. To his credit, be it said, there is no limit to the liberality of an Irishman, where his country or countrymen are concerned, but there should by this time be a limit to his credulity. The thieves, traitors and informers who have so long been masquerading as patriots should be retired to the rear and honest men sent to the front. Until this is done the pockets of every workman and woman should be closed.

The annual return of Hon. Trinidad Alarid showing the assessments in the several counties of New Mexico for the year 1883 is approaching completion. When fully prepared and published it will no doubt prove an interesting document, and show that the territory is making satisfactory material progress. Until however it is correctly made public the auditor will do well to notify the people that he is not responsible for the incongruous and stupid mass of figures made public in the New Mexican Review and credited to him. He should see that sheet for libel, club the editor, hire at his own expense a ten year old school boy to revise the tables, or resign. For an unsolvable riddle it takes the cake.

GOVERNOR TABOR of Colorado seems to be public property in that state, and the people and press of Denver are attending to the private business of the millionaire with an assiduity that is remarkable. He cannot discharge an employe, buy a carriage or hire a servant, but what his action is commented on, and generally condemned. Tabor may not be a saint, but the benefits he has conferred on Denver should protect him from the contemptible assaults now being showered upon him. Ordinary decency and common gratitude seem to be forgotten by his self elected critics, and it will not be surprising if they, at an early day, insist on dictating his bill of fare, and regulating the cut of his clothes. The practice

is disgusting, but it is sure Mr. Tabor can stand it, in the long run, if the proprietors of the journals can. The private life and acts of citizens have no place in the public prints, and because a man owns a newspaper it does not give him a license to open up the skeletons in the closets of his neighbors. The time may come when the present conductors of the journals will retire and they will hardly care to have some of their sins exposed, for each one of them is vulnerable. People who live in glass houses should not throw stones.

THE COURT HOUSE MATTER.

The discussion of the court house question has become general, and it is probable that at the citizens' meeting this evening the varied preferences of the people will be expressed. The subject is a very important one, and there need be no fear of losing anything in the end by spending time in the careful consideration of every feature which is presented. It is for the county commissioners first to learn how much our taxpayers are willing to invest in the much needed improvement, then to use their best judgment, aided by those who have special knowledge in architecture, to adopt such plans as promise to give us the most in beauty and utility for the least money. Of far greater consequence, however, is the question of selecting the best location for this public building, and in this matter there has already been exhibited some very decided and widely different opinions. We are inclined to believe that with many a choice has been made with only the Las Vegas of today in the mind's eye, and unless we can look further into the future than next year or the year after we will never be able to obtain harmonious action. It is for the metropolis of New Mexico, (which is as it should be the county seat) that we wish to build a really beautiful and substantial court house; and, with a firm faith that here will be a great city, which shall flourish as Denver has, all should be willing to lay aside every thought of direct and immediate personal benefit.

Our people's opinions are briefly expressed in the desire to obtain a site which is both central and prominent. Remembering however, that with the growth which is sure to continue, our city limits will be constantly spreading, we cannot predict with any degree of assurance which way they will spread most rapidly, and hence the center of the Las Vegas of the future is an unknown point. It is generally believed today that the city will grow towards the Hot Springs, therefore there is little danger of getting out of the city by selecting a site two or three blocks north of the bridge. The perplexing question is then reduced to finding a point neither too far east nor too far west, that will be acceptable to citizens on both sides of the river. Un- fishy deliberation is needed in this matter, and we have confidence that the generous and progressive spirit of Las Vegas will speedily overcome the difficulties already presented. A long time ago by unanimous consent the names of East Las Vegas and West Las Vegas were stricken out of our parlance, and it will be well for us to be vigilant in keeping them in exile at this time. The meeting this evening will be attended by leading citizens who can if they will inaugurate a policy and adopt pacific measures that will, we believe, satisfy every public-spirited taxpayer.

HAMILTON NOTES.

M. has been visiting friends at Hamilton for a few days. "Mont" will be as large as Daniel Lambert, of England, if he tarries long in this healthful country. "Uncle Sam" Buchanan has recently moved his large family here. Miss More, of Missouri, is visiting her sister, Mrs. M. A. Case. McKee & Pierce brought in their first herd of cattle last week. Mr. Biting and family, of Wichita, Kansas, are recent arrivals. Mr. B. is a successful merchant of Kansas who is here rusticiating among the "Rockies."

A STAND OFF.

The examination of the political record of the two parties on the railway grant question would involve an analysis of the votes of both houses of congress upon an average of probably a dozen different votes taken upon the passage of each act actually granting lands, and in addition an analysis of the numerous votes in both houses upon the several hundred (or perhaps thousand) other bills calling for land grants which were defeated and never passed. It is due to both parties to say that the record is very mixed, both parties voting for and against various bills with little reference to party lines.

BATAVIA, August 31.—The captain of a steamer which was in the straits of Sunda during the recent volcanic eruption reports that ashes fell on the deck of his vessel to the depth of eighteen inches. He passed masses of floating pumice stone. It is estimated that 1,000 persons lost their lives at Tyrang.

ST. LOUIS, August 31.—Mark Marsden, a bad character of Jefferson county, while riding along the road near Antonia yesterday, accompanied by Allen Hensley, was fired at by an ambush and instantly killed and Hensley mortally wounded.

PESH, August 31.—Tewesa, president of the Hungarian council, in order to put a stop to the outrages upon the Jews, has decided upon severe measures, which are to be put into operation wherever anti-Jewish riots occur.

London, August 30.

The vicar of Stratford-upon-Avon has signified his willingness to allow the remains of Shakespeare to be exhumed. The object is to compare the skull of the poet with the bust and portraits of him.
