FROM THE CONFERENCE CONVENOR Kristen L. Metzger

Our theme for the '83 conference is purposely ambiguous in order to encompass a wide range of subjects. We hope that there will be some topics to interest and inform everyone who attends. Some concurrent sessions are planned to give attendees a choice of topics. For those who attended the early meetings of the organization in Woods Hole, Massachusetts, you will recall the informal atmosphere which fostered a great deal of discussion and idea exchange. We'll do our best to provide plenty of time for communication and questions. Due to the location of the meeting, we hope to attract not only our members but also potential members from the industrial libraries in Texas and the surrounding states.

The conference officially begins on Tuesday night, October 4th, with a cocktail buffet. The program will commence on Wednesday morning. Presentations are planned on the preservation of rare book collections, online card catalogues, salvage of water damaged library materials, library automation, grants available to marine science libraries, and a survey of the major expeditionary reports. Several poster sessions have been scheduled. Thus far, topics include geographic coordinates in descriptive cataloging, communicating with the department, and general reference books essential in the marine science library. There are tentative plans for 1/2 day concurrent workshops on Chemical Abstracts online training, the use of microcomputers in the marine science library, searching Biosis Previews for marine science information and training on the use of Zoological Record, both print and online versions.

The package registration fee was very popular last year and will be used again this year to cover lunches, the cocktail buffet Tuesday night, the banquet on Thursday night, liquor, transportation, speaker costs, program printing, etc. A variety of possible accommodations will be offered. Rooms have been reserved at the Best Western on the ocean - conference rate - \$36.00 per night. More elaborate rooms in the same hotel will be \$50 - \$60. Dormitory rooms will be another option at \$7.50 per night. Should you decide to make this a real vacation, condominiums can be rented at a nightly rate of \$75 - \$125. Transportation will be made available from the airport in Corpus Christi to Port Aransas, about an hour away. Car rental is another option.

Ruth promises that the weather in Port Aransas will be in the 80's, barring the whims of Mother Nature. The area will be a real treat for the birdwatchers in the group since it's a major flyway for migratory birds. If you're an avid birder, be sure to bring binoculars and a camera. One or two guided tours will be provided for those interested. In addition, there are tentative plans for a one day shopping excursion to Mexico on the Saturday following the conference.

The future of the Aquaculture Database (DIALOG file 112) looks a lot brighter than it did in October when I announced that NMFS would cease funding the project in Decem-Support for the database was aided by the decision of the Joint Subcommittee on Aquaculture to coordinate the aquaculture activities of USDA, Dept. of Commerce and Dept. of Interior. Wallace Olsen of the National Agricultural Library set up a "cooperative agreement" between NAL and NMFS to support the Aquaculture Database. NAL is funding the project from January through June 1983 and NMFS plans to continue the funding from July through December 1983.

A NOTE ON THE NAMING OF LAMSLIC from Ken Morse, Pell Marine Science Library at the University of Rhode Island

The acronym by which we refer to our association (the one reason for reservations about it) was not achieved casually. The association was first known as the East Coast Marine Science Librarians in 1975 and 1976. In 1977, because the association's name was being misinterpreted by the uninformed to be that of a labor organization, it was decided to change the name and Marine Science Libraries Association came into use. It was at the business meeting of the Fourth Annual Meeting in Woods Hole, when the by-laws were being drawn up, that the name of the association was again discussed. On September 19, 1978, in the conference room of the Clark Laboratory at WHOI, the decision was made.

It was agreed that the new name of the association should emphasize libraries rather than librarians. Association of Marine Science Libraries was proposed. Candy Dunn of the URI Coastal Zone Information Center called for recognition of information services that were not libraries in the new name. The proposed name was amended to Association of Marine Science Libraries and Information Centers. Ken Morse cautioned that the acronym from the name (AMSLIC) would be pronounced "Am some progress toward federal tax-Slick." The further request to add International to the name thereby phone calls to the IRS's 800 number including our Canadian and foreign for the purpose of obtaining the members, brought us to the acronym "I proper forms, I telephoned the local Am Slick." Be sure to make your checks/money orders payable in U.S. dollars (otherwise we may lose money on the exchange rate). Also, take care to ensure that your checks/money orders indicate for whom the membership is intended: 2 cryptic checks arrived made out to IAMSLIC, neither of which carried any personal or institutional information.

In reviewing the materials forwarded to me from the previous treasurer, I discovered that although we are incorporated as a nonprofit organization in Oregon we are not exempt from that State's income/ excise taxes. Therefore, I wrote to the Oregon Dept. of Revenue for information applying for an exemption. The forms and affidavits have arrived and I am in the process of filling them out. By the way, our Certificate of Incorporation has been framed and makes a very nice addition to the walls of the President's office.

Lastly, we appear to be making exempt status. Frustrated after 3 documents in the mail shortly. I have received one massive package and am almost afraid to see what comes in the next one! FROM THE SOUTH comes the following from Mary Katherine Politz at Louisiana Universities Marine Research and Education Center

The April 22nd ground breaking for Louisiana Universities Marine Consortium's (LUMCON) \$12 million laboratory did not go as planned. Instead of radiant smiles, uplifting speeches and clear skies, there were worried looks, quick comments and a deluge. The only ground dry enough to "break" at the Cocodrie site was that under the Army tent that protected the dignitaries and friends. Governor David C. Treen was the featured speaker; other breakers of ground included Congressman Billy Tauzin (who pushed the enabling legislation through the Louisiana Legislature when he was there in 1979), Commissioner of Education William Arceneaux and LUMCON Executive Director Donald F. Boesch. The facility when completed in two years, will house administrative offices, teaching and research labs, dorms, cafeteria and yes, a library. The structure is designed to resist

hurricanes, high water and deluges. Present facilities of the 3 year old agency include 5 used trailers on the marsh with administrative offices, living quarters for visiting scientists and makeshift microplankton lab and library.

Louisiana's economy and reputation has long rested on the resouces of the coastal marsh, which is quickly eroding and deteriorating. It has taken several years to convince the state's legislators what the "locals" already knew--that the state needed a university-affiliated multidisciplinary marine science laboratory to study the marsh, the erosion and the organisms that are so affected by the changes. With this ground-breaking, a new and exciting (not to mention efficient, top-notch and comfortable) phase in marine science begins in Louisiana.

Seriousness aside, the groundbreaking continued on a much pleasanter note as the guests moved to the local marina for a typical Louisiana party: boiled crawfish and crabs, jambalaya and beer. The deluge was forgotten.




NEWS NOTES

Carol Winn has been invited to serve the American Geophysical Union as a member of the Subcommittee on Electronic Transmission and Publishing of Geophysical Sciences. subcommittee of the Publications Committee will include members with experience in automatic text processing, computer graphics, journal editing functions and library science and is chaired by Elaine Oran of the Naval Research Laboratory. The scope of the subcommittee's work will be defined by its members and may include some experimental projects involving the members home institutions.

Excerpts from a letter received from William A. Stanley, Acting Chief, External Affairs Staff, National Ocean Service, NOAA.

On November 28, 1982 the National Ocean Survey (formerly the U.S. Coast and Geodetic Survey), was abolished. In its place is the Office of Charting and Geodetic Services, an element of the new National Ocean Service. This restructuring has altered the mission of the present Ocean Survey creating separate and equal reporting elements for several activities. Newly formed is the Office of Oceanography and Marine Services, which will include tidal determinations, Great Lakes water levels, and ocean investigation. The office of Marine



Operations will be responsible for the NOAA fleet along with the Atlantic Marine Center (Norfolk, Virginia), and the Pacific Marine Center (Seattle, Washington). These new offices along with the Office of Ocean and Coastal Resource Management will answer to an Assistant Administrator for Ocean Services and Coastal Zone Management as the head of the new National Ocean Service. The functions of my former position as Chief of the Physical Science Services Branch will in part continue under the Distribution Branch (N/CG33) Office of Charting and Geodetic Services.
