# Symplectic propagators for the Kepler problem with time-dependent mass

Abstract New numerical integrators specifically designed for solving the two-body gravitational problem with a time-varying mass are presented. They can be seen as a generalization of commutator-free quasi-Magnus exponential integrators and are based on the compositions of symplectic flows. As a consequence, in their implementation they use the mapping that solves the autonomous problem with averaged masses at intermediate stages. Methods up to order eight are constructed and shown to be more efficient that other symplectic schemes on numerical examples.

**Keywords** Kepler problem  $\cdot$  time-dependent mass  $\cdot$  symplectic integrators  $\cdot$  Hamiltonian systems

# 1 Introduction

The problem of determining the motion of two bodies under their mutual gravitational attraction (the so-called Kepler problem) is one of the most studied dynamical systems in classical mechanics. It not only constitutes a paradigmatic example

of an integrable system [4], but in addition it is also used as one of the first test bench for illustrating the main features of whatever numerical integration methods for differential equations are proposed, ranging from classical embedded Runge–Kutta schemes with adaptive step size, to multistep methods [16]. Moreover, given all its geometric properties, it has received great attention for checking the recent class of structure-preserving numerical methods, such as energy-preserving and symplectic integrators [15,25].

Even in the long-time integration of planetary systems involving several bodies, the Kepler problem plays a fundamental role. This is so because, using an appropriate set of coordinates (e.g., heliocentric or Jacobi coordinates [17]), the equations of motion can be shown to derive from a Hamiltonian function of the form

$$H(q,p) = H_K(q,p) + \varepsilon H_I(q,p), \tag{1}$$

where  $H_K$  corresponds to the Keplerian motion of each planet,  $H_I$  is a (small) perturbation given by the interaction between the planets, and  $\varepsilon$  denotes a small parameter. An early reference in this respect is [27], where a symmetric second order symplectic scheme was successfully used to study the chaotic behaviour of the Solar System. Since then, many other highly efficient symplectic integrators have been designed taking into account this near-integrable structure of the problem (see, e.g [8,13,18,20] and references therein).

All these schemes require, at each intermediate stage, solving one or several times a transcendental equation to determine with great accuracy the position in phase space of each body subjected to the Hamiltonian  $H_K$ . This is done in practice by numerical iteration as follows. If we write the Hamiltonian function describing the Kepler problem as

$$H(q,p) = \frac{1}{2}p^{T}p - \mu \frac{1}{r},\tag{2}$$

where  $\mu = GM$ , G is the gravitational constant, M is the reduced mass and  $q, p \in \mathbb{R}^3$ ,  $r = ||q|| = \sqrt{q^T q}$ , the map advancing the solution in time from  $t_0$  to t can be expressed as

$$(q(t), p(t)) \equiv \Phi(q_0, p_0; t, \mu) = (f q_0 + g p_0, f_p q_0 + g_p p_0)$$
(3)

in terms of functions  $f, f_p, g, g_p$  that are determined through (see, e.g. [6,11])

$$r_{0} = r(t_{0}) = ||q_{0}||; \quad u = q_{0}^{T} p_{0}; \quad E = \frac{1}{2} p_{0}^{T} p_{0} - \mu \frac{1}{r_{0}}; \quad a = -\frac{\mu}{2E}; \quad w = \sqrt{\frac{\mu}{a^{3}}};$$

$$\sigma = 1 - \frac{r_{0}}{a}; \quad \psi = \frac{u}{wa^{2}}; \quad wt = x - \sigma \sin x + \psi (1 - \cos x)$$

$$f = 1 + \frac{(\cos x - 1)a}{r_{0}}, \quad g = t + \frac{\sin x - x}{w},$$

$$f_{p} = -\frac{aw \sin x}{r_{0} (1 - \sigma \cos x + \psi \sin x)}, \quad g_{p} = 1 + \frac{\cos x - 1}{1 - \sigma \cos x + \psi \sin x},$$

$$(4)$$

where x is evaluated by numerical iteration. As a matter of fact, this can be done very efficiently with only 2-5 iterations, depending on the time step and the values of  $q_0, p_0$ , to reach round off accuracy.

There are other astronomical problems that can be also modelled as (1), but, as they frequently involve some loss of mass, the corresponding Hamiltonian system depends explicitly on time. Examples are the evolution of planetary systems with time-dependent stellar loss of mass [2], evolution of exoplanets around binary star systems [23] with stellar mass loss [26], and the two-body problem with varying mass [12,24], among others [19]. In those situations one has to solve in an accurate and efficient way the dynamics of the Hamiltonian

$$H(t,q,p) \equiv T + V(t) = \frac{1}{2}p^{T}p - \mu(t)\frac{1}{r},$$
 (5)

where now  $\mu(t)$  is a time-dependent function, and the natural question arising here is whether the procedure (3-4) can be conveniently adapted to deal with this problem. In this work we show that this is actually the case and present several numerical algorithms with different orders of accuracy that use the map  $\Phi$  in (3) with properly averaged values of the time-dependent mass  $\mu(t)$  that are more efficient than other numerical integrators in short- and long-time integrations. The new algorithms can be seen as a specially tuned class of schemes called commutator-free quasi-Magnus (CFQM) exponential integrators, originally intended for linear non-autonomous problems [3,9,10]. They are based on compositions of the symplectic flows corresponding to certain linear combinations of the time-dependent Hamiltonian (5) evaluated at appropriately chosen times. For illustration, the map

$$(q_0, p_0) = (q(t_0), p(t_0)) \longmapsto (q_1, p_1)$$

given by the composition

$$(q_{1/2}, p_{1/2}) = \Phi(q_0, p_0; \frac{h}{2}, \hat{\mu}_1), \quad \hat{\mu}_1 = a_1 \mu(c_1 h) + a_2 \mu(c_2 h),$$

$$(q_1, p_1) = \Phi(q_{1/2}, p_{1/2}; \frac{h}{2}, \hat{\mu}_2), \quad \hat{\mu}_2 = a_2 \mu(c_1 h) + a_1 \mu(c_2 h),$$
(6)

where  $c_1 = \frac{1}{2} - \frac{\sqrt{3}}{6}$ ,  $c_2 = \frac{1}{2} + \frac{\sqrt{3}}{6}$ ,  $a_1 = \frac{1}{2} + \frac{\sqrt{3}}{3}$ ,  $a_2 = \frac{1}{2} - \frac{\sqrt{3}}{3}$ , provides a 4th-order approximation to the exact solution of (5) at time  $t_1 = t_0 + h$ , in the sense that

$$(q_1, p_1) = (q(t_1), p(t_1)) + \mathcal{O}(h^5).$$

In the following, we show how the scheme (6) is obtained and also construct similar approximations of higher orders. Then, we illustrate the advantages of the new procedures in comparison to other numerical algorithms on some examples.

# 2 Construction of the schemes

# 2.1 Hamiltonian vector fields and Poisson brackets

The derivation process of the new schemes can be carried out in a suitable way by introducing the formalism of Lie derivatives and Lie transformations [1,4]. Thus, starting from the equations of motion for the autonomous case (2)

$$\dot{q} = p, \qquad \dot{p} = -\mu \frac{q}{r^3}, \tag{7}$$

and the corresponding Hamiltonian vector  $X_H = (\nabla_p H, -\nabla_q H)^T$ , one introduces the Lie derivative  $L_{X_H}$ , whose action on a differentiable function G(q,p) is

$$L_{X_H}G = (J\nabla_x H)^T \nabla_x G = -(\nabla_x H)^T J\nabla_x G = -\{H, G\} = \{G, H\}.$$
 (8)

Here  $x = (q, p)^T$ , J is the basic canonical symplectic matrix

$$J = \begin{pmatrix} 0 & I \\ -I & 0 \end{pmatrix}$$

and  $\{H,G\}$  denotes the Poisson bracket of the two scalar functions H(q,p) and G(q,p),

$$\{G,H\} = \sum_i \left( \frac{\partial G}{\partial q_i} \frac{\partial H}{\partial p_i} - \frac{\partial G}{\partial p_i} \frac{\partial H}{\partial q_i} \right),$$

so that, in terms of the Poisson bracket, equations (7) can be written simply as

$$\dot{x}_i = \{x_i, H\}. \tag{9}$$

In case G is a vector function,  $L_{X_H}$  in (8) acts on any of its components.

If  $\varphi_t$  denotes the flow corresponding to (7), for each infinitely differentiable map G, the Taylor series of  $G(\varphi_t(x_0))$  at  $t = t_0$  is given by

$$G(\varphi_t(x_0)) = \sum_{k \ge 0} \frac{(t - t_0)^k}{k!} (L_{X_H}^k G)(x_0) \equiv \exp((t - t_0) L_{X_H})[G](x_0), \tag{10}$$

where  $\exp(tL_{X_H})$  is the so-called Lie transformation. If we introduce the operator  $\Theta_t$  acting on differentiable functions as  $G(\varphi_t(x)) = \Theta_t[G](x)$ , then we can write

$$G(\varphi_t(x)) = \Theta_t[G](x) = \exp((t - t_0)L_{X_H})[G](x),$$

so that the solution of (7) is obtained by replacing G(x) in (10) by the identity map  $\mathrm{Id}(x)=x$ :

$$\varphi_t(x_0) = \sum_{k \ge 0} \frac{(t - t_0)^k}{k!} (L_{X_H}^k \operatorname{Id})(x_0) = \exp((t - t_0) L_{X_H}) [\operatorname{Id}](x_0).$$

Lie transformations obey the following important property for any pair of arbitrary vector fields. Given the flows  $\varphi_{t_1}^{[1]}$  and  $\varphi_{t_2}^{[2]}$  corresponding to the differential equations  $\dot{x}=f^{[1]}(x)$  and  $\dot{x}=f^{[2]}(x)$ , respectively, then

$$\left(\varphi_{t_2}^{[2]} \circ \varphi_{t_1}^{[1]}\right)(x_0) = \exp(t_1 L_{f^{[1]}}) \, \exp(t_2 L_{f^{[2]}})[\mathrm{Id}](x_0).$$

Notice where the indices 1 and 2 appear depending on whether one is dealing with maps or with exponentials of operators. This relation generalizes by induction to any number of flows [15].

In the non-autonomous problem one can still formally write the operator  $\Theta_t$  associated with the exact flow as the Lie transformation corresponding to an unknown function  $\Omega(t, t_0)$ ,

$$\varphi_t(x_0) = \Theta_t[\mathrm{Id}](x_0) = \exp(L_{X_{\Omega(t,t_0)}})[\mathrm{Id}](x_0), \tag{11}$$

which can be approximated for sufficiently small time intervals  $[t_0, t]$  by truncating the corresponding Magnus expansion [5,22]. This is done by the infinite series

$$\Omega(t,t_0) = \sum_{m=1}^{\infty} \Omega_m(t,t_0)$$
(12)

which involves multiple integrals of nested Poisson brackets:

$$\Omega_1(t, t_0) = \int_{t_0}^t H(s, q_0, p_0) ds$$

$$\Omega_2(t, t_0) = -\frac{1}{2} \int_{t_0}^t ds_1 \int_{t_0}^{s_1} ds_2 \{ H(s_1, q_0, p_0), H(s_2, q_0, p_0) \}.$$

Recursive procedures to generate the terms in the Magnus series are found e.g. in [7].

# 2.2 Derivation of the new methods

The methods we propose for approximating the operator  $\Theta_t$  up to order r in the general non-autonomous case (5) have the form  $x_1 = \Psi_J^{[r]}[\mathrm{Id}]x_0$  for the step  $x_0 \longmapsto x_1$ , with

$$\Psi_J^{[r]} = \exp(\hat{B}_1(h)) \exp(\hat{B}_2(h)) \cdots \exp(\hat{B}_J(h))$$
 (13)

and

$$\hat{B}_{j}(h) \equiv L_{X_{B_{j}}}, \quad B_{j} = h \sum_{k=1}^{s} a_{jk} H_{k}(h), \quad j = 1, \dots, J$$

$$H_{k}(h) = H(t_{0} + c_{k}h), \quad c_{k} \in [0, 1] \quad k = 1, \dots s$$

$$x_{1} = x(t_{1}) + \mathcal{O}(h^{r+1}).$$
(14)

Alternatively, in terms of maps, the approximation reads

$$x_1 = \left(\varphi_h^{[J]} \circ \varphi_h^{[J-1]} \circ \dots \circ \varphi_h^{[2]} \circ \varphi_h^{[1]}\right)(x_0), \tag{15}$$

where  $\varphi_h^{[j]}$  denotes the flow corresponding to the Lie transformation  $\exp(\hat{B}_j(h))$ .

Eventually, in the setting of the non-autonomous Kepler problem, the particularly simple algebraic structure of the problem will allow us to include additional Poisson brackets in the linear combinations  $B_j$  to reduce the number of flows. In this way, the computational cost is reduced and the overall efficiency is improved. Note that, by construction, these schemes preserve the symplectic character of the exact flow.

The requirement that the scheme (13) provides an approximation to the exact solution up to a given order r implies that the coefficients  $a_{jk}$ ,  $c_k$  have to satisfy a certain number of conditions. These can be derived by reproducing the exact solution provided by the Magnus expansion (11) with (13) up to order r.

For simplicity in the presentation, we take  $t_0 = 0$  and the Gauss-Legendre quadrature rule,  $c_i$ , i = 1, ..., s of order 2s, although the schemes can be easily adapted to any other quadrature rule. Then, Theorem 2.1 in [5] applied to a non-autonomous Hamiltonian system (9) leads to the following

**Theorem 1** If  $c_i$ , i = 1, ..., s are the s nodes of the Gauss-Legendre quadrature rule of order 2s,  $\mathcal{L}_i(t)$  denotes the Lagrange polynomial

$$\mathcal{L}_i(t) = \prod_{j=1, j \neq i}^{s} \frac{t - c_j}{c_i - c_j}, \quad t \in [0, 1],$$

and x(h) is the exact solution of (9) at  $t = t_0 + h$ , then the solution of the differential equation

$$\dot{y}_i = \{y_i, \widetilde{H}^{(2s)}(t, y, h)\}, \qquad y(0) = x_0,$$
 (16)

with

$$\widetilde{H}^{(2s)}(t,y,h) = \sum_{i=1}^{s} \mathcal{L}_i\left(\frac{t}{h}\right) H(c_i h, y) \tag{17}$$

verifies  $||x(h) - y(h)|| = \mathcal{O}(h^{2s+1})$ .

Since  $\widetilde{H}^{(2s)}(t, y, h)$  is a polynomial in t of degree s-1, we can compute analytically all the terms in the Magnus expansion corresponding to the initial value problem (16) and get an approximation to the exact solution x(h) of (9) up to a given order r by computing the first terms of the series (12).

Specifically, for the the non-autonomous Kepler problem one has

$$\widetilde{H}^{(2s)}(t,y,h) = \frac{1}{2}p^T p - \mu^{(2s)}(t,h)\frac{1}{r},$$

where  $\mu^{(2s)}(t,h)$  is the interpolating polynomial of  $\mu(t)$  in the interval  $t \in [0,h]$ . If a Taylor expansion of  $\widetilde{H}^{(2s)}$  around  $\frac{h}{2}$  is considered, then

$$\begin{split} \widetilde{H}^{(2s)}(t,y,h) &= \widetilde{H}^{(2s)}\left(\frac{h}{2} + \tau, y, h\right) = \frac{1}{h} \sum_{i=1}^{s} \left(\frac{\tau}{h}\right)^{i-1} \alpha_i, \quad \tau \in \left[-\frac{h}{2}, \frac{h}{2}\right], \\ \alpha_i &= h^i \left. \frac{1}{(i-1)!} \left. \frac{\partial^{i-1}}{\partial \tau^{i-1}} \right|_{\tau=0} \widetilde{H}^{(2s)}\left(\frac{h}{2} + \tau, y, h\right). \end{split}$$

Here  $\alpha_i(y)$ ,  $i=1,\ldots,s$ , are linear combinations of  $H_j=H(c_jh,y)$ ,  $j=1,\ldots,s$ , and  $\alpha_i(y)=\mathcal{O}(h^i)$ ,  $\alpha_i(y)\alpha_j(y)=\mathcal{O}(h^{i+j})$ , etc. Now, the corresponding truncation of the Magnus series (12) up to order  $h^{2s}$ ,  $\widetilde{\Omega}^{[2s]}=\Omega+\mathcal{O}(h^{2s+1})$ , with 2s=2,4,6,8 gives

$$\begin{split} \widetilde{\Omega}^{[2]} &= \alpha_1 \\ \widetilde{\Omega}^{[4]} &= \alpha_1 + \frac{1}{12}\{12\} \end{split} \tag{18} \\ \widetilde{\Omega}^{[6]} &= \alpha_1 + \frac{1}{12}\alpha_3 + \frac{1}{12}\{12\} - \frac{1}{240}\{23\} + \frac{1}{360}\{113\} - \frac{1}{240}\{212\} - \frac{1}{720}\{1112\} \\ \widetilde{\Omega}^{[8]} &= \alpha_1 + \frac{1}{12}\alpha_3 + \frac{1}{12}\{12\} - \frac{1}{240}\{23\} + \frac{1}{360}\{113\} - \frac{1}{240}\{212\} - \frac{1}{720}\{1112\} \\ &\quad + \frac{1}{80}\{14\} + \frac{1}{1344}\{34\} - \frac{1}{2240}\{124\} + \frac{1}{6720}\{223\} + \frac{1}{6048}\{313\} - \frac{1}{840}\{412\} \\ &\quad - \frac{1}{6720}\{1114\} + \frac{1}{7560}\{1123\} - \frac{1}{4032}\{1312\} - \frac{11}{60480}\{2113\} + \frac{1}{6720}\{2212\} \\ &\quad - \frac{1}{15120}\{11113\} - \frac{1}{30240}\{11212\} + \frac{1}{7560}\{21112\} + \frac{1}{30240}\{111112\} \end{split}$$

where  $\{ij \dots k\ell\}$  represents the nested Poisson bracket  $\{\alpha_i, \{\alpha_j, \{\dots, \{\alpha_k, \alpha_\ell\} \dots\}\}\}\}$ . Since  $\widetilde{\Omega}^{[2]} = \alpha_1 = hH(\frac{h}{2})$ , then

$$\Psi_1^{[2]} = \exp(\hat{B}(h)), \text{ with } B = hH(h/2),$$

agrees with the operator  $\Theta_h$  up to order  $\mathcal{O}(h^2)$ . In terms of the map  $\Phi$ , the scheme is nothing but the well known 2nd-order midpoint rule

$$x_1 = \varphi_h^{[2]}(x_0) = \Phi(x_0; h, \mu(h/2)).$$
 (19)

We next apply the same strategy to construct higher order approximations.

Order four. The quadrature rule with s=2 has nodes and weights

$$c_1 = \frac{1}{2} - \frac{\sqrt{3}}{6}, \quad c_2 = \frac{1}{2} + \frac{\sqrt{3}}{6}, \quad w_1 = w_2 = \frac{1}{2},$$

respectively, and the interpolating polynomial reads

$$\widetilde{H}^{(4)}(\frac{h}{2} + \tau, y, h) = \frac{1}{2}(H_1 + H_2) + \tau \frac{\sqrt{3}}{h}(H_2 - H_1) = \frac{1}{h}\alpha_1 + \frac{\tau}{h^2}\alpha_2$$

with  $H_i \equiv H(c_i h, y)$ . Now the Lie transformation associated with  $\widetilde{\Omega}^{[4]}$  (and therefore the exact flow) can be correctly reproduced up to order  $\mathcal{O}(h^4)$  by

$$\varPsi_2^{[4]} = \exp\left(\frac{1}{2}\hat{\alpha}_1 - \frac{1}{6}\hat{\alpha}_2\right)\,\exp\left(\frac{1}{2}\hat{\alpha}_1 + \frac{1}{6}\hat{\alpha}_2\right).$$

Here and in the sequel, for simplicity, we denote by  $\hat{\alpha}_i$  the Lie derivative associated with the vector field corresponding to  $\alpha_i$ , i.e.,  $\hat{\alpha}_i = L_{X_{\alpha_i}}$ . Finally, expressing  $\alpha_1$ ,  $\alpha_2$  in terms of the evaluations  $H_1$ ,  $H_2$  results in

$$\Psi_2^{[4]} = \exp(\hat{B}_1(h)) \exp(\hat{B}_2(h)) = \exp(ha_{11}\hat{H}_1 + ha_{12}\hat{H}_2) \exp(ha_{21}\hat{H}_1 + ha_{22}\hat{H}_2)$$

$$a = (a_{ij}) = \begin{pmatrix} \frac{1}{4} + \frac{\sqrt{3}}{6} & \frac{1}{4} - \frac{\sqrt{3}}{6} \\ \frac{1}{4} - \frac{\sqrt{3}}{6} & \frac{1}{4} + \frac{\sqrt{3}}{6} \end{pmatrix}$$
(20)

or, in a more compact way

$$\Psi_2^{[4]} = \exp\left(\frac{h}{2}(\hat{T} + \bar{V}_1)\right) \exp\left(\frac{h}{2}(\hat{T} + \bar{V}_2)\right)$$

where

$$\bar{V}_1 \equiv 2(a_{11}\hat{V}_1 + a_{12}\hat{V}_2), \quad \bar{V}_2 \equiv 2(a_{21}\hat{V}_1 + a_{22}\hat{V}_2).$$

The map corresponding to this operator is precisely the scheme given in (6).

Order six. In this case one has to use the nodes and weights of the sixth-order Gauss-Legendre quadrature,

$$c_1 = \frac{1}{2} - \frac{\sqrt{15}}{10}, \quad c_2 = \frac{1}{2}, \quad c_3 = \frac{1}{2} + \frac{\sqrt{15}}{10}$$
  
 $w_1 = \frac{5}{18}, \quad w_2 = \frac{4}{9}, \quad w_3 = w_1.$ 

Then

$$\alpha_1 = hH_2 = h(T + V_2),$$

$$\alpha_2 = \frac{\sqrt{15}h}{3}(H_3 - H_1) = \frac{\sqrt{15}h}{3}(V_3 - V_1)$$

$$\alpha_3 = \frac{10h}{3}(H_3 - 2H_2 + H_1) = \frac{10h}{3}(V_3 - 2V_2 + V_1)$$

or, equivalently,

$$\alpha_1 = h\left(T - \widetilde{\mu}_1 \frac{1}{r}\right), \quad \alpha_i = -h\widetilde{\mu}_i \frac{1}{r}, \quad i > 1$$

with

$$\widetilde{\mu}_1 = \mu_2, \quad \widetilde{\mu}_2 = \frac{\sqrt{15}}{3}(\mu_3 - \mu_1), \quad \widetilde{\mu}_3 = \frac{10}{3}(\mu_3 - 2\mu_2 + \mu_1),$$

and  $\mu_i = \mu(c_i h)$ .

Notice that, since only  $\alpha_1$  depends on momenta (through T), then  $\{\alpha_2, \alpha_3\} = 0$ , and thus the number of conditions required to approximate  $\exp(L_{X_{\widehat{\Omega}^{[6]}}})$  is six instead of seven. Moreover, a simple calculation shows that

$$h^{3}V_{ij}^{(m)} \equiv \left\{\alpha_{i}, \{\alpha_{1}, \alpha_{j}\}\right\} = -h^{3}\widetilde{\mu}_{i}\widetilde{\mu}_{j}\frac{1}{r^{4}}, \quad i, j > 1.$$
 (21)

As already illustrated by the previous 4th-order approximation, a linear combination of  $\alpha_i$ ,  $i=1,2,\ldots$ , gives rise to a Hamiltonian function which corresponds to a scaled autonomous Kepler problem with a modified (but constant) mass  $\tilde{\mu}$ , i.e.,

$$F = \sum_{i} x_i \, \alpha_i = x_1 h \left( \frac{1}{2} p^T p - \tilde{\mu} \frac{1}{r} \right)$$

with  $x_1 \neq 0$ , whose exact flow can be determined with the map  $\Phi$  given in (3). On the other hand, and according with (21), the flow of

$$G = \sum_{i>1} x_i \alpha_i + b \left\{ \alpha_i, \{\alpha_1, \alpha_j\} \right\} = -h \widetilde{\mu} \frac{1}{r} - h^3 b \widetilde{\mu}_i \widetilde{\mu}_j \frac{1}{r^4}$$

can also be trivially obtained, since it only depends on coordinates. In consequence, we propose the following composition

$$\Psi_2^{[6]} = \exp(-x_1\hat{\alpha}_2 + x_2\hat{\alpha}_3 + x_3\left[\hat{\alpha}_2, \hat{\alpha}_1, \hat{\alpha}_2\right]) \exp(x_4\hat{\alpha}_1 - x_5\hat{\alpha}_2 + x_6\hat{\alpha}_3) \times \exp(x_4\hat{\alpha}_1 + x_5\hat{\alpha}_2 + x_6\hat{\alpha}_3) \exp(x_1\hat{\alpha}_2 + x_2\hat{\alpha}_3 + x_3\left[\hat{\alpha}_2, \hat{\alpha}_1, \hat{\alpha}_2\right])$$
(22)

to approximate  $\exp(L_{X_{\overline{\Omega}[6]}})$  up to order 6. Here  $[\hat{\alpha}_2,\hat{\alpha}_1,\hat{\alpha}_2] \equiv [\hat{\alpha}_2,[\hat{\alpha}_1,\hat{\alpha}_2]]$  is the Lie bracket corresponding to the Hamiltonian vector field of the function  $\{\alpha_1,\alpha_2,\alpha_1\}$ . It turns out that there is only one solution for the coefficients  $x_i$ , namely

$$x_1 = \frac{1}{60}$$
,  $x_2 = \frac{1}{60}$ ,  $x_3 = \frac{1}{43200}$ ,  $x_4 = \frac{1}{2}$ ,  $x_5 = \frac{2}{15}$ ,  $x_6 = \frac{1}{40}$ .

In consequence, the scheme can be expressed in a compact way as

$$\Psi_2^{[6]} = \exp\left(h(\bar{V}_1 + h^2 \hat{V}_{22}^{(m)})\right) \exp\left(a_2 h(\hat{T} + \frac{1}{a_2} \bar{V}_2)\right) \exp\left(a_3 h(\hat{T} + \frac{1}{a_3} \bar{V}_3)\right) \times \exp\left(h(\bar{V}_4 + h^2 \hat{V}_{22}^{(m)})\right), \tag{23}$$

with

$$\hat{V}_{22}^{(m)} = -x_3 \frac{5}{3} (\mu_3 - \mu_1)^2 \frac{1}{r^4},$$

$$\bar{V}_{i} = \sum_{j=1}^{3} a_{ij} \hat{V}_{j}, \qquad (a)_{ij} = \begin{pmatrix} \frac{10 + \sqrt{15}}{180} & -\frac{1}{9} & \frac{10 - \sqrt{15}}{180} \\ \frac{15 + 8\sqrt{15}}{190} & \frac{1}{3} & \frac{15 - 8\sqrt{15}}{180} \\ a_{23} & a_{22} & a_{21} \\ a_{13} & a_{12} & a_{11} \end{pmatrix}$$
 (24)

and

$$a_2 = \sum_{j=1}^{3} a_{2j} = \frac{1}{2}, \quad a_3 = \sum_{j=1}^{3} a_{3j} = \frac{1}{2}.$$

The step  $(q_n, p_n) \mapsto (q_{n+1}, p_{n+1})$  with this scheme can be obtained with Algorithm 1. It requires basically the same computational effort as the 4th-order method (6),(20), since the evaluation of r in the last map,  $r = ||Q_2||$ , can be reused in the first map in the next step as well as in the next map  $\Phi$ . Accordingly, the computational cost of evaluating the first and fourth flows in (23) can be neglected.

Order eight. The same strategy can be applied to construct 8th-order methods. Thus, for the Gauss-Legendre quadrature with nodes and weights

$$v_1 = \frac{1}{2}\sqrt{\frac{3+2\sqrt{6/5}}{7}}, \quad v_2 = \frac{1}{2}\sqrt{\frac{3-2\sqrt{6/5}}{7}},$$

one can express the functions  $\alpha_i$  in terms of T and the potential V evaluated at the nodes. Then one arrives at

In approximating  $\exp(L_{X_{\overline{\Omega}[8]}})$ , we have to take into account that, in addition to  $\{\alpha_2, \alpha_3\}$ , the following Poisson brackets

$$\{34\},\ \{124\},\ \{223\},\ \{1123\},\ \{2212\}$$

also vanish, and that the exact flow determined by Hamiltonian functions  $V_{ij}^{(m)}$ , i, j > 1, in (21) can also be incorporated into the scheme.

We have analyzed several time-symmetric compositions with enough parameters to satisfy the 16 conditions required to achieve order 8 with a reduced number of exponentials associated to the Kepler map, since this is the most expensive part. It turns out that at least five maps for the scaled autonomous Kepler problem are then necessary.

The following composition is first considered

$$\Psi_{5a}^{[8]} = \exp(x_{12}\hat{\alpha}_2 + x_{13}\hat{\alpha}_3 + x_{14}\hat{\alpha}_4 + y_1[212] + y_2[313] - y_3[213]) 
\times \exp(x_{21}\hat{\alpha}_1 + x_{22}\hat{\alpha}_2 + x_{23}\hat{\alpha}_3 + x_{24}\hat{\alpha}_4) 
\times \exp(x_{31}\hat{\alpha}_1 + x_{32}\hat{\alpha}_2 + x_{33}\hat{\alpha}_3 + x_{34}\hat{\alpha}_4)

so that  $x_{42} = x_{44} = 0$ . Here, for simplicity, we denote  $[212] \equiv [\hat{\alpha}_2, [\hat{\alpha}_1, \hat{\alpha}_2]]$ , etc. This time-symmetric composition has 16 parameters, and thus we only obtain isolated solutions. Among the existing four real-valued solutions, we have found

that the best performance corresponds to

We have analyzed other compositions with additional exponentials and free parameters that do not increase the overall computational cost. Thus, in particular, the following scheme only contains 5 exponentials involving  $\hat{\alpha}_1$  (corresponding to 5 Kepler maps):

so that  $x_{52}=x_{54}=0$ . This time-symmetric composition has 19 variables and thus one can choose three of them as free parameters (in particular,  $x_{42}$ ,  $x_{43}$  and  $x_{44}$ ). We have observed in practice that the performance of the resulting methods obtained according with different criteria depends on the particular problem to be solved. For example, if we take  $x_{42}=x_{43}=x_{44}=0$ , there are 4 real solutions, and the best results correspond to

Alternatively, if in the composition (26) we take  $x_{31} = x_{51} = 0$  the cost of the scheme is reduced from 5 to 3 maps, but we end up with only 15 parameters to solve the 16 order conditions. The composition is given by

With this, obviously, not all 8th-order conditions can be satisfied. We have considered two possibilities: either we discard the equation corresponding to [111112] or [21112]. The second choice provided s more efficient scheme where the best set of coefficients verifying all order conditions except the one coming from [21112] is

This scheme can be considered as an optimized sixth-order method that uses an 8th-order quadrature rule and satisfies many order conditions at order 8.

### 3 Numerical illustrations

## 3.1 Other symplectic integrators to compare

It is worth comparing the mentioned time-symmetric symplectic integration algorithms specifically designed for the non-autonomous Kepler problem with other well established symplectic schemes such as splitting and composition methods. It is not our purpose here to provide a full treatment of this class of methods, but just to indicate how they can be applied to the particular problem we are considering here. For further details, we refer e.g. to [5,6,15,21].

If one takes t as a new coordinate, say  $q_t = t$ , and its associated momentum,  $p_t$ , the equations obtained from the autonomous Hamiltonian

$$K(q_t, q, p_t, p) \equiv K_1 + K_2 = \left(\frac{1}{2}p^T p - \mu(q_t)\frac{1}{r}\right) + p_t$$
 (32)

have the same solution for q, p, as the original non-autonomous problem. Since the Hamiltonian  $K_1 = \frac{1}{2}p^Tp - \mu(q_t)\frac{1}{r}$  can be considered as one describing an autonomous Kepler problem  $(q_t$  does not change), and the dynamics of  $K_2 = p_t$  is trivial (it only advances  $q_t$ , that is, time), we can use splitting methods defined by a set of coefficients  $\{a_i,b_i\}_{i=1}^m$  for the numerical integration of (32). This results in the following algorithm for advancing from  $(q_n,p_n)$  to  $(q_{n+1},p_{n+1})$ :

$$Q_{0} = q_{n}, \quad P_{0} = p_{n}$$

$$(Q_{1}, P_{1}) = \Phi(Q_{0}, P_{0}, b_{1}h, \mu_{1})$$

$$\vdots$$

$$(Q_{m}, P_{m}) = \Phi(Q_{m-1}, P_{m-1}, b_{m}h, \mu_{m})$$

$$q_{n+1} = Q_{m}, \quad p_{n+1} = P_{m},$$

$$(33)$$

where  $\mu_i = \mu(t_n + d_i h)$  and  $d_i = \sum_{j=1}^i a_j$ .

On the other hand, we can use the 2nd-order midpoint rule (19) as a basic integrator of m-stage symmetric composition methods of order r [6, 15, 21],

$$SS_m^{[r]} \equiv \varphi_{\alpha_m h}^{[2]} \circ \cdots \circ \varphi_{\alpha_2 h}^{[2]} \circ \varphi_{\alpha_1 h}^{[2]}$$
(34)

with  $\alpha_{m+1-i} = \alpha_i$ . It turns out that the same algorithm (33) can be applied to implement the scheme (34) with

$$\alpha_0 = 0; \quad b_i = \alpha_i, \quad a_i = \frac{1}{2}(\alpha_{i-1} + \alpha_i), \quad i = 1, \dots, m.$$

Methods of orders r = 4, 6, 8 and 10 involving up to m = 35 basic integrators  $\varphi_{\alpha_i h}^{[2]}$  have been obtained in the literature (see [15] and references therein).

Splitting and composition methods of order higher than two necessarily involve some negative coefficients, and therefore a backward integration in time at some inner stages. If, in the specific problem we are considering,  $\mu(t)$  is a decreasing function, this represents a non-physical effect of an increment of the mass.

Commutator-free exponential integrators, originally proposed for the numerical integration of linear problems [3,9,10], can also be adapted to the nonlinear setting, eventually resulting in schemes of the form (13). Time-symmetric methods of order four with J=2,3, of order six with J=5,6, and of order eight with J=11 can be found in [3]. We should notice that, whereas scheme (20) belongs to this class, this is not the case of the new integrators of order 6 and 8, which have been specifically designed taking into account the special structure of the non-autonomous Kepler problem.

# 3.2 A pair of numerical examples

Next we compare the performance of the methods proposed in this work with some of the schemes mentioned before. Specifically, we consider m-stage symmetric compositions of order r of the form

$$\mathrm{SS}_m^{[r]} \equiv \varphi_{\alpha_1 h}^{[2]} \circ \varphi_{\alpha_2 h}^{[2]} \circ \cdots \circ \varphi_{\alpha_k h}^{[2]} \circ \varphi_{\alpha_{k+1} h}^{[2]} \circ \varphi_{\alpha_k h}^{[2]} \circ \cdots \circ \varphi_{\alpha_2 h}^{[2]} \circ \varphi_{\alpha_1 h}^{[2]}$$

with the midpoint rule (19) as basic integrator  $\varphi_h^{[2]}$  and m=2k+1. In particular,

- $\begin{array}{l} -\ SS_3^{[4]} \colon \text{the 3-stage fourth-order composition,} \\ -\ SS_9^{[6]} \colon \text{the 9-stage sixth-order composition,} \\ -\ SS_{17}^{[8]} \colon \text{the 17-stage eighth-order composition,} \end{array}$

whose coefficients can be found e.g. in [15].

Within the class of commutator-free (quasi-)Magnus exponential integrators, we select, in addition to  $CF_2^{[4]}$  given by (6), the following schemes presented in [3]:

- $CF_{3opt}^{[4]}$ : the 3-stage optimized fourth-order composition,
- $-\operatorname{CF}_{5}^{[6]}$ : the 5-stage optimized sixth-order composition,
- $\operatorname{CF}_{11}^{[8]}$ : the 11-stage eighth-order composition.

In all cases, the computational cost is counted as the number of evaluations of the map  $\Phi$ . Finally, for the sake of completeness, we also compare with a pair of ODE solvers provided by Matlab, namely

- RK<sup>[4(5)]</sup>: ode45 Runge-Kutta solver, based on the embedded Dormand-Prince
- AB<sup>[13]</sup>: variable-step and variable-order ode113 Adams-Bashforth-Moulton solver, designed to be more efficient than ode45 at problems with stringent error tolerances.

In this last case it is less obvious how to estimate the computational cost in comparison with the previous algorithms. We have counted the number of times the solver calls to the vector field. However, to take into account the relative cost with respect to the cost of the map  $\Phi$ , one should know the computational cost for estimating the local and global errors and to change either the time step or the order of the method as well as the cost of evaluating the mass  $\mu(t)$  (for some problems this could be the most costly part, depending on the model used). For these reasons we have decided to count two evaluations of the vector field (and the cost to change the order and/or time step) as the cost to evaluate one map  $\Phi$ . Obviously, different choices for the relative cost would result in a (small) shift of the corresponding curves, although the overall conclusions remain valid.

Example 1. We illustrate the performance of the new schemes on the classical Eddington–Jeans law for the secular evolution of mass in binary systems [14],

$$\dot{\mu} = -\gamma \mu^{\delta}, \qquad \mu(0) = \mu_0$$

or, equivalently

$$\mu(t) = \left(\mu_0^{1-\delta} + \gamma(\delta - 1)t\right)^{\frac{1}{1-\delta}}.$$

Note that, for non-integer values of  $\delta$ , the computational cost of evaluating  $\mu(t)$  cannot be neglected. We consider the 2-dimensional case with  $\delta=1.4, \, \mu_0=1, \, \gamma=10^{-2}$ , initial conditions

$$q_0 = (1 - e, 0), \ p_0 = (0, \sqrt{(1 + e)/(1 - e)},$$

with e=0.2 and e=0.8 and final time  $t_f=20$ . We compute the solution at the final time,  $(q(t_f), p(t_f))$ , numerically to high precision and plot the two-norm error of (q, p) at the final time versus the computational cost (measured as the number of times the Kepler map  $\phi$  is called) for different choices of the time step.




Fig. 1: Efficiency plots for Example 1 (the smaller value of e on the left). First line – 4th order methods, second line – 6th order methods, third line – 8th order methods. The bottom line summarizes the best methods of each order and the classical reference methods.

Fig. 1 shows the results obtained for methods of each order: 4th-order in the top, 6th-order in the second, 8th-order in the third row. The graphs for the smaller value of the eccentricity are given in the left column. The best method of each order, along with the classic reference methods, ode45 and ode113 of Matlab, are summarized in the last row.

From the graphs we conclude that the symplectic methods have better general performance than the classical adaptive methods. Moreover, the adaptation of methods by the inclusion of cheap Poisson brackets leads to a notable performance gain compared to the general-purpose CF methods.

Among the new schemes and for this type of problems,  $\Psi_2^{[6]}$  is the method of choice for low and medium accuracies, while  $\Psi_{5b}^{[8]}$  should be chosen for high accuracies.

 $Example\ 2.$  As a second illustration we consider the 2-dimensional case with a decreasing function given by

$$\mu(t) = 1 + \exp\left(-\frac{1}{5}(t + \frac{1}{4}\sin^2(4t))\right),$$
 (35)

and the same initial conditions as in the previous example for the time interval,  $t \in [0, 20]$ .




Fig. 2: The same as Fig. 1 for Example 2.

Fig. 2 supports the results of Ex. 1. In this case, with a faster decaying mass, the symplectic methods perform better than the classical methods. The main change we see that in this example the difference between the 6th-order methods,  $\Psi_2^{[6]}$  and  $\Psi_{3opt}^{[6]}$ , is more notable, depending on the value of e. In addition, the second 8th-order methods is marginally better in this problem.

### 4 Conclusions

In this work we have considered the numerical integration of the two-body gravitational problem with a time-varying mass. The exact flow corresponds to a symplectic transformation, and different symplectic integrators from the literature can be adapted to solve the non-autonomous systems. However, none of these symplectic methods were designed to solve Hamiltonian systems with this particular structure. This is a relevant problem and new specifically designed symplectic integrators have been built. These new schemes can be seen as a generalization of the commutator-free quasi-Magnus exponential integrators and are based on compositions of symplectic flows corresponding to linear combinations of the Hamiltonian function and certain Poisson brackets. The implementation makes use of the mapping that solves the autonomous problem for averaged masses at each intermediate stage. In the autonomous case the schemes provide the exact solution, so they also show a high performance in the adiabatic limit.

We have built time-symmetric methods of order four, six and eight that can be used with any quadrature rule of the order of the method or higher. Some of the proposed methods are optimized using a quadrature rule of higher order than the order of the method as well as by adding free parameters into the scheme in order to satisfy certain order conditions at higher orders.

The new methods have shown to be more efficient that other symplectic schemes to all desired accuracies on several numerical examples.
