# Sharon Case, french horn

Sharon Case, second horn in the Symphony of the Americas, made the finals this September, 2002 for the principal horn position of the Palm Beach Opera, and performed in New York at the 2002 Paxman Young Player Horn Competition. This December Miss Case will be touring China and Japan with members of the Atlanta Symphony for one month. She will be receiving her Bachelor of Music Degree in December from the Conservatory of Music at Lynn University. This year, Miss Case began her fourth year as a private instructor of horn at the Pine Crest Preparatory School in Boca Raton, Florida. She was a founding member of the Elan Wind Quintet that has just completed its first recording. Her passion is reaching out to the community and sharing music with young children.

This past summer Miss Case was a participant at the Henry Mancini Institute in Los Angeles where she studied with Mr. Richard Todd, and performed with Eddie Daniels, Christian McBride, Roy Hargrove, John Clayton, and Bob Belden. In the summer of 2001, she was accepted into the National Orchestral Institute Philharmonic in Maryland and completed her third season with the Manchester Music Festival.

As a student at the New World School of the Arts in Miami, Miss Case received the Most Outstanding Freshman Award and Best Section Player Award. In 1995, Sharon enrolled in the prestigious Interlochen Arts Academy in Interlochen, Michigan. The recipient of an NFAA Arts Award, she also received a full scholarship to Florida State University, later transferring to the Conservatory of Music at Lynn University to study with Mr. Greg Miller of the Empire Brass Quintet. She has performed with the Florida Sunshine Pops, Boca Pops, and the Palm Beach Pops.
