# Center for Terrorism Law

## Monthly Activity Report

### November 2012

1. The Center for Terrorism Law hosted a one-day conference at St. Mary's University School of Law, San Antonio, Texas, on Saturday, November 10, 2012. The conference was attended by over 100 participants. In addition 25 San Antonio ISD students received a lecture and tour by Professor Addicott at the Center for Terrorism Law. The conference featured Pastor Robert Dean, Jr. who discussed Christianity and Islam. Other legal and policy issues associated with the War on Terror were also covered. The conference was entitled: *Legal & Policy Issues Regarding the War on Terror*. The conference was free and open to the public.
2. Professor Addicott's detailed law review article entitled: *Rightly Dividing the Domestic Jihadist from the Enemy Combatant in the War Against Qa'eda – Why it Matters in Rendition & Targeted Killing*, has been submitted for publication to the Case Western Reserve Law School, Cleveland, Ohio. Addicott participated in a roundtable debate on this topic at the Frederick K. Cox International Law Center War Crimes Research Symposium on 7 September 2012, in Cleveland, Ohio.
3. Professor Addicott is working on a law review article regarding the Rules of Engagement. This article should be completed in early 2013.
4. One of the most critical missions of the Center for Terrorism Law is to provide legal assistance to military and law enforcement personnel who are unjustly treated as a consequence of the performance of their official duties. Currently, the Center for Terrorism Law is providing legal help to a Coast Guard officer regarding discriminatory treatment by the Department of Homeland Security and the US Coast Guard.

7. The Center for Terrorism Law has awarded **new fellowships** to select St. Mary’s law students for the coming year! Candidates were required to complete a rigorous process of application. This process required the completion of an extensive research packet designed by senior research fellows. This packet challenged candidates to answer complex legal questions utilizing research skills and formal citations. Additionally, candidates were asked to examine policies outlined in various congressional studies regarding U.S. foreign policy and the crisis in Syria and draft a concise report. Next, the candidates completed a formal writing sample over one of six topics related to national security. Those who submitted the most outstanding research packets were then asked to complete an interview before a panel of senior fellows. Other factors considered were references, resumes, and overall professionalism. Although a record number of applicants completed the process this year only ten second year law students and five third year law students were selected. Six seasoned fellows were asked to return this year - three of which were selected for senior command positions.
