Re: Evaluation of S&T Administrators

The Administrative Review Committee is a Standing Committee of Faculty Senate. This committee is charged with evaluation of administrators in accordance with a resolution passed by the Intercampus Faculty Council.

This year, the committee conducted evaluations of Vice-Chancellor Robinson, Vice-Provost Krishnamurthy, Vice-Provost Schwartz, Vice-Provost Allada, and Dean Goff. It is the responsibility of Faculty Senate to provide the results of these evaluations to the person evaluated and the next-level administrator to whom they report.

This year's assessment was similar to the evaluations used in previous years. To help assure confidentiality and anonymity, the assessment forms were available on-line through Blackboard.

The survey was available through Blackboard between March 1 and March 15, 2010. The numbers of respondents for the evaluated administrators are given below:

| Dean Goff: | 40 | 80% | 10% | 10% |
