ABOUT THE COLLECTION

Biographical History: Clermont Huger Lee was born March 4, 1914, in Savannah, Georgia to Lawrence Lee, MD and Clermont Huger Lee. She attended Barnard College before transferring to Smith College, where she earned a Bachelor Degree in Landscape Architecture in 1936. After completing her undergraduate degree, she attended the Smith College Graduate School of Architecture and Landscape Architecture, obtaining a master's degree in 1939. In the 1940s, Lee worked as an assistant to landscape architect Talmadge Baumgardner with the Sea Island Company.

In 1949, she established her own firm, becoming one of the earliest women landscape architects to practice privately in Savannah. She created designs and planting plans for several historic buildings in the city, including the Juliette Gordon Low Birthplace, the Andrew Low House, and the Green-Meldrim House. From 1951 to 1972, Lee developed and oversaw the renovations of five of Savannah's historic city squares including Green, Madison, Troup, Warren, and Washington Squares. Having joined the American Society of Landscape Architects in 1950, she worked with Hubert Bond Owens to establish the Georgia State Board of Landscape Architects.

In 1964 Lee transferred seventy-two acres of land to the Nature Conservatory for the creation of the Charles Harrold Nature Preserve. Lee, along with Mr. F. R. Dulany, had been deeded the land in 1958 by the widow of Dr. Charles C. Harrold, who bought the land in the 1930s. Located in Chandler County, near Metter, Georgia, the Charles Harrold Preserve protects ecologically significant land which includes two distinct habitats: a sandhill community and a mixture of flatwoods and alluvial swamp.

Scope and Content: The collection consists of Clermont H. Lee's research on the wild south Georgia shrub, *Elliottia racemosa* and the development of the Charles C. Harrold Nature Preserve in Candler County, Georgia. Materials span 1936 to 1994 and include correspondence, field notes, photographs, and published materials.

System and Arrangement: These files were arranged and organized by Clermont H. Lee. Her arrangement of the materials is undisturbed. Detailed notes containing background and

content information on the papers in the folders were prepared by Lee for the first eight folders. The originals and typed transcripts of these notes are in the front of each individual folder.
