Dear Mr. Dunnack:

I wish to thank you for the books which you forwarded. I had previously seen the book on Forts and I am very glad to own it.

In regard to Mr. Barry's works, I do not know of any actual list but as far as I know the following are the books that he has published at various times. There is one, "Pen Sketches of Old Houses", which is simply a book of pen sketches, no reading matter; "A Stroll By a Familiar River", a story of the Mousem River in my Town; one, "Old Block Houses"; one "The Chronicles of Kennebunk", which is short sketches of things of interest about our Town; and "A Stroll Through the Past". As far as I know that is all of his works. If I find others, I will endeavor to secure copies for your State library.

Most of Mr. Barry's works were in the same form as the book I just forwarded, with very few copies made.

At the time of Mr. Barry's death, in his Will he instructed his nephew and myself, as executors to preserve his historical data, etc., in some manner.

All summer we went through his manuscripts and endeavored to save everything that had not been published. And I expect in the near future that we will publish a book which will probably be a "A Stroll Through The Past" combined with a number of sketches and notes which we have found of value.
