Dear Mr. Rice:

Notice of your book, THE SHIPPING DAYS OF OLD BOOTHBAY, 1775-1917, recently came to our attention, and we promptly ordered a copy for the general lending section of the library.

We are writing now with regard to the Maine Author Collection, an exhibit of about a thousand books written by Maine writers or pertaining to the state, most of which are inscribed and presented to us. These books are shelved in the State Librarian's office, and are very interesting at present, attracting many visitors each year. We are, however, admittedly building for the future, and such a collection will of course present a veritable mine of information for future researchers and students of Maine's contribution to literature.

It is very kind of you to write to us about your fine book, SHIPPING DAYS OF OLD BOOTHBAY. We do not, unfortunately, have an inscribed copy in the Maine Author Collection. When we first wrote about the matter, you had a copy sent to us by your nephew, with an invoice. This copy we purchased for use in the lending section of the library.

The Maine Author Collection, however, is quite separate from the lending section, and the collection books do not go out of the library at any time. They form a permanent exhibit, and include old books and new ones: from Madam Sally Wood's early novels, through John Neal, Henry Wadsworth Longfellow, Elijah Kellogg, and authors of this period, down through the years to Kenneth Roberts, Rufus M. Jones, Mary Ellen Chase, and other modern writers. It is the one existing collection that includes (or attempts to include) all the works of all Maine authors.

You can understand our disappointment at any omissions. There are such omissions, we confess, but we are steadily and earnestly trying to remedy this unhappy situation; and we shall continue to hope that when you are in more comfortable health we may receive a gift copy of SHIPPING DAYS OF OLD BOOTHBAY for the Maine Author Collection.

Mr. Catherwood's request regarding the naming of Augusta has been transferred to our Research Librarian, Mrs. Marion Cobb Fuller, who will no doubt write to Mr. Catherwood about the matter.
