Know all Men by these Presents, THAT

Whose name is undersigned & seal hereunto affixed appointed an AGENT by the General Court of the Commonwealth of Massachusetts, to make and execute conveyances, agreeably to resolves of said Court passed *the seventeenth day of June eighteen hundred and twenty* and pursuant to resolves of said Court passed *the fourth day of March eighteen hundred and twenty eight, eighteenth day of February eighteen hundred and twenty nine, and eighteenth day of February eighteen hundred and thirty one*

do give, grant, convey and confirm, and by these presents, in behalf of said Commonwealth, have given, granted, conveyed and confirmed unto *Wesley S. Johnson of the town of Brandon, in the County of St. Lawrence, in the State of New York, Assignee of Comfort Johnson formerly a Sergeant in the Massachusetts Regiment of Artillery commanded by Col. Bullwin*

who enlisted as a Soldier into the American Army to serve during the revolutionary War with Great Britain, and who was returned as a part of the Massachusetts quota of said Army, and who did actually serve in said Army the full term of three years, and was honorably discharged, and to his heirs and assigns, all the right, title, and interest of said Commonwealth, in and unto a lot of land numbered *One & Two in the 9th range of lots* situate and lying in a township, in the County of *Somerset* in the State of Maine, *Numbered four in the 9th range of townships north of W. Pennington's Reserve Purchase*

said lot contains two hundred acres, bounded *On the north by lot No 182 in the 10th range, on the east by lot No 3 of the 9th range, on the south by lots No 8 & 9 in the 8th range, and on the west by the town line*

according to a plan of the survey of said township made by *Eleazer Coburn* in the Autumn of the year *eighteen hundred and eighteen* and will more fully appear on reference being had to said plan now on file in the Land Office.

To Have and to Hold the aforegranted premises to the said *Wesley S. Johnson* his heirs and assigns, to their use and behoof forever. IN TESTIMONY WHEREOF, I have hereunto set my hand, and affixed my seal this *26th* day of *November* in the year of our Lord eighteen hundred and *thirty two*

Know all men by these presents, Ulicius Comfort Johnson of the Town of Piermont in the County of Sullivan and State of New York, formerly a soldier of the Revolution, who was entitled to Bounty Land from the Commonwealth of Massachusetts on account of his services as a soldier of the Revolutionary war, in the Corps or Regiment of Artillery Artificers in the Massachusetts Line of the Continental Army, and whereas the said Comfort Johnson has assigned and set over to me Hiram S. Johnson a resident of the Town of ^{of Canton County} ~~of~~ Sullivan and State of New York, all his interest right and title of or in and to the aforesaid Bounty Land, by his assignment bearing date the fourth day of October instant, reference to which assignment is here had - Now Therefore Know ye that I the said Hiram S. Johnson for a valuable consideration by me received do hereby constitute and appoint Francis Willson my true and lawful attorney for me and in my name to take a title and patent from the said Commonwealth of Massachusetts of the said Bounty Land above mentioned, and for me to locate the same agreeably to the provisions of the Laws of the said Commonwealth, and do authorize my said attorney for me and in my name to sell assign and dispose of the said Bounty Land, and all my right title and interest of in and to the same, as fully, completely and absolutely as I myself could do were the same personally done by myself, hereby expressly ratifying and confirming all the acts and deeds done and made by my said

attorney in the premises - In witness whereof

charge signed by Gen. George Washington ~~and Gen~~
which discharge certified that the
said Johnson had served during the war, and that he
for six years had been honored with a badge of merit
for his faithful service, which said discharge has been
lost or destroyed more than thirty years.

County of St. Lawrence 3^d: Comfort Johnson of the Town of Piermont
in the County of St. Lawrence and State of New York late
a revolutionary soldier and drawing a pension as such
under the statute of Congress of the 18th of March 1818 aged
seventy eight years, do upon oath testify and declare
that I enlisted into the service of the United States
for the term of "During the War" and that I contin-
ued in the service aforesaid until the close of the same
when I received an honorable discharge at the termina-
tion thereof from the Regiment or Corps of Artillery
artificers of the State of Massachusetts under the com-
mand of Capt. Comdr. Thos. Patten and when I was a
sergeant: I further testify that in the year 1780 I ser-
ved in Captain Thomas Patten's - company in the Re-
giment or Corps of Artillery artificers in the line of the
State of Massachusetts under the command of Captain
Comdr. Thomas Patten and Gen. Henry Knox.
I further testify that I have never received a title or patent
for the quantity of Land promised to me on the part of
the Commonwealth of Massachusetts or any commu-
tation money for the same.

Therefore know all men by these presents that
Comfort Johnson aforesaid do hereby assign all my right
title and interest of in and to the aforesaid quantity of Bounty
Land due from the aforesaid Commonwealth of Massachu-
setts unto Hiram S. Johnson of the Town of Canton
in the aforesaid County of St. Lawrence and State of New York
he having paid me a valuable consideration therefor
and the aforesaid Hiram S. Johnson is hereby invested with
all my right title and interest and demand against the
aforesaid Commonwealth of Massachusetts, relating
to said Bounty Land and may at all time and pleasure
make the location and take out the patent describing and
