I *Joe Withie* of *Industery* in the County of *Somerset* and State of Maine, aged *Seventy five* years, do, upon oath declare, in order to obtain the benefit of a Resolve of the Legislature of Maine, passed March 17, 1835, entitled a "Resolve in favor of certain Officers and Soldiers of the Revolutionary War, and the Widows of the deceased Officers and Soldiers," that I enlisted *as a private in the year 1781 into Capt Johnsons Company of the 6th Maine Regt of the Mass Army in the Army of the Revolution and was discharged at West Point in the year 1783 in the month of June having rec'd on honorable discharge I am now upon the Pension roll of the U. Joe Withee of Industry in the County of Somerset and Dist of Maine,  
aged fifty six years a resident Citizen of the United States, de-  
siring to obtain the provisions made by the law of Congress, en-  
titled, "An Act to provide for certain persons engaged in the land  
and naval service of the United States in the revolutionary war"  
and to be placed upon the pension list of the District of Maine,  
do on oath testify and declare: That after having been in the  
Continental service for six months with the New Hampshire troops,  
I in March, 1781. enlisted in the Company of Artillery Commanded  
by Capt Shaw of which Williams Johnson was Capt Lieutenant,  
in Col. Branes' regiment of Mass: Artillery, and served until  
December 1783, when I received an honorable discharge under  
the hand of Maj: General Knox - About four years ago this dis-  
charge was accidentally destroyed, by falling into the hands of  
a child, and it is not now in existence. I was in the battles of  
Rhode Island and Valentines Hill. By reason of my reduced  
circumstances in life, I am in need of assistance from my  
Country for support. (Signed) Joe Withee.

having been duly cautioned and examined, made oath to the  
truth of the foregoing declaration by him signed. Before me

Moziel Withee of Number three in the County of Somerset and  
Commonwealth of Massachusetts, of lawful age testify and de-  
clare that sometime in the month of May or June A.D. 1781 I  
arrived at West Point. (I being a Soldier in the Army of the U-  
nited States) and on my arrival there I found my brother Joe  
Withee who (as I am well knowing) belonged to Capt. Shaw's Com-  
pany of Artillery in Col. Branes' Regt. of the Artillery of Massachu-  
setts. I continued at West Point until the month of November A.D.  
1782 when I was discharged from the Army, and I am knowing  
that the said Joe belonged to the Continental Army from the  
month of June 1781 until the month of November 1782, and I have  
no doubt (although I cannot have personal knowledge) the said

See enlisted in the Company aforesaid sometime in the month of March 1781 and continued in said Company until December 22. 1783. (Signed) Uzziel Withers.

Somerset Co. April 29<sup>th</sup> 1818. Then the above named Uzziel Withers personally appeared and made solemn oath to the truth of the above declaration by him subscribed. Before me.

I Amos Childs of Hallowell, in the District of Maine of lawful age, upon oath testify and declare that I well knew Joel Withers, a Continental Soldier in the Revolutionary War, in Capt Johnson's Company, and Col. John Francis reg<sup>t</sup> of Artillery, Massachusetts Line, he was a three years man, I served with him more than two years & half, and the said Withers was discharged at the same time I was, viz. at West Point. Dec 22. 1783. (Signed) Amos Childs.

I hereby certify that the foregoing pages numbered from one to two inclusive, are truly copies from the originals on file in the Pension Office, War Department. And I do further certify that it appears from a Register of final Settlement Certificates, issued by John Pierce, Esq. Pay Master General, and Comptroller of the Army accounts of the United States, that Uzziel Withers received three certificates, all dated the 5<sup>th</sup> of March 1784. One for \$45.<sup>50</sup>/<sub>100</sub> due January 1. 1782, another for \$100. due January 1. 1783, and another for \$88.<sup>50</sup>/<sub>100</sub> due on the first of January 1784. — (Signed) B.
