Mrs. C. I. Barker, of Lewiston, has in her possession the picture of Mrs. Mary Gorham Irish, the first white child born in Gorham, Maine, and her own great-great-grandmother. The picture is an ancient daguer-reotype, after a pencil sketch from life, and is very greatly prized by its present owner. Mrs. Irish was the daughter of Capt. John Phinney, the first settler of Gorham. She died in 1825, aged 89 years.

The gates at the railroad crossings in Autown ranks among the best hay producing towns in Maine, and its farmers are as a rule rosperous and many of them owners of quite valuable estates. The village of Gorham, the fifth station out of Portland on the Portland & Rochester railroad, is a quiet place with but few manufacturies, there be died in 1825, aged 89 years.

Nearly every store in Saccarappa is lighted with incandescent lights and many of the houses are. For house lighting the incandescent lights are furnished at the rate of \$5 each for the first two, lamps and all exceeding that number at the rate of \$3 per light for one year. The rate for stores is \$5 per light, no reduction being made for more than two lights. The lights may be burned all night every night in the year at this price. At present the lights are turned on at 3.30 in the afternoon, and the electric machines run uptil 7 o'clock in the morning. The arc lights are of 200 candle power and cost the town \$100 cash per year. The electric light company is prepared to furnish motors and power for the same for manufactories of all kinds, and their plant is arranged so that another water wheel with a capacity of 130 horse power can be easily put in when it is needed. There is abundant water power at Saccarappa for running an electric light plant of any size, and many citi-

guments by counsel, and both gentlemen. amuel Hoar for the defendants and General Butler for the plaintiff, were early on hand this morning, with big piles of papers, locuments and notes. On the counsel's table was a whole library of legal lore. Counsel Hoar, looking at the array of volimes said: "Your honor, will counsel be allowed to read authorities in the course of

The court--"Well, gentlemen, I think counsel are old enough to do everything proper

Counsel Samuel Hoar, after briefly explaining the technical form of the suit, and that it was for the recovery of securities alleged to have been wrongfully converted to their own use by the defendants, told the their own use by the defendants, told the jury that a separate finding must be given on each item in the declaration. Each item was in reality a separate case, and each depended on different occurrences and circumstances. "This case," said Mr. Hoar, "is one of great importance to my clients. These two defendants are men of good standing in this community; they have gone in and out in the presecution of their business for nearly 15 years, respected by allmen. If there was any plot or stain on their character you may be sure that the diligent counsel for the plaintiff would have spread it before the jury and the court.

"It is not so much a question of money with the defendants, as it is what their future business life shall be, for upon your decision depends whether they shall have a fair or smirched reputation. It means honor or disgrace to them. I tell you, gentlemen, a mistake made against the defendants would carry with it far-reaching misery.

"Take another view. Here we have a mother and an only child. The plaintiff is 73 years of age and infirm. Well, in the natural course of events that son will be the sole heir of his mother's property and estate. She is suing for this property, and the case depends on the son's testimony. I say, gentlemen, that this suit is being prosecuted almost entirely for the son's benefit, and yet he is the principal witness.

"Ah, gentlemen, what a witness he is! If we are to believe the plaintiff's counsel (and he takes that position in the case) Edward Preble is a thief! The property in question was his mother's, and Edward Preble, the thief, stole it. He comes before you and confesses that he stole his mother's bonds, and he confesses tha he lied to his mother to cover his stealings. Even when she repreached him with living extravagantly he lied to her, because he told her he was making plenty of money by stockbroking. Edward Preble stands before you by his own confession as a liar and a thief.






