A BRIEF ANALYSIS COVERING SELECTED MAINE LABOR MARKET AREAS

AUGUSTA LABOR MARKET AREA

The employment situation in the Augusta Labor Market Area worsened in January 1982, as employment dropped and unemployment rose. Resident employment declined 290 to 26,610, while the number unemployed grew to 2,320, 590 more than in December. The unemployment rate climbed to 8.0 percent, well above the preliminary rate of 6.0 percent for December. The rate for January 1982, however, is below the rate of 9.4 percent evidenced in January 1981. Employment losses in textile mill products and apparel, leather and leather products, and paper and allied products, coupled with declines in nonmanufacturing, including government, contributed to the overall decline in resident employment. The corresponding unemployment rates for the State and the nation were 8.3 percent and 9.4 percent, respectively.

BANGOR-BREWER LABOR MARKET AREA

Economic conditions in the Bangor-Brewer Labor Market Area experienced a slight downturn in January 1982. A decline in resident employment from 40,400 to 38,000, combined with an increase in the number of unemployed persons from 2,300 to 2,700, resulted in an unemployment rate of 6.6 percent in January. The preliminary rate in December was 5.4 percent. Employment in manufacturing remained relatively stable, with small gains in nonelectrical and electrical machinery, equipment, and supplies and textile mill products offsetting nominal losses in food and kindred products and paper and allied products. Contract construction, wholesale and retail trade, and government were responsible for a sharp decline in nonmanufacturing employment.

BIDDEFORD-SANFORD LABOR MARKET AREA

During January the Biddeford-Sanford Labor Market Area suffered a third consecutive month of rising unemployment. Total unemployment increased 500 to 2,600 in January. Resident employment dropped by 200 to 28,300 in January from a preliminary estimate of 28,500 in

December. This combination caused the local unemployment rate to jump to 8.4 percent compared with a preliminary rate of 6.9 percent in December. Seasonal layoffs in leather and leather products, contract construction, textile mill products, and transportation equipment contributed to the downward economic trend.

LEWISTON-AUBURN STANDARD METROPOLITAN STATISTICAL AREA

Economic conditions in the Lewiston-Auburn SMSA suffered a substantial setback in January, as the local unemployment rate rose from a preliminary rate of 6.5 percent in December to 9.0 percent in January. Meanwhile, the State and national unemployment rates stood at 8.3 percent and 9.4 percent, respectively. Between December and January, total joblessness in the Lewiston-Auburn SMSA increased by 1,000, from 2,400 to 3,400. Nonfarm wage and salary employment fell to 33,300 in January, its lowest level since July 1980. In January, seasonal layoffs were reported in contract construction and wholesale and retail trade, which lost 500 jobs following the Christmas shopping season. Other layoffs possibly linked to the national recession were reported in metals and machinery, leather and leather products, rubber and miscellaneous plastics products, and government.

PORTLAND STANDARD METROPOLITAN STATISTICAL AREA

The local unemployment rate in the Portland SMSA rose from a preliminary estimate of 4.6 percent in December to 5.7 percent in January. Total unemployment increased from 4,300 in December to 5,200 in January, with layoffs in wholesale and retail trade, services, contract construction, and government. Despite the monthly setback, economic conditions in the Portland SMSA compare quite favorably to the State and nation, which recorded January unemployment rates of 8.3 percent and 9.4 percent, respectively.

WATERVILLE LABOR MARKET AREA

Economic conditions in the Waterville Labor Market Area, based on unemployment, continued to slide as the unemployment rate for the area was again above the rate for the State. An increase in the number unemployed from 1,430 in December to 1,810 in January and a decline in employment from 20,240 in December to 19,310 in January combined to produce an unemployment rate of 8.6 percent, well above the preliminary rate of 6.6 percent in December. In addition, the rate for January 1982 is above the rate of 8.3 percent for January 1981. The increasing unemployment rate is in part the result of the continuing influence of the loss of two manufacturing employers, Ft: Halifax Packing Co. and Wyandotte Industries, during 1981. Additionally, January employment losses occurred in nonmanufacturing, paper and allied products, and apparel. The corresponding unemployment rate in January for the State stood at 8.3 percent, while the national rate rose to 9.4 percent.
