#### **Description of the Papers**

In 1998 the South Portland Citizens for Justice campaigned in support of the city's proposed Human Rights Ordinance, that was to be voted on, on November 3, 1998. The Archives contains newspaper articles (clippings and entire issues) that relate to the ordinance. Also included are items from the South Portland Citizens for Justice organization, such as correspondence, publications, posters, stickers, and press packets. The only anti-gay/anti-Ordinance item is in Folder 5, a copy of The Gay Agenda, published by Paul Volle and the M.R.D.A. (?).
