#### Campaign Kickoff on March 9!!!

At the recent CCHR Steering Committee meeting, those attending reconfirmed our commitment to focus energies in 2000 on passage of the Civil Rights law that will go to referendum this November. In order to do that we voted to form a Political Action Committee (PAC).

Youare invited to an important local campaign kickoff in Belfast for the newly organized Waldo County for Equal Rights (WCER) group. A decisive victory in November will ensure that sexual orientation will be an included protected category under the Maine Human Rights Act. This bill has been especially long awaited by our gay, lesbian, bisexual and transgendered community. The legislature is expected to pass the amended version of L.D. 2239 "An Act to Ensure Civil Rights and Prevent Discrimination" in late February or early March.

This meeting will take place on Thursday March 9th at St. Margaret's Parish House, 90 Court Street (corner of Park St.), Belfast. Light Refreshments and music from 6:30 to 7:00 P.M. Meeting from 7:00 to 9:00 P.M. Information will be given about the civil rights bill, statewide activities and local efforts. We also want to hear your ideas and help people find out the best way that they can help the campaign. We hope to get people working locally in their own towns, identifying voters, doing education and fundraising efforts. We also need help on a county level as part of a steering committee that will help oversee the local voter identification work, education, media work, outreach and fundraising.

### Bill Supporters Outnumber Opponents at LD 2239 Hearing

Supporters outnumbered opponents among the three hundred people attending the February 16 legislative hearing on LD 2239 before the Judiciary Committee. LD 2239, "An Act to Ensure Civil Rights and Prevent Discrimination", amends the Maine Human Rights Act by adding "sexual orientation" to the list of prohibited bases for discrimination in the areas of employment, housing, credit and public accommodations. Senator Abromson offered an amended bill, the result of an agreement between the Roman Catholic Diocese and the Maine Lesbian Gay Political Alliance (MLGPA).

The Judiciary Committee was expected to vote on the bill at a work session scheduled Wed. February 23 at 1:30 p.m. Then the bill goes to the full legislature. Call 287-1692 for bill status; representatives at 287-1400; senators at 287-1500. Access is also available by Internet and email.

Please contact your legislators as soon as possible to express support for the amended bill.

### ML King Celebration in Belfast

We huddled together on a windy night in January, with a wind chill of what seemed like thirty below zero. It was the annual Martin Luther King holiday march and celebration on January 17.

Fortunately, we got our candles lit and marched quickly just a few hundred yards up Church St. from the Belfast Post Office to the First Church. Other celebrations had been held that day in Orono, Waterville, Lewiston, Portland, and other towns and cities in Maine.

Social Justice and Truth in History member London Mitchell, a former Bath Iron Works employee and civil rights advocate with the shipyard's union, spoke about his own history as an African-American in Maine and some current problems of racism that affect all Maine people.

We read excerpts from Martin Luther King's "I Have a Dream" speech and from his "Letter from a Birmingham Jail." We discussed and debated civil rights, nonviolence, and what we could do to continue King's efforts for social change.

We ate cookies, had cold and hot drinks, and went home feeling a little warmer and more hopeful inside than we had earlier in the day. Thanks to Larry Hess, Percy Daley, and all the others who organized and participated in another celebration of the life of Martin Luther King Jr. in Belfast.

### Contact Legislators LD 2239

Please let them know you want them to vote to pass LD 2239 and put it out to a public vote. You can reach your State Senator at 1-800-423-6900 and your State Representative at 1-800-423-2900.

Our state senator Susan Longley of Waldo County, an active supporter of civil rights, has taken a position against the bill because she believes that the public should not vote on minority rights.

Rep. Donald Berry of District 109 (Swanville, Searsport, Morrill, Waldo, Lincolnville, Belmont and Searsmont) - 342-5675. He's never voted for the bill.

Rep.Carol Weston of District 110 (Burnham, Freedom, Knox, Liberty, Montville, Palermo, Thorndike, Troy and Unity)–589-4481. Has stated that she will not vote for the bill.

Rep. David Lindahl of District 105 (Belfast, Isleboro and Northport)-338-1430. He has voted favorably in the past but was cautious this time "depending on the wording".

Rep. Joseph Brooks of District 107 (Brooks, Frankfort, Jackson, Monroe, Prospect, Stockton Springs and Winterport)—223-5041. He has been supportive in the past.

Please talk to these folks and let Mitzi know (338-5889) what they say about the reasons they

will vote for or against this bill.

If you do talk to someone previously opposed to the bill, ask if they are aware of the changes in the bill. Let them know there's new language that makes it clear that the bill:

\*Does not grant special rights to any person or group covered by the Human Rights Act

\*Does not confer legislative approval to any person or group covered by the Act

\*Does not endorse or include sexual behavior

\*Does not protect sexual attraction to a minor by an adult

\*Does not require any school to promote or teach any sexuality or sexual orientation

\*Does not establish any affirmative action based on sexual orientation

\*Does not require or prohibit employers from providing domestic partnership benefits
