## Maine Faces LD 1116 Veto Campaign

On Friday, July 4, Michael Heath announced that the Christian Civic League and Christian Coalition of Maine had reached their goal of 1000 volunteers to circulate anti-gay petitions. The petitions will ask voters whether they want to veto LD 1116, An Act to Prevent Discrimination, the bill we worked 20 years to pass.

It comes as no surprise that the governor, the legislature, the business community, and many in the religious community strongly oppose discrimination. Drawing on some of these allies for a press release we issued on July 7, Senator Joel Abromson stated that "the people of Maine spoke on this issue in 1995 and the Legislature and the Governor acted to protect the rights of gay and lesbian citizens in 1997. It is clear that Maine people will not tolerate discrimination."

Reverend Eric Kelley, minister of the Williston West United Church of Christ, said, "I deal with real human issues every day and we never have enough resources to meet the needs. It is alarming to me that a portion of the Christian community is focusing its energy which is so desperately needed elsewhere on depriving a group of Maine citizens of their basic human rights."

And finally, Dana Connors, President of the Maine Chamber and Business Alliance, stated, "Discrimination does not reflect what Maine is all about, and it most assuredly does not reflect the values of Maine's business community. Our employees, our co-workers, our customers and our suppliers are all entitled to know that the dignity of the individual and respect for minority rights are values that the business community holds dear."

In order to successfully oppose the people's veto, Maine Won't Discriminate will probably resurrect itself for the task. MLGPA has been issuing press releases and arranging press conferences around this issue thus far, but MLGPA will not be the central organizing unit of this campaign. Maine Won't Discriminate became a household name in 1995, and it is probably the best chance we have of winning this issue in a public forum. And that's because... Maine Still Won't Discriminate.

Currently we are waiting to review campaign strategy proposals. There will most likely not be a decline to sign component to the campaign. (We have never succeeded in preventing signature collection in the past.) We will spend the summer planning and preparing for the best possible approach to win this campaign, which will kick off in early September. If you have any suggestions or comments, the MLGPA phone line is always open.



If more than 50,131 signatures are gathered and verified by September 4, 1997, the future of L.D. 1116 will be decided by popular vote on the November ballot.

### **Grant for Hate Crimes Protection**

MLGPA was awarded \$5000 from the Maine Community Foundation (MCF) for a Hate Crimes Prevention program. MLGPA's grant was a portion of MCF's two-year matching grant from the National Lesbian and Gay Community Funding Partnership. The purpose of MCF's funding is to promote greater understanding of GLBT issues in Maine and in so doing address issues of diversity, inclusiveness and acceptance of differences.

The Maine Community Foundation was one of 16 community foundations nationwide selected to participate in this funding initiative. MCF made its funding decisions to Maine organizations based on the following priorities:

- ▼ guaranteeing civil rights for GLBT people and protection against violence
- ▼ strengthening community education to reduce oppression and counter anti-GLBT fear
- ▼ broadening recognition of, and rights for, GLBT families
- ▼ increasing education to improve the quality of GLBT health care
- increasing cultural, social, recreational activities for diverse GLBT communities

MLGPA was thrilled to have received \$5000 for its work in hate crimes. Beginning in the fall, MLGPA will further develop and implement a statewide hate crimes prevention program that will have as its goals: 1) to increase hate crimes awareness in the GLBT and non-GLBT communities, 2) to increase GLBT safety and reduce the risk of being victimized, 3) to increase hate crimes reporting, and 4) to recruit and train project staff and volunteers.

# Opening Reception for Deborah Kass

A showing of works by Deborah Kass, a New York artist and visiting faculty member of the Skowhegan School of Painting and Sculpture, will open July 12 and run through August 16 at the O'Farrell gallery in Brunswick. Kass has made a name for herself in the art world as the Jewish, lesbian answer to Andy Warhol. She so identifies with the artist that she has appropriated not only his style but also his imagery. Working with a technique identical to Warhol, the artist uses photography as the first in a series of steps to create a finished work of art.

Instead of Warhol's "Double Elvis," Kass appropriates the image of one of her icons, Barbra Streisand. In "Double Yentle," a double image of actress Streisand wearing a yeshiva boy's uniform transforms this pop celebrity into a cool and ironic lesbian icon.
