

Mission Committee Meeting January 11th 1938

The regular monthly meeting was held in the Choir Room on above date Dr Peckham presiding. The following members being present Mrs Connolly, Mrs Mackelden, S. Jones, F. Brown & Hornsby and W Lyall, Mrs Stuart reported sick and J Blackwell was working.

Dr Peckham opened the meeting with prayers.

The minutes of previous meeting were read and an addition made re: acceptance of Candelsticks minute then were approved.

The Treasurer's report by Mrs Auer was then read and showed a Balance of \$5-82 on Jan 1st. Report received & Filed.

Mr Brown reported on Special report fund. He has received credit of \$1-68 from Lumber Co which leaves a Balance in fund of \$7-11. The cracks on Basement walls had not been filled yet owing to weather and screens had not been put on Basement windows yet owing to lack of material but he hoped soon that they will be done like the others report received & Filed.

A letter was read from Secretary of Altar Guild thanking the Committee for Purchasing Green Burses and Veil. Received & Filed.

Dr Peckham read a letter from Bishop Davis thanking us for our large Christmas Offering for his Discretionary fund also stating our application to be in Union with Diocese had been received and we have to elect a Delegate for next convention and have him ready to be seated when the convention opens and acts upon same. This report was received and matter of Delegate was left over until nearer the convention, agreed.

The Clerk then read a communication from the Bishop saying he had not received the Title Deeds to Redeemer property yet but he would write to Mr. Orr of St Peter's Church right at once and ask him to draw the Deeds as soon as possible including the Original Land. Letter received & Filed

D^r Peckham then reported that M^{rs} Auer gave him a sketch on pledges paid on 1937 as follows.

The Canvas for 1938. shows pledges \$735.80 as these pledges are mostly from those that pay regular and a few new pledges it looks as though we will be better than last year as there will no doubt be more pledges coming in. As there was no further Business the meeting was adjourned with Prayers.

The regular monthly meeting was held in the Choir room on above date D^r Peckham Presiding The following members were present, M^{rs} Connolly Warden Fred Brown, Treasurer Sam Jones, Frank Hornsby Jack Blackwell and Clerk W^m Lyall. M^{rs} Mackelden and M^{rs} Stuart were reported sick. D^r Peckham opened the meeting at 8.09 P.M all members rising for the benefit of prayers. The minutes of the previous meeting were then read and approved as read M^r. Brown reported there had been no special activities by Repair Committee owing to weather being bad for outdoor work. He reported there was \$102.11⁰⁰ in special repair fund. M^{rs} Connolly asked M^r. Brown if it were possible to have the junior altar painted before Easter M^r. Brown promised to have it done. M^r. Jones then read Treasurer's report made by M^{rs} Auer, after being corrected by D^r Peckham, showed a Deficit of \$16.19⁰⁰ moved report be received and filed. M^{rs} Connolly reported the Auditing committee had been auditing the Books and found them favorable she promised to give full report next meeting. D^r Peckham read a communication from the Bishop regarding the Title Deeds of the property. The Bishop's letter showed he had received a copy of the deeds which comprise of 5 Lots 1. 3. 5. 7. 9. on Twenty-third St which makes a frontage on 23rd St of 204 feet and a frontage on Pine Avenue of 124 ft which means the full original property

has been turned over to the Diocese. Dr. Peckham also read a communication from Bishop Davis regarding the Furniture, Vestments, Etc of St James' Church Buffalo which will close at Easter. The Vestry of St James are keeping everything at present and putting them in storage at least that is their intension at present Dr. Peckham reported that at a luncheon for all the Priests in the Diocese The Bishop gave him permission to appeal to all the parishes in the Diocese for the Various things we need in our parish. Dr. Peckham said every parish in the Diocese was represented except 3 and his appeal was well received and he hoped there would be some results from same. Dr. Peckham said the card table in his room was missing. Mr. Brown said he had given Al MacFadyen permission to us his (Mr Brown's) table and probably he had got the wrong table but he would see it was back next day. Dr. Peckham wanted to know just what was to be done with the Large Common Prayer Book of 1892 as it was never used now. The matter was left in Dr. Peckham's hand to give it to one of our older members who would use it and whose eyesight may keep them from reading the Smaller Books. The matter of taking care of Altar Curtains and Dorsals was brought up. At present everything is being squeezed in a Big Drawer and it is a very unsatisfactory way of keeping them. The committee thought a

cupboard could be made for about \$10.00 that would hold all the Curtains and leave more room in the Drawer for the other material. Dr. Peckham said if Altar Guild would give \$5.00. He would give \$5.00. out of Discretionary Fund. The matter of having a stairway leading from Choir room to Basement was discussed. As there is only one stair now down to Basement it was found to be inadequate for our needs the committee estimated it would cost about \$25 or \$30 Dollars to Build one leading down from Choir room. The matter was left open at present. As there was no further Business the meeting was adjourned with prayers by Dr. Peckham

The Regular monthly meeting was held on above date in the Choir room Dr Peckham presiding. All members were present except Mr Stuart (Alternate) who is sick. Dr Peckham called the meeting at 8. P. M. Sharp all members rising for the Benefit of prayers. The minutes of previous meeting were then read and approved as read. The Treasurer's report was then read which showed a Balance of \$22.32. with unpaid Bills totaling \$80.66 which would leave a Deficit \$58.34. Report received & filed. A Bill from Mr. Hutton Diocesan Treasurer of \$9.34 for assessment for March was read & ordered Paid. A Bill for 75 Cents for New record Book to Clerk was received and order paid. A communication from the Duplex Envelope Co. regarding envelopes for next year was left in hands of Financial Committee with instructions to note the Discount if Ordered by March 31st. A Communication was read from Samuel Jones, Treasurer submitting his resignation as Treasurer to be effective at this Date. Dr Peckham spoke on the matter as he had talked with Mr Jones on the subject and Mr Jones health was not so good and to protect his health he had to be released from the strain of the work as Treasurer. A motion was made and seconded that the resignation be accepted with deep regret as Mr Jones has always been a faithful and hard worker Carried. Mr Jones

will stay on the Committee and retain his place on the Financial Committee. Dr Peckham said so far in his appeal to the diocese he had received 3 Surpluses, 2 Collars and Hassocks for the Choir. Dr Peckham reported that the table had been returned with one leg broken and Mr. Brown promised to repair it. Under New Business Mr Lyall was appointed, to fill the unexpired Term of Mr Jones, as Treasurer. The matter of Stairway was brought up and the matter was left in the hands of Mr Hornsby to go ahead as the Dramatic Club was willing to bear the cost. It was also decided Dramatic Club purchase a Lock and Keys for the Trap door Dr Peckham to have one & Dramatic Club to have one so door will always be locked when not in use. The matter of Cupboard for Doreal Curtains was brought up It was believed that the Cupboard used at present by some of the Choir would be good for Captains and there was room in vestment cupboard for the vestment now in big Cupboard so that would leave the Cupboard free for Curtains. The matter of annual visit of Sons and Daughters of St George was brought up and Dr Peckham was asked to write to Mr Baker and Mrs Hilda Roth the respective Secretaries inviting both organizations to a Church Service in April Carried. The matter of an Easter letter to the Parish was brought up

it was agreed we send the Bishop's letter a Pastor's letter and a Mission Committee letter and a Easter offering Envelope to all members of the Parish Dr Peckham to draft the pastoral letter and Wm Lyall the mission committee letter. The Clerk was instructed to write Bishop Davis asking if the Department of Missions had granted an appropriation for repairing the roof so that something might be mentioned about it in the Easter letter. As there was no further business the meeting adjourned with Prayers

The regular monthly meeting was held on above date in the choir room. Dr Peckham presiding the following members being present. Mr Connolly, Mr Mackelden and Mrs Fred Brown, Frank Hornsby, Samuel Jones and Wm Lyall. Mr Stuart and John Blackwell being absent. Dr Peckham called the meeting to order at 8.00 P. M. All the members rising for the Benefit of Prayers. The minutes of the previous meeting were read and approved as read. The Treasurer then read his report as follows. Total Revenue for month \$179.74. Disbursements \$167.62 which left a Balance \$12.12. Unpaid Bills Totalled \$52.60 which made a Deficit of ~~\$40.48~~. The report was received & filed a Bill to Mr Auer assistant Treasurer for 65 - 2 Cents Stamps = \$1.30 for Quarterly reports was received and ordered Paid Mr Brown reported the Easter letters & Envelopes had been sent out. Mr Hornsby reported the Back Stairway to the Basement was almost finished there was just a few minor details to complete it was thought more advisable to put a Bolt on inside of Door instead of Lock as at first mentioned. Mr Brown promised to get a Key for the new Piano and to repair the Card table before next meeting He also promised to fix the light switch in the Basement. The Clerk read a communication from the Bishop regarding the repairs on the roof. The Bishop had turned the matter over to Rev James Cosby as Chairman of Committee of Department of Missions. A communication was read from Rev Cosby asking a full estimate from Mr Kelly of the

work to be done on the roof and he promised to come to the Falls soon after Easter as soon as he familiarized himself with the Estimate. The Clerk reported he had communicated with M^r Kelly of the Connor roofing Co and had forwarded the Estimate to M^r Cosbey. M^r Connolly wanted to know about M^{rs} Templar's Salary while playing the Organ for Church School. The Treasurer said he had paid M^{rs} Templar's Salary in full and the school was now indebted to Treasury for \$3.00. for Jan. Feb. March. She promised the Treasurer to send Cheque for same. M^r Connolly thanked M^r Brown for Painting the Junior Altar. D^r Peckham announced both the Sons and Daughters of S^t George had accepted his invitation to attend S^t George's services at the Redeemer on April 24th. D^r Peckham announced it was time an Alternate to the Diocesan convention be selected as his name had to be in before we had another meeting. Wm Lyall was selected to Alternate the Warden M^r Brown. M^r Brown promised Fred Brown Jr. would take D^r Peckham to La Salle after services on Easter Morning. The matter of some one entering the Building through the window about the roof of out house was brought up and it was agreed to put a screw in window so it could not be opened from outside. M^r Connolly reported the floor in Basement near the stage was broken. M^r Hornsby promised to see about it. The Dramatic

Club asked for hall Monday Eve 18th for a party which was granted. M^r Brown spoke about having a list of younger men & youths to act as side men at the services their Duties to consist of Ushers, handing out Prayer & Hymn Books and taking collections. The matter was left in M^r Brown's hands to get a list of those 16 years or over to do this work. A list of members who seem to have taken no interest in the Church for a long time was gone over and after some had been taken of the rolls as having left our Church. The Centennial Committee under Chairman Harry Allinson agreed to visit the others and see if they could be brought back to the fold. M^r Allinson agreed to report to D^r Peckham by May 3rd so D^r Peckham can report to the Bishop when he comes on May 8th for his annual Visit & Confirmation Class. As there was no further Business the meeting adjourned.

The Regular monthly meeting was held in the Choir room on above date D^r Peckham presiding. The following members being present. M^{rs} Connolly, M^{rs} Mackleden, Fred Brown, Frank Hornsby and W^m Lyall, D^r Peckham opened the meeting at 8.17 P. m. All members rising for the benefit of prayers. The minutes of the previous meeting were read and approved as read. The Treasurer read the monthly Financial report as follows Total Monthly receipts \$178.18[¢] Disbursements \$164.68[¢] leaving a Balance of \$13.50[¢] no unpaid Bills. Moved & Seconded report be received and filed. M^r Brown reported he had got a Key for the Piano, The light switch in the Basement had been fixed, The Lawn mower had been repaired, The Baptism Font had been moved and floor fixed so as seats could be placed in corner and the Table would be repaired soon as it had to be welded, Report received and filed. M^{rs} Connolly reported that M^{rs} Mackleden had made a cover for the Grand piano and thanked M^{rs} Mackleden for her thoughtfulness report was received and filed. W^m Lyall reported the Very Rev. Cosby of Buffalo had come down about the Roof & said Rev Cosby was very much impressed with the work we had done and was going to recommend to Board of Missions that the best roof would be the one he favored. On Sunday Ev after Confirmation the Bishop spoke about the roof he said he doubted if the Board of Missions could pay \$471 for the roof at present but he would see what could be done. The Bishop asked M^r Hornsby to see

what it would cost to patch the roof at present until such times there would be more money in the Treasury. The Treasurer reported there was a water Bill of \$4.80 which he thought was too high after some discussion it was agreed to try and all the Syphon every month to keep it from sticking it was thought this will help a lot. The Treasurer also reported he had received a Bill of \$13.77[¢] for Envelopes for 1939. He reported he had not received Envelopes yet and Bill was not due until Jan. 31. 1939, Treasurer reported he had received \$4.00 from Sunday School for Organist Salary for 4 months. M^r Hornsby reported he has not yet put a screw in window but he would soon. The Clerk reported he had been approached to give the hall for organization of 5th Ward republican Club. It was moved & seconded that we live up to past recommendation that Hall be not rented to any organization outside the Church. D^r Peckham said he had received M^{rs} Allinson's report on visits to indifferent members all had been visited but there were one or two cases to be visited again. A motion was made and carried that the Summer Schedule begin on June 6th There will be no Evening Services and Morning service will be at 9-30. am. with Sunday School at 11. a.m. no time was set for going back to regular services again. M^{rs} Connolly asked permission to have the hall June 8th & 9th for the dramatic Club play which D^r Peckham granted. M^r Brown promised to have upright Piano brought upstairs

as soon as possible in case anything should happen to organ. M^{rs} Connolly reported that she had a long talk with M^r Oldham and he seemed to be interested in the Church. D^r Peckham promised he would visit them as soon as possible. M^{rs} Connolly & M^{rs} Mackleden promised to see if they could get a curtain for the Wash room up stairs. M^r Brown promised to purchase a Dust pan. M^r Hornsby reported M^r Fabiano had asked permission to put a Barb Wire fence on top of our present fence to keep people from climbing over as they were damaging our property as well as his. M^r Hornsby promised to write and find out if City Ordinance permitted this if so he was to tell M^r Fabiano to go ahead. The matter of a hedge fence around lot on Pine Ave and 23rd St was discussed and M^r Hornsby is to enquire what cost would be. A motion was made & carried that Delegate to Convention be paid Expenses also that D^r Peckham's admission to the Pageant at Buffalo Consistory be paid. There being no further Business the meeting was adjourned with prayers.

The regular monthly meeting was held in the Choir room on above date. The following members being present. D^r Peckham, M^{rs} Connolly, M^{rs} Mackleden Samuel Jones, Fred Brown S^r. Frank Hornsby and William Lyall. Absentees were John Blackwell and M^{rs} Stuart. D^r Peckham called the meeting to order at 8. P. M. All members rising for the Benefit of Prayers. The minutes of Previous meeting were then read and approved as read. The Treasurer then read his report as follows. Total revenue \$96-55 Expenditure \$29-67 Unpaid Bills \$88-66 Leaving a Deficit of \$21-78 cents Report received and filed. The following Bills were presented J. Di Franco 12. 100 watt Light Bulbs \$2.40. Secretary Treasurer Expense Convention \$2.30. Stamps + Mailing Whit Sunday Letters \$2.40. Bills received and order Paid. A communication was received from Bishop Davis thanking us for \$8-54⁰⁰ from Confirmation Service and congratulating us on the condition of our mission and in being in union with the Diocese & being represented at Centennial Convention. Under old Business M^r Brown reported he had oiled the Siphon, The piano was not moved yet but M^r Hornsby promised to examine the front stairway and if it is strong enough M^r Brown promised the piano will be moved before the week is over. M^r Brown promised he will take table home tonight and have it fixed at once. M^r Hornsby reported he had gone to City Hall and spoke to Building inspector about the

Barb wire on the fence while there is at present nothing in the code regarding it the Building inspector is against Barb wire and is going to see if he can get in the code condemning it. It was agreed to tell Mr. Fabiano not to put it up for that reason as it might mean a damage suit against us if some one was hurt. Mr. Hornsby also reported he had enquired regard a Hedge around the grounds he had spoke to Mr. Chambers who has a very fine one Mr. Chambers introduced him to Mr. Williams 440 - 4th St this City who is the agent for Empire State Nursery Co Newark, New York State. The prices range from 10 to 15 cents a Bush according to size etc taking them in lots of 100 or more we would require about 350 Bushes that would run from \$35.00 to \$52.50. Mr. Brown reported he had received a price from Harris & Laver which was about the same the matter was left over Mr. Hornsby reported he had sent an estimate for repairing the roof to Bishop Davis as per the Bishop's request, Mr. Hornsby agreed to repair the roof and keep it in repair for 2 years provided the leaks were caused by ordinary wind or Rain or Snow Storms for the sum of \$58.00. The Bishop said the Diocese were quite agreeable to that agreement provided the Mission committee would approve. It was hoped that by the end of two years enough money would be forthcoming to put a new roof on the Church.

A motion was made and carried that the committee approve of the arrangement between Mr. Hornsby and the Bishop. W. Fyall then reported on the convention and our being admitted in Union with the Diocese the report was received and ordered put in the minutes Dr. Peckham then reported on the large Prayer Book which was left in his hands to find someone who would appreciate and read it. He asked Mr. Chambers but his eyesight was failing him so he does not read much. He asked Mr. Joseph Lynn and he said he would appreciate it very much so Dr. Peckham gave it to him. Mr. Lynn was so pleased to receive it that he & Mr. Lynn called to see Dr. Peckham after the service and again showed his appreciation by personally thanking Dr. Peckham again the committee were quite please to know the large prayer Book had found a Home where it will be appreciated. Dr. Peckham also reported he had called on the Oldham Family as requested but found their interest in the Church was mostly for social activities and anyway they were soon expecting to move to La Salle Under New Business Mr. Hornsby said when he was down at City Halls he enquired how much we had paid for Water Bills during last 10 Quarters we had paid more than 25 Dollars over our regular rate. He said he price some Electric Pumps and they would cost about \$35 Dollars and he thought we would be in pocket

in the end as our syphon was always giving us trouble and keeping our Bills up. The matter was left over at present with a possibility of taking the matter up with the Bishop later. Mr. Hornsby then stated he had several matters to bring before the Committee. 1 He had repaired 8 Double chairs. 2 A light is needed on Back stairway and the gutter spout is leaking where the new Pipe joins the old. The paint is peeling off on both sides of the Building. Mr. Brown Promised to see what could be done about the gutter spout & he also promised to see about painting & coming off & re-coat same. W. Lyall said Mr. Auer promised to see about the light on stairway. Mr. Hornsby said he would speak to him about it as there was no further Business the meeting was adjourned with Prayers at 9.30 P.M.

The convention was held on May. 16th, 17th & 18th in St Paul's Cathedral Bishop Davis presiding. The convention on the whole seemed to be a very hot and dry affair. No doubt this was on account of the Centennial program taking up so much time. There was at least 2 Items of Business which is of great interest to us at the Redeemer. As you are aware I did not attend the first day at the Bishop's request but Dr. Peckham was there. The first Item of importance to us was at the first session when Dr. Peckham asked that the Church of the Redeemer be admitted to be in union with the Diocese, according to the minutes the Bishop spoke very much in favor of the Redeemer being admitted. A motion was made and seconded & unanimously carried that the Redeemer be admitted. at first session on the 17th Dr. Mosher moved that the Redeemer Delegate be seated which was unanimously carried. Owing to the kindness of Mr. H. Allinson, Mr. Hornsby and myself were able to at the Early Communion at 7.30 am in Trinity Church which was mostly attended by the Clergy. At 9 am we all went to St Paul's where the convention was held. Most of the Business was Election of Delegates and accepting resolutions. One of the resolutions was of interest to us namely, that no Parish indulge in any gambling games, This resolution was the subject of much discussion and was sent back to the committee for further definitions. Bishop Manning was asked to give his opinion on the matter. This resolution was to conform with the Church's objection to the passing of the State of New

York's Gambling Law. Finally the resolution was passed which forbids all games of chance such as Bingo, Lotteries and Card games for money. The Priest in Charge to have the final voice to object to any games which come under the resolution. The Cathedral was filled to overflowing for the service at 11. am. which was very impressive and Bishop Manning gave a very stirring address. The Dinner at Buffalo Hotel was a very rousing and cheerful affair and everyone enjoyed to the full every minute of it. and we got to know from the speakers of other Denominations what a powerful Influence Bishop Davis is in the Diocese & districts. The Pageant in the Buffalo Consistory in the Evening was very well played indeed and depicted the Church from the Beginning in Western New York till the present time. The play received great approval & the Consistory was almost filled to capacity. On Wednesday 18th there were just meetings of the various committees and a repeat of the Pageant in the Evening.

A communication was received from the Bishop authorizing M^r Hornsby to go ahead with his contract to repair the roof for 2. years for \$58.00. The Clerk was instructed to write the Bishop regarding the money for the repairs as M^r Hornsby had already started the work and had spent \$10.00 on it. A letter was read from M^{rs} C. Mears asking use of 5 Double Chairs and a Card Table for a Lawn Party. The request was granted providing the Chairs & Table be returned on or before Saturday 16th. Under old Business M^r Hornsby reported the front stair should have some supports in Centre before Moving Piano. The cost of work would be a Dollar for material & work. It was moved and seconded M^r Hornsby go ahead & do the work. The matter of the Gutter Spout was brought up M^r Hornsby said nothing had been done yet and the spout on the

other side of the Building was now leaking As Mr Brown was absent. M^r Hornsby said he believed M^r Meehan does this kind of work. M^r Hornsby was instructed to see M^r Meehan and if the work could be done for \$2.00 or less to go ahead with it. The Clerk was instructed to notify Mr. Brown when he came back from his vacation to see about moving the Piano and repainting the side of the Building where it is peeling also that rear furnace was leaking gas and to see if he could get M^r Blackwell or M^r Clark or someone else to fix it before winter, hoping to get immediate action on these problems.

M^r Hornsby promised to finish back stairway as soon as possible and try and get M^r Auer to put a light in same as at present Back Stairway is dangerous and to avert any one being hurt it was decided to close Back stairs until they are finished completely. M^{rs} Connolly reported she had seen the janitor ~~was~~ watering the lawn and he had to stand and hold the hose she wondered if we could get a sprinkler for the janitor as he was doing his best to keep things nice & if he had a sprinkler he could be doing other work and would not have to spend so much time at the Church. M^{rs} Mackledin said she had a sprinkler she

would be glad to loan the janitor as she believed the janitor deserves as much help as possible in his efforts to keep the lawn nice. The committee thanked M^{rs} Mackledin & accepted her offer. D^r Peckham reported he was surprised when he received a letter from Mr. Freeman stating the City was going to Pave 23rd St and that the Sewer & Water connections had to be done on Lots 1, 3, 5, 7, 9. before July 31st or the City would do it and charge for same. As this called for immediate action D^r Peckham and the Clerk went down to City Hall after communicating with D^r Mosher. While in consultation with the City it was discovered that 3 Sewer & Water connections had been put in from Pine St and that our present Building occupied Lots 1, 3, 5 and Part of lot 7. The City Engineer recommended that we petition the Council to release us from making connections on Lots 1, 3, 5, 7 but that we make connections on lot 9. he also asked us to see the City Manager on the matter he promised to advise the Council that he was favorable to our petition. The City Manager also was favorably impressed with the arrangement & promised to do what he could to help us. The City Manager also promised to regrade the Alley so the water would not run in our Basement. On the Advice of the City Engineer and Manager the

Clerk sent a request & petition to the Council asking them to release us from the expense of making connections to Lots 1. 3. 5 & 7. and we would make connections on lot 9th. This petition was brought before the Council on Monday Eve 17th Inst and was sent to City Manager for consideration. The Clerk talked to 2 of the Council on the matter & it is believed everything will be past favorable for us. This Paving and Sewer Connection program is a W. P. A. project. A motion was made and unanimously carried that the Committee support the action of Dr Peckham and the Clerk on this matter. As there was no further Business the meeting was adjourned with the Blessing by Dr Peckham.

A letter from our secretary to Mr Freeman was read.

Mr Brown asked to be excused at 8:30 pm. request granted.

The question of whether we should take a special offering for the civilians in China was brought up. We voted to send for 50 envelopes.

We were pleased to welcome our new member Mr James Meehan.

The untidy looking front windows was spoken of Mrs Mackelden + Mr Hornsby were appointed a committee to see about prices for improving same.

Other names to come in.

Meeting closed with prayer 8:50 PM.

The Regular monthly meeting was held in Choir room on about 8 o'clock. Rev. Dr. Peckham presiding. The following members were present. Mr. Connolly, Mr. Mackledin, Mr. Hornsby, Mr. Brown and the Clerk W. Lyall. On account of slowness of the men in arriving the meeting was opened by Dr. Peckham at 8.24 o'clock members rising for the benefit of prayers. The minutes of previous meeting were read and approved as read. The Treasurer's report was read showing a balance for January of \$13.06 the report was approved as read. Mr. Mackledin & Mr. Hornsby reported they had not completed their report yet regarding front windows but promised to have full report at next meeting. Mr. Hornsby reported the piano key was made new & worked O.K. Mr. Connolly reported Janet Lyall was on the Kitchen Committee. As it is necessary for the Kitchen Committee to act as soon as possible. Mr. Jones was nominated to represent the Choir. It was moved that the matter of changing & repairing toilets be left in hands of Mr. Brown & Mr. Hornsby they are to act with Kitchen Committee so that any changes to be made will be done at same time. Mr. Brown reported that the Brackets for small roof would be ready this week but the weather is mainly what is holding up the work. Mr. Brown reported he had been down to see Bank manager

but had not seen him yet but he will make special efforts to see him next Saturday and have special repair fund account transferred to an interest bearing account. Mr. Connolly reported the basement floor seems very weak in places. Mr. Brown promised to strengthen the weak places before the play on 21. & 22. Feb. Mr. Hornsby reported that there is a seep in the outside wall which caused so much water in Basement & the supports are rotting away. Mr. Hornsby & Mr. Brown agreed to take side Boards down & look for bad spots in wall so it can be fixed when dry weather comes then after that is repaired the rotten supports will have to be fixed so the floor will be safe. Two Broken Windows in the Basement will be repaired this weekend. Mr. Brown reported. Mr. Hornsby promised to Bolt two Windows in Church over small roof as some persons have been entering the Church unlawfully by means of windows. As the Bishop is holding Confirmation at St Stephen's this year and we have 3 members to be confirmed it was agreed we cooperate in a body with our Choir with St Stephen's Church on April 22nd though it means we have no Evening service in our Church that day. A Bill for \$32.00 for Coal was ordered paid as soon as

funds are available. It was agreed that two letters one by the Pastor and one by Committee be sent to all parishioners, accompanied by a Easter offering Envelope, for Holy week. The Clerk was instructed to draw up the Committee letter for consideration next meeting. The Treasurer was instructed to order 500 Easter offering Envelopes which will last 2 or 3 years. As there was no further Business the meeting adjourned at 10.17 P.M.

Mr. Brown reported he had ordered a new Sump pump Valve from Elderfield + Hartsborn Payment of

Bill left over till next meeting. Mr. Mackleden reported on prices + Designs for Front Windows. Mr. Allinson offered to pay for two Church windows up till 10. Dollars offer was received. The Women's Aux promised to take care of two Front Windows down stairs. Much time was spent in choosing most suitable Design. Finally it was agreed Mr. Mackleden enquire if there is a picture to match Dove Design in size. Mr. Brown reported the Brackets for the roof were ready waiting on the weather. Mr. Brown reported if we change our Building Fund account to an interest Bearing account we would have to keep at least \$100.00 in it and only receive 2. per cent interest. Moved to leave account as it is carried. The Basement wall and Floor have still to be Fixed. Mr. Hornsby reported the Windows have been screwed up. The Easter Letters by D. Puckham + W. Lyall were approved as revised. Childrens weekday Lenten Service reports steady improvement in attendance as there was no further Business the meeting was adjourned at 10-35 P.M.

The new pump Valve ordered by Mr. Brown was sent back by him as it cost \$10.40 and he was having old Valve repaired. It was reported that Water Bill this quarter would be \$15.00. Mr. Brown agreed to see what could be done with an Electric pump & report at next meeting. The matter of Alternate Lay Delegate to Convention May 15th was brought up. it was agreed to lay matter on Table till May 9th so members would have better chance to know who would be Free. Mission Committee Meeting May 8 - 1939

The regular monthly meeting was held on above date instead of 9th on account that Dean Zwicker desired to meet the Committee regarding the Paving of 23rd St. All members were present when Dr. Peckham called the meeting at 7.31 P. m. Members rising for the Benefit of Prayers. The minutes of the previous meeting were read and approved as read. The Treasurers report showed an income for April \$177.41. Expenditure \$126.20. Balance \$64.92 unpaid Bills \$134.74 Leaving actual Deficit \$69.82 report was received and filed. The matter of Excessive Water Bill \$16.90 and flooding of Basement was discussed pro & con. It was believed there must be some leakage in water main which floods the cellar and causes the pump to be continually working which increases our Water Bill. A motion was made & carried that Clerk write to Superintendent

of Water Bureau explaining the condition of Basement and damage done and asking for a Test for Possible Leakage and reconsideration of our Water Bill. Another motion was made and carried that present Water pump be replaced by an Electric pump and if necessary the present pump be installed at other end of Building. The cost of new pump to be taken from the Emergency repair Funds. The matter of repairing the Floor was laid over until other repairs were made. Mr. Hornsby promised to see about the Seepage in walls right away. The matter of making a drain to prevent further seepage was left in hands of Drainage committee as follows. Messrs. Brown, Hornsby & Mukan. This committee to report next meeting. If present weather continues the Brackets Etc on outhouse roof will be put up this week. At this time Dr. Zwicker our Dean arrived. The matter of a Delegate to Diocesan Convention was brought up. A motion was unanimously carried that Mr. Jones be appointed Delegate and that he be reimbursed for any expense incurred by Hiring a man to take care of his Business. In case Mr. Jones was unable to go Fred Brown Jr. was recommended to Dr. Peckham for appointment as Delegate alternate. The matter of Summer Schedule was discussed

It was moved & seconded that we change to our Summer schedule on June 4th there being only one Dissenting vote the motion was carried. A motion to adjourn the Business meeting was carried. D^r Peckham declared the regular meeting closed at 8.40 P.M. and asked D^r Zwicker to take the chair for special meeting.

As D^r Zwicker took the chair D^r Peckham handed the Parish register to him for his inspection. D^r Zwicker after examining the register asked a few questions regarding the Sunday ^{school} and prospects of our Church in the neighbourhood and seem quite satisfied with the answers. The meeting was quite informal & was more like a family gathering the welfare of our Church and parish being the main object. D^r Zwicker said the reason of his visit was to be fully acquainted with all conditions of our Church and to find information, to report to Committee in Buffalo May 9th regarding the paving of 23rd street and the desire of our committee to sell Lot 9 on 23rd St to pay for Paving. D^r Peckham answered D^r Zwicker by stating the Committee was not over anxious to sell Lot 9

but as the Diocese had no funds and we were not able financially to help Diocese on the matter we were all willing to recommend to Diocese this one way out. D^r Peckham also told the Dean we had received an offer of \$700.00 cash but he said if Diocese decide to sell we recommend that the Diocese have lot appraised and we believe that more than \$700.00 could be received but we hoped the Diocese would act soon but not too hastily. D^r Zwicker then asked just what information we could give him regarding our lots. The Clerk told him we have five lots with a frontage of 204 ft on 23rd street the Depth was about 140 ft. The Church covers Lots 1, 3, 5 and 4 or 5 ft on Lot 7. Lot 9 is vacant as Lot 9 is 40 wide it leave about 35 feet from Lot 9 to rear of Church as all lots are 40 ft frontage except Lot 1 which is 44 ft. There are 3 sewer connect to the other lot in Pine Ave. and one sewer connect on Lot 9 into 23rd St so Lot 9 would be available for sale if Desired by the Diocese. D^r Zwicker then asked if there was anyone against selling the lot. Mr. Hornsby stated he was not willing to sell the lot if it was to be used as a Dump yard for a contractor but he understood that Mr. Fabiano intended to build a house on it and he was satisfied. The Clerk said he understood the lot was intended by D^r Mosher for a Rectory

but he did not think with the surrounding Elements it would ever be used as such but he believed if Diverse could see their way to pay paving without selling lot at present it would increase in value at a later date.

D^r. Zwicker thanked all the members for their cooperation and said he was glad he had come & now he could put full facts before the committee on Tuesday. He could see we were already overburdened with work & certainly could not expect us to do more. He also said there were some things about our beginning he was not altogether satisfied with and he was going to investigate personally but in the meantime we were to carry to the best of our ability. D^r. Peckham thanked D^r. Zwicker for his presence and kind words and asked him to accept some old Records of Grace Church Lockport of which D^r. Zwicker is rector. D^r. Zwicker thanked D^r. Peckham and committee & promised to do all he could to help us. The meeting adjourned at 9-45 P. m.

The regular monthly meeting was held in Choir room on above date. All members, Alternate and M^r. Jones the convention delegate were present when D^r. Peckham called the meeting at 8.02 P. m. All members rising for the benefit of Prayers. The minutes of previous meeting were read and approved as read. The report of Treasurer was read showing Total income for May \$178.23. Total Expenditure \$163.81. Leaving a Balance May 31st of \$14.42. Less unpaid Bills totaling \$96.70 leaving actual Deficit \$82.28 report was ordered received & filed. A communication was read from Bureau of Water in answer to the Clerk letter regarding the large water Bill and leakage at Water Main. The Bureau admitted the leakage but claim the property owner is responsible for same and we would be billed for work done in repairing the damage as there was nothing we could do about it at present the letter was received and filed. M^r. Brown reported he had paid a bill of \$1.50. out of repair fund for material for putting wire on roof of out-house he had made 2 corner Brackets and work would be finished this weekend. M^r. Brown reported he had talked with D^r. Peckham regarding the installation of an Electric pump. He had fixed the old Sump pump & it was working better now and as the main leakage had been fixed he believed the present pump

would be able to keep water out of Basement. An Electric pump would cost \$29.50 it was agreed to wait and see just how the old pump acted before installing an Electric pump. The matter of damage to lattice work around the Building was brought up by Mr. Connolly it was finally agreed that Mr. Brown see what can be done about getting expanded metal to replace the lattice work. It was also agreed that Mr. Brown and Clerk see about getting some notices posted warning Trespasser to keep off our property. Mr. Jones gave a report on the 102 Diocesan Convention held May 15 + 16 in Trinity Church Buffalo. Owing to illness of Bishop Davis Rev. Broughton occupied the Chair. After the Usual Routine Business the meeting was adjourned to allow holding a Service at 8 P.M. at which the Rt. Rev. Peabody Bishop of Central New York addressed the Convention. May 16th Morning session was held with Election of the Officers of ensuing year practically the same officers were elected. The Bishop's annual report was read which very optimistic it told of having to close a mission at Springville it also reported the great cooperation of the Clergy & Hospitals in aiding the sick people. Dean Purdue gave a very interesting talk

Mr. Connolly, Mr. Mackleden, Mr. Brown and the Clerk. owing to lateness of Mr. Brown the meeting was opened with Prayers by Dr. Peckham at 9.30 P.M. at 8.30 P.M. Mr. Dominick Trapasso appeared before members by request of Dr. Zwicker to state personally his request for removal of Trees in front of Church. This request by Dr. Zwicker came about a Telephone message

received by Dr. Peckham from Mr. John Galante asking the Church's permission to have the 5 Trees removed and promising that Mr. Trapasso would compensate by paying the Installation of Decorative Lights. Mr. Galante also promised to try and aid the Church if the Alley was paved as there was a petition now to have same done. Owing to shortness of time Dr. Peckham Phoned Dean Zwicker for appointment to lay request before the Dean. On Tuesday at 3 P.M. Peckham said as he was directly under the Bishop who is actually our Rector here he has been carrying out the wishes expressed by the Bishop at the Convention however as the Bishop seems to condone other Churches in the Diocese playing cards he advised M^r. Connolly to write Direct to Bishop Davis explaining fully our conditions and asking the Bishop for an opinion on the matter also to be sure to tell the Bishop they had D^r. Peckham's permission to write the letter. D^r. Peckham announced he had a telephone call from a M^r. Pevite asking for permission to rent Basement on Sunday afternoon 2-4 P.M. for an Accordion Band practice. A motion was made and carried that the request be denied according to our standing rule of the Committee as of May 10th 1938. The Clerk said the Scout Master Fred Brown Sr. had asked him to ask the Committee to sponsor the Scout Troop of our Church for ensuing year the matter was thoroughly discussed and the following motion was unanimously carried that the Church sponsor the 4th Troop for ensuing year under following conditions 1st That the

Boys live up to Scout rules and regulations especially that part which calls on them to attend Church service on Scout Sunday, as last year only a very few boys attended. 2nd That only Basement be used by the Troop and no one to be allowed upstairs as the Basement can be arranged to hold 4 classes at one time. 3 That Scoutmaster be held responsible & see that every boy is out of Building & that every window & Door is securely fastened & that no boy be allowed, or left, in Building without a proper advisor being with them. The Clerk was instructed to write the Scoutmaster to that effect and to thank him for his work with the Boys in the Past. It was also the opinion of the meeting that the Boys and girls of all organizations be not allowed to use the upstairs unless it was necessary and only when a responsible person is with them & the Door to back stair to be kept closed. The meeting was then closed.

Dr Peckham also report the Financial Condition of the Parish that during last five years 47 members had moved out the Parish which was one reason for the poor Financial Condition. The Treasurer handed the Bishop a copy of the April Monthly report which showed a Deficit of _____ to date and this was after receiving the Easter offering. The Bishop then said he was very pleased to be present to confirm the class and to address the Sons and Daughters of St George. He also said he was very pleased to meet the Mission Committee and get the reports of Dr Peckham and the committee. Owing to the Financial condition of the Church the Bishop said he would not take the Evening collection which he generally takes when visiting a parish. The

committee thanked him. The Bishop then asked several questions regards the condition of the Parish & just what class of people were taking the place of those who have left and why they left our parish. The Bishop was told many members left the Parish to go to outskirts of city because their financial condition forced them to live where rents were cheaper. Others left because the Foreign Element was crowding them out and then some of them had died. Mr. Dawson told the Bishop that a few years ago the Aux could make \$100% on a rummage sale to day they are lucky to make \$25. The Bishop said it was plain that conditions were now different here and he felt very confident that the workers here were doing everything that was possible to keep the church going. He asked the clerk to write him given a true statement of conditions here and he would bring up the matter of an increase in aid before his committee in Buffalo. A vote of thanks and appreciation was given the Bishop and meeting was adjourned.

it showed it would be more costly than present plan and there could be no spiritual guidance nor visiting done in the Parish which certainly would be very unhealthy for the Parish and also very inconvenient. Dr. Peckham called the meeting at 7.30 P. M. All members rising for the Benefit of prayers. The minutes of previous meeting were read and approved. The Treasurer's report was as follows Income \$227-63[¢]. Expenditure \$201-60. Balance \$26-03 all Bills paid to date. The report was ordered received and Filed. The matter of Church Envelopes was brought up. The Clerk said he had received 85 sets with Christmas Envelopes enclosed for 1942. So far we have received 56 pledges. Dr. Peckham said St. Stephen's Church had received word they may not get their sets of Envelopes in time as they are not sure of the Printers getting enough Paper owing to the War. As we have 28 old sets of Envelopes from 1940 + 1941 on hand He wanted to know if we could help St Stephen's out by selling them some of our Envelopes. After some Discussion it was agreed to sell St Stephen's Church 40 sets of 1942 and 10 sets of the older ones in all 50 sets at the price we paid for them 16[¢] per set. Everyone agreed the Annual Parish meeting was very successful but Dr. Peckham desired to know just what would be called regular attendance rule as per Canon Law. This matter was discussed Pro & Con but no definite rule was decided upon.

it was definitely agreed upon, that work, sickness, out of town, and having to stay home to take care of children while others were working or at church, were good reasons for being absent from church. but no one had same idea just what would be proper with Canon Law on the matter it was agreed to take up this matter at a future meeting so the Pastor could have a clearer understanding before next annual meeting. Dr. Peckham announced that the Red Cross had called up to find out how many people could be fed in our Basement in case of emergency. He told the Red Cross to call on Mr. Connolly for proper figure as he thought probably 40 people.

As there was no further business the meeting was adjourned
